A New Weapon.

The millionaires who own the railroads are employing all kinds of weapons to check the growth of popular sentiment in favor of government ownership of railroads. The newest weapon is the club of ridicule which is now being thrown by the metropolitan press. One form of ridicule appears in the serious treatment of a proposition made by a Chicago man to contract with the government for the handling of the postoffice department. This man says he has a capital of fifty million dollars behind him, and that he will guarantee to reduce the postage fifty per cent, and give the people better postal service than the government now gives. Of course the proposition is only for a purpose, that purpose being to give the big newspaper which the railroads own a chance to discredit government ownership generally. The chief point made by this railroad stool-pigeon in Chicago is that in private hands the postoffice department could be conducted cheaper, wages would be lower, individual energy would be greater, and the public would get the benefit. A glance at the workings of the private owned express companies will serve to show the absurdity of a postoffice department under private management. During a legislative investigation of express company rates a few years ago an express company official testified regarding the rule by which express charges were fixed. After severe questioning this official finally testified in substance as follows: "In all cases where we can get business away from the government on small packages which might be sent by mail we give the big shippers a special low rate, lower than the postage rates. On larger packages that cannot be carried in the mails, we make the charges as high as we believe the public will pay—in other words, we charge all the traffic will bear." And that same rule is now followed by the railroad rate-fixers. They do not have anything in the nature of justice and right mixed with the freight rates—greed, avarice and advantage being the sole ingredients. Under government ownership of the railroads the sole basis of freight rates would be the rock of justice, which is the basis now used by the postoffice department. No good man has anything to fear from government ownership of railroads. It is natural that the owners of the railroads should oppose government ownership, because it will take away from them the privilege of exacting exorbitant and unfair charges. But ridicule will not check the growth of government ownership sentiment. The people have witnessed the utter failure of every attempt to regulate railroad rates by law. They have seen every law defeated by a secret rebate or by a subsidized judiciary. The only remedy for existing railroad evils lies in the direction of government ownership, and the people are getting ready to apply that remedy.—Columbus Telegram.

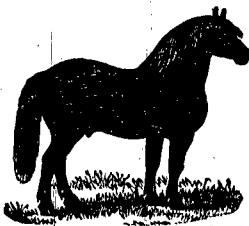
Still Faking.

The best sample of fake reform put forth by our republican friends in Nebraska was issued a few days ago by Chairman Rose, of the republican state committee. He wrote an open letter to the republican members of the new legislature, telling them that they must redeem their pledges for reform. And on the day when he wrote that letter Chairman Rose was in consultation with those same hypocritical influences which have so often shouted reform while organizing the legislature with a Burlington striker in the speaker's chair and a Union Pacific-Northwestern political agent in the chair of the president of the senate. The Telegram is ready to concede that many of the new republican legislators will go to Lincoln this winter with an honest purpose to accomplish some good for the state—with a sincere desire to enact legislation which will drive the railroads out of the governing business in Nebraska. But they will be helpless. The plans and specifications for legislative work has been agreed upon by the railroad lawyers for weeks. They have already agreed upon the 116 members they will have to preside over the two houses. The principal committee chairmanships have been placed where they will do the most good. Chairman Rose must have knowledge of what the railroad lawyers have been doing. If he doesn't have that knowledge, then he is a dead one indeed. We cannot regard his public letter to the legislators as other than bald mockery. He must know that with a state senate organized and officered to suit the notorious Joe Burns and Jack McKesson there will be no more show for reform legislation in that senate than for a snowball in hell. However, the people of Nebraska have demonstrated again and again that they like to be humbugged, and we predict that at the close of the next legislative session those who like the stuff will be able to say it was never handed out to them in more liberal doses than by Chairman Rose and the "reform" legislature soon to convene in Lincoln.—Columbus Telegram.

Pershing!

Late news from Manila throws light upon the action of President Roosevelt in promoting General Pershing over the heads of so many army officers. The president is a great admirer of men who produce children, and Pershing appears to have a good record as a producer. Citizens of Manila have filed with congress some nasty charges against Pershing. The charges say that the officer who in the old days taught military tactics and played the part of a social lion in Nebraska has been doing things in the Philippines. The specific charge is that five years ago Pershing got married to a Filipino woman on the Elsie Clews plan; and that he is the father of a whole flock of little brown babies. One year ago Pershing abandoned the Filipino wife, in order that he might marry an American girl. The protest of the Manila citizens came too late to prevent the promotion of Pershing, as the senate had already confirmed

him. We shall not be at all surprised if Roosevelt shall soon give a cabinet position to Reed Smoot, the Mormon senator from Utah. His record is not quite as good as the Pershing record in the matter of propagating and replenishing, but it must be remembered that he is still a young man, and since Roosevelt sent Taft out to the Mormon country to help elact the Mormon tickets in Utah, Idaho and Montana, greater opportunity will be opened to Smoot and other Mormons to win the Roosevelt smile of approval.—Columbus Telegram.
