



### County School Notes.

(By County Superintendent Littell.)  
By demanding that school district treasurers file their official bonds before any funds could be drawn from the treasury Mr. Cherry has succeeded in causing every school district treasurer to file the proper bond; a condition that has not always existed, and has been hard to bring about.

We trust that school boards will not put off hiring teachers for the coming school year until after the annual meeting, provided they can secure the services of desirable teachers before that time. There is a demand for the teachers who have made a success of the work, and unless a choice is made early school officers may not have an opportunity to select from the better class of teachers.

All reading circle credits for the years 1906-7 will be certified to the state superintendent June 8th. Those who have not made application for these credits will do so before that date.

Miss Pauline Braunger reports at the close of her school year in district No. 51, that Willie McEachen has been neither absent or tardy for a period of five years, and his sister Gertrude for a period of four years.

State Superintendent McBrien will deliver an address at the eighth grade graduating exercises to be held June 15th, 1907.

Eighth grade pupils who desire to take the examination and who can find sufficient excuse for not taking said examination at the regular examination dates will be given a special examination if they make application to the county superintendent before June 7th.

The program for the eighth grade graduating exercises will be ready the first of next week.

A number of applications have been received from parents desiring free high school privileges for their children, but many have yet to comply with the requirements, who, when the time comes to start their children to school this fall will be disappointed in that they will have the tuition to pay, unless they attend to the matter before the second Monday in June. An entertainment was given in the evening of the last day of school.

Quite a crowd was in attendance, and the program rendered by six pupils was highly spoken of by Bertha Henderson, district No. 33.

The work of the school year just closing has been most satisfactory in many ways; we have evidence on every hand that the course of study has been closely observed, which means more to the schools of the county than we can realize: the discipline in our schools has been better than it was the last half of the preceding school year; the professional work of the teachers have been kept up in a very creditable manner; teachers have been paid better wages than ever before, and I believe, in most cases, the patrons feel that they have gotten value received. I will except no county in the state in which school boards are more deeply interested in the welfare of the schools than they are in Wayne county; the present high standard of our schools is due wholly to their careful selection of teachers, and co-operation with teachers and county superintendent during the school year. I am convinced as is every teacher, that the greatest drawback to our country schools is the irregularity of attendance; it is a mystery to teachers how parents can offer complaints because their children are not making progress when they often fail to attend school the time required by law. Teachers report pupils absent for two reasons, one that they are not quite satisfied with the teacher, and another that they are obliged to stay at home to work. The class that stay at home to work are not excused by the compulsory education law, and the parent is guilty of a misdemeanor if they fail to send them to school the time required. The class "don't like the teachers" could be almost eliminated if parents would refuse to listen to their childish prattle, but send them to school with explicit instruction to learn all they can rather than for the purpose of passing judgment on the teacher; while it is very true that in a few instances parents could justly criticize the teacher there is nothing to gain and much to lose, if it is done in the presence of school children; it would be much better to consult the teacher quietly, or allow those little annoying matters to "blow over" and hope for better conditions in the future. It is interesting to note that the most confirmed "sticklers" in the districts are those who fail to curb their children at home and expect a teacher to do so without resorting to even the lightest form of punishment. With as strong a form of teachers as the county had this year, I predict for the schools unparalleled success next year.

Two of a Kind

The DEMOCRAT recently received a letter from Senator Burkett evidently wanting a little free advertising for his dates in Nebraska as a chautauqua lecturer, purely private business. Here is the manner Edgar Howard of the Columbus Telegram sizes up the big little senator. Once upon a time, many years ago, a poor Nebraska boy stole two pennies from a government post-office. He was tried by the court and jury, found guilty, and sentenced to a long term in prison.

Another Nebraska boy took many pennies from the Government, but he is not in prison. He is in the United States senate. His name is Elmer Burkett, and he represents the state of Nebraska in the highest legislative body on earth. Our government gives its senators and representatives certain envelopes, which they are permitted to send free through the mails when writing about government business. The law provides a penalty if those envelopes be used for private business.

Senator Burkett is a thrifty fellow, and looks close after the pennies. So close does he look that he often uses those public envelopes for purely private business. Last week The Telegram received a letter, bearing on the envelope the official frank of Senator Burkett, but minus a postage stamp. We wondered what manner of official business the distinguished senator could have with The Telegram, and the editor was pained and humiliated when he opened the letter and discovered that it did not deal with public matters at all, but was a letter in which the editor was given a list of the speaking dates for the senator during May and June.

We say we were humiliated, because it is indeed humiliating to know that Nebraska is represented in the senate of the nation by a man who will use his official frank for private business, thus cheating the parent government out of two cents on each letter. If this were the first offense of the kind committed by Senator Burkett we might regard it as accidental, but it is not the first offense. He has mailed other private letters under his frank. It is indeed strange that a man occupying such exalted station should be guilty of such small conduct.

If it be true that the law forbids Senator Burkett to use his official frank for private business, then it follows that he is as much guilty as was that unfortunate Nebraska boy who was sent to prison for stealing two pennies from a government postoffice. The Telegram will not ask that Senator Burkett be sent to prison. But we shall beg our senator to take a higher view of the great office of honor which he holds, and in that view be brave to lift himself above the little things which must drag a senator and the office down to a level unworthy.

West Point Democrat.—The reverend editor of the Pender Republic is an ardent prohibitionist and spends no small part of his time in fighting the sale and use of booze. A couple of weeks ago he accepted and published an advertisement for a "malt extract" and with it an apology the gist of it being that he needed the money in his business and that tainted money would go as far in paying bills as the other kind. It is evident that some of his parishioners labored with him during the following week and pointed out his inconsistency and then the "malt extract" ad disappeared and another apology occupied the "malt extract" space. What's the difference? A man can't serve the Lord by running a republican paper, anyway.



## Another Big Killing.

Wayne people received news Monday noon of another tragedy, this time three miles north and one east of Hoskins, where Henry Kneiss shot and killed his brother George Kneiss and then shot himself, inflicting wounds from which he died shortly after the noon hour. Sheriff Mears and Coroner J. Williams, and County Atty. Wilbur and Dr. Cosner left at one o'clock for the place of tragedy. It appears there has been bad blood between the two families for some time, and Sheriff Mears is satisfied that Mrs. Henry Kneiss knows what the trouble was over, although at the inquest held she denied all knowledge of it and that she ever knew her husband had a revolver. The two brothers live a half mile apart. George owned a bull in partnership with Henry Amends, a neighbor living north of Henry Kneiss' place. Monday morning Geo. Kneiss was taking the animal to Amends' place, and to do so he led a cow and Amends led the bull, going past his brother's house, where Henry was unloading hay. They all reached Amends home when Henry was seen coming, driving his team to a buggy. Knowing there was trouble brewing Amends told Geo. Kneiss to go into the house. As Geo. drove up he asked where George was, and then asked Amends to call him out, the latter telling him to do himself. Amends preceded the bad man into the house. As Geo. Kneiss came towards them Henry fired, the bullet narrowly missing Amends and hitting George in the lower part of the body. Amends then got out of the way, the second shot taking effect in George's chest, and he falling backwards, probably instantly killed. Henry then pulled the body out into the yard, took a shot at himself, reloaded the revolver and fired three more bullets into his own body, staggered and fell close to the brother he had killed. When help arrived he was taken to his own home but died soon after, only speaking a word or two and being unconscious—until death blotted out his murderous career.

The parents of the dead brothers, Mr. and Mrs. Conrad Kneiss, who live 10 miles north of Hoskins, arrived at their sons' home after Sheriff Mears got there. Mrs. Henry Kneiss said the old man made threats against her, and asked Mr. Mears for protection, but the old man denied it when questioned. Sheriff Mears came home on the Tuesday morning train. He has the gun, a 38, in his possession. It was evidently purchased in Omaha where Henry Kneiss lived until three years ago. The murdered man leaves a widow and six small children, the murderer and suicide a widow. Wayne people who know the family say they were rather a shiftless outfit.

## A Voice From Omaha.

Omaha, Neb., May 27, 1907.  
Editor The Democrat, Wayne, Neb.

We notice in your publication two weeks ago a comment on the jury decision in the case at court, Denison—vs Omaha Daily News, stating that "Omaha is certainly rotten to the core—but the saloon element and gambling interests of Omaha are too many for any white man etc."

Will you kindly tell us through what process of reasoning your mind led you to connect the saloon element with the verdict? The jury in this case was selected from a big panel and each member was carefully examined so that a thoroughly unprejudiced jury, satisfactory to the attorneys of both contestants sat in the box and on that jury were neither saloon man or gambler. The jury was also guarded by the sheriff during the entire trial so that it would have been impossible for outside influence to reach them. It has leaked out since the trial that the jury reasoned in this manner:—

1. So long as Denison has reformed and gambles no more he is before the law as good as a deacon.

2. Even a church member and lawyer like Elmer E. Thomas (in this case) may not damage a man by slander.

3. When a reputable and responsible publication repeats the slander of an irresponsible person the law must step in and give protection and justice.

We presume some may repeat that worldly and unchristian like remark "that Denison had no character, etc.", therefore the jury had no basis for allowing him damages" but we must refer you to the good book, the foundation of all law. Read Matt. ix where Christ sat down to eat with publicans and sinners, also Luke XIX where Christ called Zacchaeus "which was the chief among publicans" from the Sycamore tree and went with him as a guest to his (Zacchaeus) house. You will have to admit that "The Master" gave every man a standing in society and sought to protect those who had sinned from slander, at the same time pointing them to the lighted path. Wherein, then was the jury wrong in their reasoning, and to revert back to the original point in our letter how can you blame the just decision of the jury (undersirable though it may be to a newspaper man) on the saloon element?

We rather think the esteemed editor was suffering from a brain storm or an attack of indigestion and as some one had to "get it", unfortunately Omaha and the much abused saloonman were made the target. We wish to assure you Mr. Editor that Omaha is far from being "rotten to the core." Come down here any old time and see for yourself. We have as high a percentage of honest law abiding citizens as there are in any community in the United States, and the saloonman you will find averages up better in morals and honesty than the reformer and agitator who poses as a heaven born emissary sent to interfere with the personal rights and liberties of others and who in his mistaken zeal does not even stop at slander.

### Lid is Jarred Loose.

Monday afternoon Judge Welch affirmed the verdict of the mayor and council of Wayne in the Thomson saloon case, and the place immediately opened up for business. The pleadings were heard last Saturday. When court opened Atty. Thomas filed a motion that in as much as the city council had not made a formal order granting Thomson a license, the saloon petitioners had no case in court. In other words, although an agreement had been made by Thomas with the city that no such question should be raised, and had taken an appeal on the real merits of the case, he was alert to win out by any means possible. This may or may not have had something to do with Judge Welch's verdict; at least it will be quite interesting news to the men who paid Mr. Thomas' fat fees to learn that they lost the case because he took an appeal from the verdict of Mayor Ley and Councilmen Stringer, Chace, Neely and Craven, instead of an appeal on errors made in the first hearing. Any way the "majority" drew their first blood in this instance, but don't ever believe it will be the last. There will be "no quarter" given hereafter, if the DEMOCRAT understands the situation, and it will be a good thing, perhaps, to do a little "probing" all round. There have been worse crimes and grafts perpetrated in Wayne county than selling a glass of beer—unintentionally—to a 20-year-old young man, and possibly there may be good opportunity to return some of these "reformers" a dose of their own medicine.
