There is no development of the prohibition agitation more significant than the converting power it seems to be having on public men. Senator Colquitt likes to tell about the days of yore when he and Senator Blair were the only men who could get to present prohibition petitions in the Senate. And those days of their loneliness are not so remote either. Now it is the custom here to hear the most radical temperance talk from Senators and Congressmen. Only to-day Senator Reason of North Carolina said that during the last six years he had thought more on temperance questions than on any other. He confessed that he had not yet come to the conclusion that prohibition is the best method of dealing with the liquor traffic, but he added that if it were in his power to utterly abolish the traffic he would do it if it should do him good in public life.

A new prophet of national prohibition arisen, in the person of Congressman A. X. Parker. At the Twenty second District of New York, Mr. Parker came to the front as the champion in the House of the joint resolution proposing a prohibition amendment to the Federal Constitution. This is in course of the most extensive of temperance bills. Here is the text of the amendment resolution: Resolved by the Senate and House of Representatives of the United States of America in Congress assembled (two-thirds of each House concurring therein) That the following amendment to the Constitution of the United States be, and hereby is approved, and that the States be, and hereby are authorized to ratify the same when ratified by the Legislatures of three or more of the several States, as provided in the Constitution:

SEC. 1. The manufacture, importation, exportation, transportation, and sale of all alcoholic liquors as a beverage shall be and hereby is forever prohibited in the United States and in every place subject to their jurisdiction.

SEC. 2. Congress shall enforce this article by all legitimate legislation. This is the resolution just as it was drawn up by Senator Blair with the approval of the National Temperance Society and all prohibitionists. In the House it was taken in charge by Mr. Dingels, sent to the Judiciary Committee, and from it reports adversely with only one dissenting vote. The manager was Mr. Parker, and he made a minority report which is worth quoting in full. Here it is: "The undersigned dissenting from the report made by the majority of the committee herein, respectfully submits: That the question of the sale of alcoholic liquors as a beverage, according to existing customs has become recognized as one of national scope and importance. That it is a matter of common information that religious societies numbering many millions in their membership urge the suppression of liquor-traffic, and that extensive and powerful labor organizations are proclaiming that the dramshop is the foe of the workman's family, and that temperance is the very corner-stone of prosperity, and call for congressional action upon the side of reform; while social industrial and reform societies which exist in every community in the land, and unite in contributions and labors of multitudes of earnest and influential men and women, demand national action. If the people thus speaking are mistaken in their views they should be disregarded, but if they are right they should be heeded. It is not necessary to make argument as to whether they are right or wrong, as it is a matter of observation or experience with almost every one that alcoholic beverages are injurious to mankind. Therefore it is respectfully submitted that Congress should adopt the resolution, by so doing it will promptly respond to the just requirements of millions of American citizens. It will also nationalize the temperance movement and attach it to the very foundation of our civil institutions; it will challenge the attention of the people from the most exalted platform from which they can be addressed, and will designate the States as the battle-fields for finally deciding this impending conflict. A. X. Parker."

Doubtless it is the case from the fact that a convention will be necessary to nominate candidates for county attorney and commissioner, and select delegates to the state convention at Lincoln for the nomination of state officers. The re-nomination of Mr. Dorsey is apparently a foregone conclusion, and the only other interest Wayne county republicans have in the congressional convention is to secure, if possible, the election of Mr. Brewster, as one of the delegates to the national convention. Under the circumstances it would be his proper thing to pay Mr. Brewster the compliment of permitting him to name the delegates.

WYOMING'S WILD DOGS.

Graphic Description of the Forestry with Which They Attacked a Bull Elk.

Says a Lander (W.) special: A stockman just from the Upper Wind River ranges relates a story that illustrates the activity and ferocity of the wild dogs infesting that section.
