## THE CROWN JURY

And the Anti-Groninites Who Attempted to Corrupt It.

ANOTHER IMPORTANT ARREST

John Graham held on one of the leading conspirators—reads in Two Thousand Dollars with a Brother of Attorney Trade as a Signer.

CHICAGO, Oct. 16.—The mysterious prison arrested by Capt. Schuetzler and brought to the Chicago Avenue station with his face muffled in a handkerchief so as to conceal his identity, is John Graham, who has an office in the same room with A. S. Trade. Whether Graham has confessed and acknowledged a connection with the conspiracy is not yet known, except to the state's attorney, Judge Longenecker, who examined the grand jury to their room and an indictment will be returned against Graham and the two additional individuals named men already in jail. The probabilities are that Graham's backer and employer in the conspiracy will also be arrested before night. The whole scheme is on the point of a complete exposure. Most startling developments are looked for.

John Graham has been A. S. Trade's right hand man for several years. He is known as a smooth worker and was closely associated with Starkey, the jury trader who is now in Canada and charged with having inspired the bogus interview with Dr. Cronin that emanated from Canada. He is locked up in the state's attorney's office. The latter says a still more important arrest may be effected before night.

### Jury Fixers Give Heads.

CHICAGO, Oct. 15.—John Graham, the seventh man indicted in connection with the conspiracy to bribe jurors in the sum of \$10,000, double the amount required of his fellow conspirators. A brother of the noted lawyer, A. S. Trade or Thomas Whelan became securities for the prisoner, Joseph Komen, the fruit dealer, who was arrested late Saturday night, which was furnished by his relatives.

State Attorney Longenecker said that Graham was the man who employed the other six to see the men who were to be summoned on the jury. The evidence against Graham, he said, was as strong as could be expected in this case. Graham began this work over two months ago, but the state attorney is satisfied that he

Eight Jurors Already Accepted have not been tampered with. Roderick Smith will be the principal witness against Graham. Longenecker stated that up to this time there had not been any evidence of any kind that would implicate A. S. Trade or Thomas Sinnott, clerk of the probate court, whose names have been connected by rumor with the plot. He asserted that he had no new evidence at present which would warrant in further indictments for jury fixing, but did not hesitate to say that he believed the same man to be at the back of this plot who was the fountain head of the conspiracy to swindle Dr. Cronin.

### Working on the Jury.

Despite the absence of State Attorney Longenecker, who was engaged in the investigation of the alleged jury fixers, a court of inquests resumed the work of securing a jury in the Cronin case. Of the three men held since Friday two were excused for cause. The third man is practically accepted by both sides. Five veniremen were examined and all accused for cause.

### Mysterious Movements at Detroit.

DETROIT, Mich., Oct. 15.—Mr. O'Reilly, treasurer of the National League of America, and Col. John Atkinson, a prominent attorney and Irish Nationalist of this city, left here for London. Rumor has it that their departure has something to do with recent disclosures in the Cronin trial at Chicago. Dr. O'Reilly left Sunday night, received a cablegram from London and a telegram from Chicago, and subsequently held a conference with Col. Atkinson at the latter's residence, which lasted long past midnight. Their intention to go abroad was not known by any of Atkinson's associates or Col. Atkinson's many clients.

### Murdered His Faithless Wife.

SAN FRANCISCO, Oct. 15.—Antonio Mesdama, a barber, whose wife left him some time since, went to a lodging house where his wife was living with another man, and tried to persuade her to return to him. On her refusal Mesdama drew a revolver and shot her dead. The report of the pistol was heard by a policeman, who rushed into the room just in time to prevent the murderer from blowing off his own brains.

### Mexican Soldiers Massacred.

NEW YORK, Oct. 15.—An El Paso special to the Sun says: In Sonora, Mexico, two companies of Mexican soldiers were caught in a swamping by Yaqui Indians, who slaughtered the latters. The exact number of men killed is not known, but so far not out of the soldiers has returned to tell the tale. The Mexican government has sent 4,000 men in pursuit of the Indians, who are believed to be retreating toward Arizona.

### Murder in a Ball Room.

JEFFERSONVILLE, Ind., Oct. 15.—At the residence of Nathan Ashley, near Centerville, James Bishop shot Charles Heppa twice, one ball going through the heart, killing him instant ly. A ball was in process of being fired when the other was drunk, Bishop being less so than any of the others. Bishop was very drunk and attempted to walk in the ladies' room. Bishop requested him to stop, when he fired the fatal shot.

### THE CAUSE'S VITALITY.

All Agree that the Cause and Emperor have changed views in Good Purpose. BURLING, Oct. 15.—Statesmen, diplomatists and politicians express the heartiest satisfaction with the result of the exchange of views between the czar and Emperor William. Of these results little is positively known, but there seems to be excellent grounds for believing that misunderstandings have been cleared up and that the outlook for peace has been greatly improved. It is quite generally agreed among public men, whose guesses are most apt to contain an element of inspiration, that a pass for the settlement of the territorial Balkan question was fixed upon, and that the basis was that Bulgaria belongs to Russia and Serbia to Austria, within the proper sphere, an function of Italy were declared to comprise a protectorate over Albania.

### Judge M. Jackson Dead.

MANHATTAN, Wis., Oct. 15.—Judge Mortimer M. Jackson died here. He was born in Rensselaerville, N. Y., about 1831. He was a delegate to the young men's state Whig convention which nominated William H. Seward for governor of New York in 1854, and was author of the celebrated address issued at that time. Mr. Jackson was the first chief justice of the Fifth judicial circuit in Wisconsin. He was elected to the chief justiceship but declined to serve. In 1881 he was appointed by President Lincoln consul at Halifax, and continued as such until 1888 when he tendered his resignation, which was not accepted.

### Emerson's Grave Investigated.

CONCORD, Mass., Oct. 15.—The description of Ralph Waldo Emerson's grave, which was issued on Saturday night, has caused much comment here. Dr. Elmer A. Emerson has returned home and appears satisfied with the confirmation made by Solomon Keys, the undertaker, and Chief of Police Sanford on Sunday, who declare that none of the rumors has been taken. The Emerson family doctors no further investigation. A watch will be continued at the grave for the present and until a solid shaft of granite was placed over the grave.

In the matter of the southern Manning complaint against the Omaha road for exorbitant rates no one, the state board of commissioners have ordered a reduction of rates on coal for all roads in the state.

The reduction will be from 40 to 60 per cent on the present rate.

The democracy can not plot a single one of their candidates without republican votes, and they are not in very good position to ask for them.

At the democratic convention it was made a party war cry that the democrats of Wayne county wanted nothing to do with anyone but dyed-in-the-wool democrats.

Having drawn the line thus sharply they cannot expect that republicans will step over it.

Once more the Omaha Republican has changed hands, the new proprietor being J. C. Wilcox. Mr. Wilcox is not yet well known throughout the state, and it remains to be seen whether he is the man to make the Republic the strong, influential and successful paper it should be.

It must be regretfully admitted that the "saturnator," with which the new proprietor greets his readers does not give evidence of a very strong personality.

Secretary Noble has decided that the printing of Senator Manderson's pension by commissioner Tanner was illegal, and the whole matter has been dropped by the pension department.

As the Senator made no application for an increase, and at no time expressed any intention of accepting it, even if the department decided that he was entitled to it, it will be harder to stop the abuse which has been so freely bestowed on him for action he was in no way responsible for.

Three candidates for clerk, and all of them excellent men, well qualified for the position, are presented to the voters of the county by the three parties this year. On a straight party ticket can a course be taken which will give the election of Mr. Dills, the republican nominee. If the opposition was united on either Mr. Russell or Mr. Miller, and a vigorous fight made there might be some question of the result, but under existing circumstances it is a foregone conclusion.

There is no reason why any republican should refuse to vote for Mr. Dill. He made a straight, clean fight for the nomination, was given it by the party, and is entitled to the full party vote.

At the adjourned union labor convention Saturday, the following ticket was placed in nomination: Clerk, Wm. Miller; Treasurer, L. F. Reynolds; Sheriff, J. W. James; county Judge, C. J. Randall; commissioner J. A. Elliott; surveyor, Warren Slatt; coroner, Geo. Shaw. No nomination for Supt. was made, but the convention endorsed the republican nominee, W. E. Howard. The ticket as a whole is a fair one, and some of the nominations are very good, but of course there is no possible chance of the election of any of it.

Men who have in the past received favors at the hands of the republican party of Wayne county are trying to defeat its regular nominees for treasurer and sheriff. The party owes it to itself to see that such work shall be so emphatically rebuked that we will have no more of it in the future. The opposition concentrate all their work on these two offices, and hope by an extensive trading, and creating dissatisfaction among the republicans to secure enough votes to elect Fisher and Rickabaugh. There is no occasion for republicans to lend themselves to any such scheme. The entire ticket can be easily elected, and there is no need of trading or searching for tickets.

**IN A SMASHUP**

Mr. Steer and wife sustain severe injuries in a highway.

MARION, Ind., Oct. 15.—Major George W. Steele of this city, recently mentioned as a candidate for the office of commissioner of pensions, met with a painful highway accident. He reached home last Monday night after a ten days absence in Washington, and at 3 o'clock p.m. with Mrs. Steele and two children and the business part of the city behind a pair of spirited horses. He had not gone far when a fore wheel came off dropping the front part of the carriage down on the horses' heels. In the smashup that followed Major Steele had his left arm broken, his left leg broken at the elbow. The latter is also severely injured at the hip, sustaining severe cuts, bruises and internal injuries. Both were promptly extracted and the broken bones set.

**White House Rules**

WASHINGTON, Oct. 15.—The necessity for making some preparation for the meeting of congress has compelled the president to establish the following rules for the daily transaction of business at executive mansion, which will be strictly adhered to: Senators and members and others having business with the president will be received every day except Monday between the hours of 11 and 12:30 o'clock, and at no other time. The public reception in the East room at 1 p.m. Mondays, Wednesdays and Saturdays, will be held as usual. The president's private reception of his friends may be subjected by the enforcement of these rules, but he is sure that they will see the necessity of his having some hours each day that are absolutely free from interruption.

**The Quartermaster of a Connecticut Post**

NEW HAVEN, Conn., Oct. 15.—At a meeting of Admiral Post, post G. A. R. Saturday night, the auditors reported a deficiency of nearly \$1,000 in the accounts of Quartermaster William H. Stone. Mr. Stone has been a very prominent G. A. R. man, and was for years instructor in military tactics at Gen. Russell's preparatory school. He has been quartermaster of the post for seven years and stood high in honor in social circles. There was much feeling expressed at the meeting over the fact that the auditor's quarterly examinations of Stone's accounts have merely been formal for some years past.

**A Canadian Town Burned**

SARASOTA, Fla., Oct. 15.—Fire broke out in Cook's lumber yard at Saragat River, Ont. A heavy northwest wind was blowing at the time. At 6 o'clock the whole town was on fire. There are forty buildings in the town, generally stores and dwelling houses. Fifteen million feet of lumber, three years cut, has been consumed. The loss is estimated at \$300,000. The vicinity is strewn with household goods and burned families.

**A Hint to Uncle Sam**

LEWISPORT, Oct. 15.—The Times says that a view of the amount of English capital invested in the Sandwich islands England could not see them pass into the hands of another power without a difference, but that their acquisition by the United States would be regarded with much suspicion by the British government. It is pointed out by any European power, to which the British government would never concede the islands and the British government may see its way clear to gobble up the islands and the British intent is evidently to encourage Uncle Sam to adopt such a course.

**For Poisoning a Family**

LEWISPORT, N. H., Oct. 15.—Chauncey L. Williams of Lisbon, was arrested on suspicion of attempting to poison Frank Foster and family. It was found that about two pounds of Paris green had been used in a hot and hung water-tank used by the family. Williams being suspected, search was made and strong circumstantial evidence secured. Williams was arraigned before Justice O'Connell, who committed him to be held over to the November term of court. No securing bail was waisted to the Haverhill jail.

**Cotton Burned**

GREENVILLE, Miss., Oct. 15.—The gin house on Cook's plantation, near here, was burned, with \$200,000 of cotton. Denis Walker, a colored laborer, was arrested to destroy the same. The gin burned at Beauux Bridge was also burned, with a loss of cotton \$200,000. The loss is \$300,000, and insurance \$300,000.

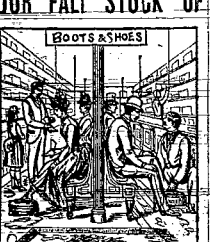
