**MURDER DONE BY WHITE CAPS.**

A South Carolina Takes Two Lives and Says It's Only a Family Affair—A Lady Drugged into an Alley at Niagara Falls and Shown to Her Execution.

**NEWTONS, Conn., Feb. 18.**—John Campbell was flogged by masked men on Sunday night, and is suffering badly. Campbell has been in the habit of beating his wife, an amiable young woman, and has once been confined in jail for thrashing her. The couple live on the Turnpike, and the neighbors say they often hear Campbell beating his wife. Sunday afternoon he struck her on the head with a blunt instrument, making a dangerous wound. Mrs. Campbell fled to a neighbor's house, where her wounds were dressed, and she was made comfortable. Late Sunday night four men dressed in white caps, surrounded Campbell's house and dragged him into the street. Campbell's night-shirt was torn and in a single second he was lashed in a telegraph pole. The four men then whipped him until he became unconscious. His hands and limbs were covered with welts. He was carried back to his house and placed in bed. A crowd of the neighbors and brought a crowd to the scene, but when the masked men called, no resistance was offered.

**Maryland White Caps Murder a Woman.**

**FREDRICK, Md., Feb. 18.**—A party of masked men, numbering about thirty and posing as White Caps, surrounded the house of Dennis Davis, colored, at Brook Hill, six miles from here, at 9:30 on Sunday night, and calling for Mrs. Rebecca Bruchey, a white woman 40 years old, who was inside. They entered her of some intimacy with Davis and threatened to kill her. She was fatally wounded. None of the parties have been identified, nor have the authorities taken any action. She laid all night out the care of a physician.
