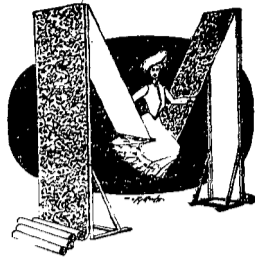

DECATUR VOTES R. R. BONDS

Strange Bird Shot at Jackson Lake—Columbus Closes Saloons Sundays—Work on Norfolk Asylum Going Ahead—Wakefield Woodmen Prepare for Picnic—Fremont Enforces Chicken Ordinance.

It is reported that work will commence without delay on West Point's new depot.

A. H. Krull, a veterinary surgeon of New York, has decided to locate in Wakefield.

Police authorities have passed an ordinance fixing a fine for bicycle riding on sidewalks.

Louis Gramke, for nearly forty years a resident of Omaha county, died in West Point Thursday night, aged 77 years.

J. O. Milligan of Wakefield is announced by the Republican of that place as a candidate for representative from the Dixon county district.

Fremont enforces its ordinance to prevent barnyard fowls from running at large. It is an ordinance that prevents much grief to vegetable and flower gardens.

The Swedish Mission church at Wakefield will hold mission meetings Friday, Saturday and Sunday, April 23, 24 and 25. The attendance of several outside ministers is expected.

Wakefield Woodmen have had a meeting to make preliminary arrangements for their annual picnic. It will probably be held in August, or after the backhills of winter has been effectually broken.

Work is being pushed forward with all possible speed on the new insane hospital at Norfolk. Instead of one building, there will be several cottages—the first arrangement of the kind to be inaugurated in the west.

Desnon Huse, who edits the WAYNE HERALD, printed a supplement last week containing all the news words he ever used; at least that is what we suppose, for it was printed in some foreign language—and we know it wasn't English or Irish.—Allen News.

On account of failing health Rev. Father Loecker has resigned as priest in charge of the Holy Trinity church at Hartington and will be succeeded by Rev. George Chamber of Omaha. Father Loecker is one of the best known clergymen in this part of the state.

Decatur voted bonds last week to aid the proposed electric railroad to that place. The vote stood 395 to 13. Grading is now in progress for an electric line from South Sioux City to Homer and it is believed to be a part of the same line in contemplation for Burt county.

The order of the mayor of Columbus for the closing of the saloons there Sundays went into effect last Sunday and was obeyed to the letter. Hereafter in that town those who can't pull through Sunday without the assistance of liquid inspiration must lay in a supply Saturday.

A bird of the loon variety, a stranger to this country, was killed near Jackson lake last week. The bird was one of a pair passing over the lake. It is coal black, with the exception of leopard-like spots on its back and mottled white on its wings. It is like the loon found in South America.

The bank at Naper, Neb., was entered by robbers at 3 o'clock Tuesday morning and the safe dynamited and robbed of \$1,200 in cash. The force of explosion wrecked the building, blowing out the entire plate glass front. The sheriff of Boyd county has been pursuing the robbers with bloodhounds.

Charlie Long well remembers the time when he was clerking in a drug store at Hartington 19 years ago as noted in our last issue. It was during the time of the changing of the county seat in Cedar county and Charlie said everybody in Hartington was full except himself and the only thing that kept him from getting "overjoyed" was because he was afraid to venture out of the store for fear he would be waylaid.—Wakefield Republican.

In last Sunday's Sioux City Journal was a picture of Minnie Hearn, the successful race mare owned by Frank Strahan of Wayne. This mare was out last year for the first time, was entered in six races and took the money in five

of them. She was raised by Dr. E. L. Rolph from his Nutwood brood mare. Mr. Strahan is now handling one of Dr. Rolph's colts, from the same mare, sired by Allerton, the \$125,000 champion sire of the world.—Pender Republic.

J. R. Manning of Wayne, has ardent supporters in the north portion of the state in his candidacy for commissioner of public lands and buildings and there will be many counties in this section that will send delegates to the convention to work in his interests. Mr. Eaton of Fremont, the present deputy in the office, appears to be Mr. Manning's strongest opponent and if his present position and consequent acquaintance with the officials of the administration and acquaintance in the South Platte country do not give him an advantage that cannot be overcome, Mr. Manning's friends will be reasonably confident of his success. To offset this advantage, if any exists, there is a considerable sentiment throughout the state, adverse to advancing deputies to the position of chief in the office where they have served, and the Wayne man's admirers are hopeful that his sentiment may be strong enough to prevent Mr. Eaton's lead. Anyway they propose to make a strong showing for their favorite and work early and late for his success.—Norfolk Daily News.

The New York delegates to the national democratic convention have been instructed to support Judge Parker for the presidential nomination. Thus, Hearst's fading boom received no attention in his home convention.

The Pender Republic gives a bunch of Nebraska City statesmen a blast of deserved criticism for advocating a law to disfranchise people who have no property on which to pay taxes. Better to make ability to read and write a requisite for the right of suffrage than to base it on dollars and cents.

N. D. Jackson of Neligh, has withdrawn as a candidate for clerk of the supreme court, and it is believed he will agree on an appointment. Judge Barnes has been favoring Mr. Jackson and Judge Sedgwick has been supporting Victor Seymore of Lincoln.

Representative Kinkaid is the father of a bill in congress to grant settlers in the extreme western part of Nebraska 1280 acres apiece under the homestead law. That seems to be quite a patch of ground to give one man, but considering its quality it is probably now worth less than ten acres in Wayne county.

The South Dakota congressional delegation has concluded to concede an increase of \$1 per acre for the government lands proposed to be opened for settlement in the Rosebud reservation. The concession is made to satisfy the wishes of President Roosevelt. According to the amended bill, the land will be held at \$1 per acre.

The storm of opposition to Gov. Miscoy in rival candidates disappeared as quickly as it appeared, and the present incumbent now rests assured of a renomination and re-election. Those who announced their candidacies, withdrawing after consulting the public pulse are now among the staunch supporters of the governor.

The people are endorsing Harry Lindsay for clerk of the supreme court and it is expected the worthy judges will do the rest—tender him the appointment. Mr. Lindsay was a popular candidate for United States district attorney, and realizing his eminent fitness and merit, his defeat for that place has aroused efforts to secure him the supreme court clerkship.

The Rosebud bill which provides for the opening to settlement of 416,000 acres of land owned by the Indians, has passed both branches of congress and will become law when signed by the president. The land being tributary to north Nebraska, the effect of the measure offering it to white settlers will add materially to the business activity of this part of the state.

The result of an interview with Senator Dietrich was published in Sunday's Omaha Bee, setting forth, among other things, his determination not to be a candidate for re-election. He commends both Hon. E. J. Burkett and Hon. W. E. Andrews as worthy successors. While the senator proposes to cheerfully abide by any action taken by the state convention in the matter of nominating a United States senator, he frowns on the wisdom of such an innovation.

While the new revenue law causes a great deal of annoyance and is faulty in some respects, it will undoubtedly develop through legislative remodeling into a system of assessment far more satisfactory than the old one. Needed changes will no doubt be made by the next legislature, and then, with the people accustomed to it, the law will operate justly and satisfactorily. Improvements in the first Australian ballot law had to be corrected to make it acceptable, and now that system of voting changed and perfected, seems indispensable. The same result will likely follow improvement of the new revenue law.



Personally, we have no ill will toward the Democrat man, but we certainly regard with repugnance his "by dad" filth and unwarranted attacks on people who have displeased him. He should recognize the fact that Wayne has advanced too far in civilization and education to tolerate his chosen methods and pursue a course more in keeping with decency and refinement.


