THE THIRD DISTRICT  
Pierce Call: The official vote of  
the state has just been made public and  
a study of the same discloses some very  
interesting if not startling figures. Es-  
pecially is this so in the eighteen count-  
ies comprising the 3rd congressional  
district of which Pierce county is a  
part. This district has for some years  
past been conceded to the democrats  
by a strong majority. The total vote  
cast in the recent election for presi-  
dent in this district was 49,664. Of this  
Wilson received 21,038, Roosevelt 13,  
400, Taft 13,186, Debs 222, Clafia 531.  
Thus it will be seen that Wilson fell  
behind the combined vote of Roosevelt  
and Taft by 4,950 votes. Roosevelt's  
lead over Taft was but 247. For United  
States senator Congressman Norris led  
Shallenberger by 1,867, while Congress-  
man Stephens defeated Cook, the Paul  
Moore candidate by 4,353. Morehead,  
for governor, ran 1,010 ahead of Gov-  
ernor Aldrich, but every other repub-  
lican on the state ticket carried the dis-  
trict by an average majority of 2,231.  
The weakness of the republican candi-  
dates for congressman and governor  
explains why Congressman Stephens  
and Governor-elect Morehead weather-  
ed the storm. As the Wisconsin Tribune  
says: "All this simply proves that the  
old district-fief republican whenever  
it wants to be." Still with the repub-  
lican ranks rent and under and the dem-  
ocratic forces fighting like "Kilkenny  
cats" over the political spoils, the re-  
sult in this district, state and nation in  
the two years is problematical. The old  
still believes in the principles of the  
republicans of Lincoln, Grant,  
Garfield, Blaine and McKinley, but  
the party cleavage in the recent campaign  
was so wide and disastrous that we  
are not sure whether our guns were  
aimed at a target or nothing.

NEBRASKA STATISTICS.

Omaha, Neb., December 24.—Though-  
tless in population among the twelve  
states of the middle west, which in-  
clude Illinois, Iowa, Kansas, Missouri,  
the Dakotas, Michigan, Ohio, Indiana,  
Wisconsin and Minnesota, Nebraska is  
third in number of cattle, fifth in num-  
ber of hogs, fourth in wheat produc-  
tion, fifth in corn production and sixth  
in oats production. These facts were  
made public by S. C. Bassett of Gibbon,  
in an address on Nebraska's rank made  
before the Nebraska Farmers' congress  
in Omaha last week.  
In comparison with the United States  
in total population, rural population and  
area, Mr. Bassett offered these figures:  
Nebraska has 1.3 per cent of total  
population, 1.7 per cent of the rural  
population and 2.5 per cent of the land  
area, yet Nebraska produces 7 per cent  
of the corn, 7 per cent of the wheat  
and 5 per cent of the oats.  
Nebraska produced 5 per cent of the  
entire corn crop of North America,  
Spain, America, Europe, Africa and Aus-  
tralia. A very remarkable showing as-  
serted Mr. Bassett.  
That Omaha makes possible the mar-  
keting of these crops is urged in favor  
of the co-operation of the state and  
metropolis. On account of this gigantic  
production, Omaha is the second live  
stock market of the world, the fifth pri-  
mary grain market and the fifth gen-  
eral grain market for corn. And Omaha  
ranks first as a creamery butter pro-  
ducing center, more than 20,000,000  
pounds annually being shipped from  
Omaha.
