**Go-Ahead by Commissioners** A \$3 million plus grant for the proposed Willow Creek flood control and recreation project southwest of Pierce, received the approval of the Nebraska Natual Resources commission. The board members, meeting in Lincoin, voled unanimously to allocate funds, according to Ray Hartung, administrative coordin-ator for the Nebraska Resources Development fund which will supply the money. Approval has been anticipated because of an advisory board beat administrative the state devel-opment fund last month recom-mended the Willow Creek pro-ject to the commissioners. Willow Creek meets the four standards by which the commis-sion measures projects: enviromental acceptability and tech nical, economical and financial feasibility, advisory board mem-bers concluded. The full com-mission agreed with the board, according to Hartung.

Money for the Nebraska Re sources Development fund is appropriated annually by the Legislature. Williow Creek will now be placed on a prioritized list of projects around the state destin-ed to receive development fund grants, Hartung said. Some money for Willow Creek will be available in July after the

Legislature appropriates funds, he added. The grant was for \$3,016,125 and will finance 58 percent of the \$3.2 million project cost. A grant from the Nebraska Game and Parks commission is ex-pected to pay 23 percent (\$1.2 million), while local funds would finance the remainlon 19 percent

finance the remaining 19 percent (\$1 million).

Plans call for construction of a 1,700-acre park that includes a 615-acre lake. The recreation area would include an arbor-etum, equesilan center, scenic overlook, boat ramps, three beaches for swimming, beth-houses, camping and picnic areas and an interpretative center. The game commission is expected to allocate funds it receives from the federal government next spring.



Overcoming the marriage penalty

(Third in a series of five articles from the Nebraska Society of Certified Public Accountants on preparing 1978 Federal income Tax Returns.) Tax treatment that is fair for everyone continues to slude even the most deter-mined tax reformers. Once again Con-gress has worked long and hard at re-shuffing the tax (aws, still no one would describe the results as a new deal, equitable to all.

A source of the second as a new deal, acuitable to all. An example of old inequities that per-sist is the "marriage penalty," which causes married couples to pay more taxes than two unmarried individuals with the same income, exemptions and deductions. This was not an intended result. It was an inadvertent side effect of efforts to correct a previous imbalance resulting from still earlier adjustments in the tax code.

of efforts to correct a previous imbalance resulting from still earlier adjustments in the tax code. The chain of unsuccessful attempts at achieving fair treatment for married and unmarried alike began in 1948, when it was decided that families should be treated as single economic units, with family income texad as though each spouse had earned half of it, thus sharply reducing the tax rate in cases where one spouse, in fact, earned the buik of the income. The income splitting option gave such families an advantage over those in which both spouses earned roughly equal incomes, and an even bigger advantage over single individuals. The latter pro-test this treatment and continued to do-o until 1971, when congress granted a more favorable rate for the single individual. Hwis putting the shoe on the other topi once more.

Since 1971 if has been working couples' turn to protest, and they have been doing so as successive administrations have wrestled with the problem, so far to no

Congress has resisted various solutions that have been offered, partly because it feared they would lead to excessive loss of tax revenues, but chiefly because changing the rules would violate the principle of progressivity, which requires that faxes be levied according to the ability to pay.

that faxes be levied according to the ability to pay is unresolved, what can married couples who both have incomes do to minimize their taxes? Forget about filing singly; the marriage penalty for that is even worse than with a joint return. Forget also getting a "quickle" divorce in December and then remarrying in January so that at year end you are "single." Internal Revenue Service has ruled such divorces, obtained solely for tax reasons, "are a sham and has decided they do not alter a couple's fax status.

sham and nas decided they do not alter a couple's fax status. What, then, can working couples do? First, they can be extra diligent in identifying business deductions. With two people employed in the family there is hvice as much likelihood of job-related deductions, such as business travel and entertainment.

entertainment. If you have to hildren or a disabled adult you have to hire someone to look after so hart both of you can hold loba, look into the child care credit. With two or more qualifying dependents this credit could be worth as much as 800, depending on

If one of you began working again in just the past year or so, it's possible that your combined incomes have taken a big jump in 1978. If so, you may be eligible for income averaging. This permits you to calculate your tax bill for the current year by assuming that you earned the income over a five year period; i.e., the current and preceding four years

Or if either of you is not covered by a pension or pofit-sharing plan, you might be able to defer until retirement the taxes on some income by setting up an individual Re-tirement Account.

trement Account. Give extra attention to the tax aspects of your investments. There is a world of difference among ways of financing your future. Many far-out investment schemes do not really shelter you from faxes: they simply push the taxes into another year, when your tax rate may be even-higher than it is now. But there are tax shelters that are perfectly sound — real estate and petroleum development ventures, for example, that offer tax breaks because Congress intended that they should. Talk over investments with your financial advisor — in advance.

working couples, and other taxpayers with higher than ordinary incomes, have reason to be concerned not just with their 1978 taxes but with those in future years, as well. For them, tax planning is a year-around necessity.
