of the administrative council, faculty senate and student senate will follow They will determine whether or not specific strategies need to be im-plemented to eliminate any problem that might exist," said Fleck.

"While we don't believe that racial differences were the underlying cause of that specific incident, I think we need to assess how adequately campus serves the needs of students," he said. all





THE WINSIDE Volunteer Rescue Squad purchased a newer unit in September 1987. The old unit, however, continues to be used as a backup.


A spokesman for the squad said


