

The winter of our discontent

When or will it ever end?

Last week's mild weather that melted away a winter's worth of snow was just the lull before another pair of dangerous and aggravating winter storms this week.

A Tuesday-Wednesday storm dumped six more inches of unneeded frozen moisture and Thursday night another couple of inches was added to the blowing, drifting piles.

Travelers warnings were issued for Thursday night and today with blowing snow cutting visibility to near zero and drifts reappearing across roadways faster than the snowplows could move them off.

MEANWHILE THE Elkhorn River continues to flood areas in

neighboring communities of Wisner and West Point as ice jams back up the runoff water. Officials fear the latest snowfall will only worsen the situation when predicted warmer temperatures this weekend send more runoff into the basin.

Schools were delayed two hours before starting Wednesday to give road crews opportunity to make way for buses and school traffic. Classes also were scheduled to start late today but were cancelled altogether when the blowing snow made country roads impassable.

With the harsh winter still several weeks from abating, area school officials warily eye the calendar and the lack of any more snow days in the schedule.

closure of schools additional days may have to be added in the spring or classes may be called on Saturdays to meet the state mandated schedule, according to Wayne Superintendent Dr. Dennis Jensen.

"I'd like it to end tomorrow," said Jensen of the winter which he characterized as only the second worst winter he has faced as an administrator. The worst was one year while he was an administrator in Minnesota.

"We've all had enough of it," he said of the miserable weather. "It affects everyone's attitude," he said.

Jensen said the schools have already been closed 4 days this year due to weather and have had delayed openings and early dismissal on 5 other days. The record should reflect that one early dismissal last August was because of heat. Beginning last fall the Wayne district scheduled five more school days than the state required minimum of 175.

THUS, THERE would normally

Political picture takes shape; deadline passes

The political picture is taking shape for the May primary election in Wayne County with Thursday's end of the filing period for incumbents. Challengers have until March 11 to decide to run.

All of the incumbents on the Wayne School Board will seek reelection. Willis C. Davis and Dr. Ken Liska both filed for reelection Wednesday and Cap Peterson filed last week. No challengers have filed to date for the board.

Wayne City Council will have at least two new members and voters will be electing a new mayor this year. Mayor Bob Carhart made good

his promise to serve only one term when he let the Thursday deadline pass without filing.

Third Ward council member Sheryl Lindau has filed for the post of mayor leaving her council seat vacant. In addition, Second Ward council member Pat Prather has decided to step down from council leaving her position open to a new candidate.

Dan Zulkosky filed Thursday as a candidate for the third ward council seat.

Previously First Ward incumbent

Chief warns about solicitors

Wayne Police Chief Vern Fairchild has said his office is receiving a number of inquiries about a telemarketing firm which is soliciting funds for the "Fraternal Order of Police."

He said several people in Wayne have apparently been contacted by the organization, which he said is a legitimate police officer's union, however, he said some people have apparently been told the organization represents police officers all across the state, when in fact none that he knows of are from this area.

He called the reference to state-wide representation "misleading." Fairchild said if residents here contributed to the organization thinking they were benefiting local law enforcement officers, they would be mistaken. The funds would most likely benefit Omaha Police officers, he said.

City Council approves tax break for project

Wayne City Council has approved a \$250,000 tax incentive plan for the developers of a new retirement housing complex in the city.

The tax incentive program means Excel Corporation, which will begin building 44 retirement housing units in the Vintage Hill subdivision this summer, will be loaned \$250,000 from a bank under an agreement that all property taxes on the improvements in the new development will be passed through to the lender until the loan is paid off.

Taxing entities including the schools, Wayne County, the natural resources district and the city will have to forego property tax receipts from the new development until the loan is paid off.

City administrator Joe Salitros said the new development should pay in the neighborhood of \$46,000 per year in property taxes after the project is developed. That should mean it will take about eight years before the city, schools, county and other taxing entities start receiving

tax revenues from the new project.

No one attended the public hearing Tuesday night to discuss the tax incentive plan for the project as a winter storm raged outside. The plan generated some controversy earlier when Boyle Companies, owner and developer of the Wayne Care Centre, said approval of the tax break for Excel would be unfair since the new corporation would compete with Wayne Care Centre. In addition Care Centre officials said they were rebuffed by the city when they had asked for tax incentives for the new care centre development.

Salitros said recently the city and Boyle Companies have discussed the possibility of similar tax incentives for an assisted living complex planned as an annex to the new Care Centre.

The vote by council was unanimous on the tax incentive for what was described as a \$2.5 million retirement housing project developed by Excel.

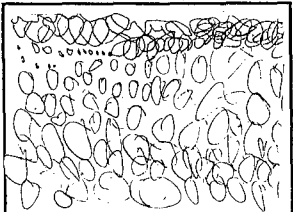

Building projects set Wayne record in '93

Building activity in Wayne more than doubled in 1993 setting a record building year for the community but the amount of building on new residential units was well below previous years.

With only eight new housing starts in Wayne last year, the community's housing shortage, estimated at over 200 units in planning documents, continues to be the number one development priority.

These messages were contained in the annual report of the planning and building department of the city of

Wayne which was presented to city council Tuesday evening.

CITY PLANNER Don Siefken presented the report which showed nearly

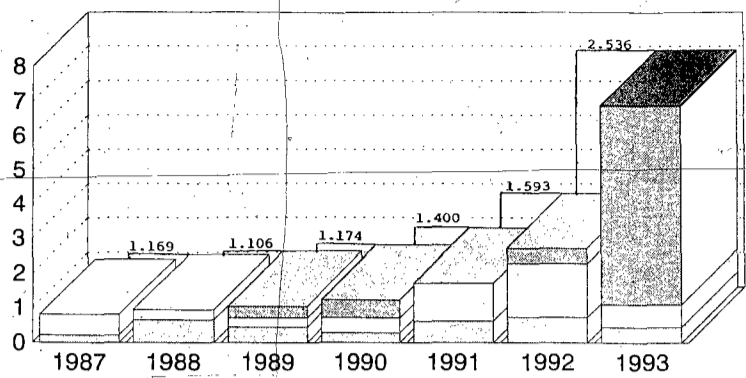

\$7 million worth of construction projects in the city last year. He told council, however, that 1993 may not be a record year for long.

This year is shaping up to outdistance last year by a dramatic amount again, said Siefken.

He cited numerous housing projects including the new \$2.5 million Excel Corp. retired housing project, the new student center project at Wayne State College, planned expansion at Restful Knights, the new clinic at Providence Medical Center, and other projects as reason for optimism for 1994.

ONE FACTOR holding the number of new housing starts down in 1993 which could also be a severe problem for 1994 is a shortage of

qualified construction workers.

Siefken said he knows many of the area construction workers have been hired to work on the WSC building and the Wayne Care Center project. He said many residents have discussed housing projects with the city building office and plan to begin construction as soon as a tradesman can be found.

"The waiting list is extremely long," said Siefken of the building plans.

Mayor Bob Carhart, asked Siefken if he knew of ways to get more tradesmen in the community and Siefken said he hopes many of the workers imported for the Wayne State and Care Centre projects might see the opportunity for long-term future employment in Wayne and stay in this area.

SIEFKEN ADDED that a shortage of suitable building sites has also limited the number of new housing starts in the last year. He said this situation should change this year with the development of several new subdivisions in the city.

He said the economic incentives through the new Wayne Housing Corporation's housing development assistance program should also boost the residential housing projects. The city has earmarked \$200,000 in the economic development loan fund for housing project assistance.

"Housing (shortage) is holding people from moving to our area," said Siefken, who cited the oft quoted statistic that two thirds of the employees who work in Wayne manufacturing plants live outside the Wayne area.

be only one day left for school dismissal because of weather. However, Jensen said the state requirement also calls for minimum of 1080 hours in high school classroom time each year which equates to a 6-hour day. Since the Wayne school schedule is set up on an approximately 7-hour daily schedule, the district will have several days worth of cushion at the end of the year even if more school days are cancelled because of weather.

The weather situation this winter has left road maintenance crews with the city, county and state harried and frazzled.

When the crews aren't out plowing and spreading gravel mix they have been frantically trying to keep equipment maintained and salt and sand supplies stocked for the next bout, said Wayne City Administrator Joe Salitros.

"IT'S A TIRING, frustrating pro-

cess keeping the streets cleared," said Salitros, who added this winter has been unusually difficult for street crews.

He said the total cost in overtime, materials and equipment repairs is likely to be abnormally high too, but no one has had time to sit and calculate the costs.

Wayne State College classes were called off early Friday because of the high winds and blowing snow conditions.

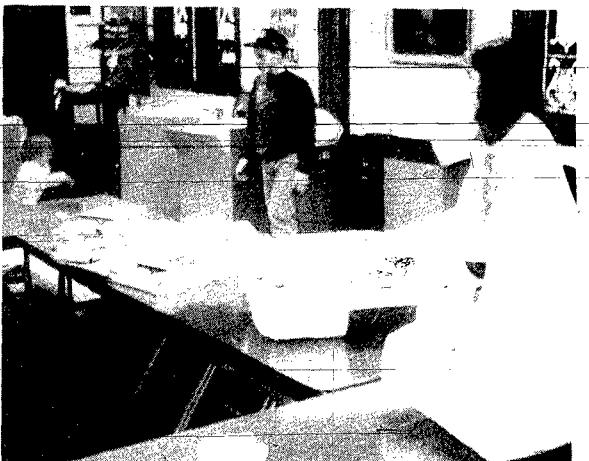

Laurel boys lose to Cedar in Subdistrict title game

The Laurel boys basketball team came with in a half second from winning the C1-7 Subdistrict championship over top 10 rated Hartington Cedar Catholic, Thursday night in Wakefield.

Unfortunately for Clayton Steele's Bears, Cedar's Brian Kinney launched a 22-foot missile that found nothing but the bottom of the net to tie the game and send it to overtime.

Laurel missed three front ends of one-and-one's in the final 30 seconds of regulation and Cedar's clock beating bomb to tie the game crased an 11-point Bears lead in the final 4:10.

Still, it appeared the Bears were in good shape in overtime as they built a three point lead and had possession of the basketball with a minute to go. The Bears, however, missed on their ensuing possession and Cedar came down the court and scored which made it a one point game at 47-46.

Laurel was fouled on its next possession and the Bears again missed the front end of the one-and-one and Cedar went for the last shot and the win. Kinney, who had sunk four, 3-pointers in the game took a long shot with about six seconds to go which barely drew rim.

Instead of the ball bouncing out for the rebound it came straight down into the waiting arms of McGregor who put the shot back up off the glass for the easy bucket and the lead with five seconds left.

The Bears tried an in-bounds pass which hit the rafters, thus turning the ball over to Cedar. Laurel fouled right away with 2.8 seconds left and Cedar missed the one-and-one opportunity.

Shane Schuster took possession of the ball at about the three-quarter court area and as he went to pass the ball he slipped and the ball never went passed half court thus, ending the Bears season at 16-5 with a 48-47 setback.

Cedar will play Randolph, an overtime winner over Crofton in the C1-8 Subdistrict championship, Monday at Wayne State College. Cedar will be seeking its fourth straight state tournament trip and if successful, the Trojans will seek their first state championship during that successful tenure after losing in the Class B finals to Wahoo last season and losing to Wahoo Neumann in the championship of C-1 the year before.

The Bears led 10-5 after the first quarter and scored the game's first eight points before Kinney knocked down a 3-pointer for the Trojans. Laurel's lead was trimmed to two at the half at 21-19 and Cedar took its only lead in regulation 16 seconds into the third quarter when Jaime Jones drilled a 3-pointer to give the Trojans a 22-21 lead.

Laurel, however, proved unshaken by the sudden change of momentum and the Bears went on a 14-2 scoring run to close out the third quarter with a 35-24 lead.

Sophomore point guard Tyler Erwin led Laurel in scoring against Cedar with 14 points while Jared Reinoehl netted 12. Jeremy Reinoehl scored 11 points and played nearly the whole game despite being in major foul trouble.

The 6-3 junior got his third foul with over five minutes remaining in the first quarter and yet played half of the second quarter with out picking up his fourth. He did get whistled for number four with less than a minute gone off the clock in the third quarter but managed to play the rest of the game.

Laurel connected on 15 of 22 free throw attempts while Cedar was a dismal, 1-5. Kinney led the winners with 14 points while Jones tallied a dozen.

THE BEARS reached the championship game by defeating Pender on Tuesday, 61-49. The Bears led by a 26-21 margin at the half but out-scored Pender, 17-5 in the third quarter to virtually put the game away.

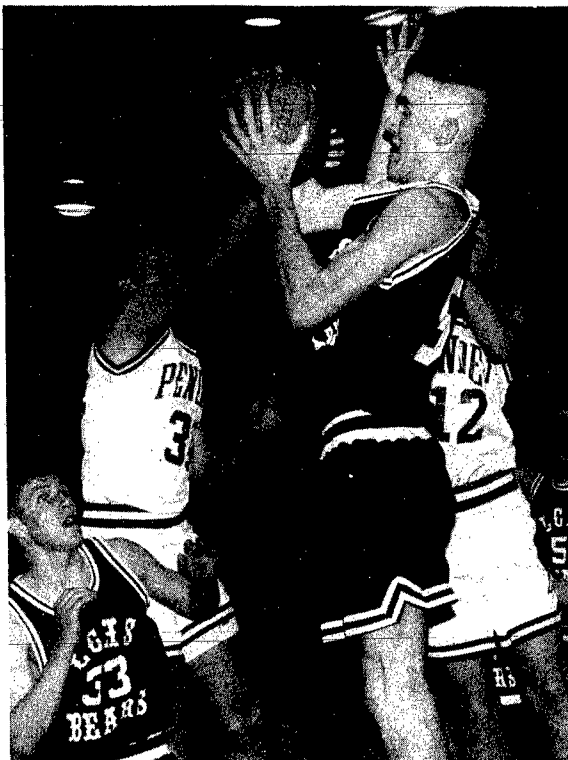

From the Desk of the Superintendent

On Monday, Feb. 7, the district was visited by the Department of Education for the purpose of reviewing our curriculum; our elementary, middle and high school schedules; our instructional hour policies; our multicultural education policy; our performance reporting policy; and our most recent school system performance report. Jerry Jordan and Claudia Carter with the Approval and Accreditation section with the state department of education were the reviewers. The exit interview was held in my office at 3:00 PM with Board members Marion Arneson and Phyllis Spethman in attendance along with Dr. Don Zeiss, Mr. Richard Metteer; and Mr. Dave Lutt. It was an interesting experience since this was the first visit of this type by the department during my time here and what the state reviewers have to say does carry some weight since they approve school districts under Rule-10 — not following their requirements could mean loss of accreditation — but, our district came through with flying colors.

The reviewers were sent our policies; schedules; curriculum offerings; and performance reports in advance of their visit giving them time to be familiar with our district before actually touring the buildings. They were extremely interested in our recent efforts at updating our technology offerings; in our curriculum improvement plan; and in keeping our staff current with inservice training. Claudia toured the elementary building and the high school; while Jerry visited the middle school. After the tours, they all met in my office to share with us their findings.

Claudia Carter applauded the district's efforts in the area of technology and was impressed with the level of Board support for providing funding for such changes and improvements. In the area of curriculum, they found no area where the district did not meet minimum standards — and in most areas the district excelled — or provided offerings above the minimum number required. During the visit, the reviewers were guided through our local school improvement process and they were happy to see that we were interested in the performance level of all our students — meaning, even though the Wayne district has an excellent history in many areas — especially in graduation rate, in how many students go on to post-secondary education, and in the total averaged test-score results compared to any other district in the state: we still need to focus efforts at how our students are performing ranked in the lower third academically. The district's efforts in the area of curriculum change has brought attention to students in these categories and, with time, we expect to see improvements in these test score results.

They concluded their exit interview by saying that overall they were impressed with the improvements and the general direction of the district and complemented the Board on their vision and their work.

I want to complement the administrators, faculty and staff for their constant efforts at giving the students their best at all times. The results of this review, and reviews from the past, serve as examples to the community of the quality educational programs offered to all the children of Wayne and Carroll. The district's philosophy on serving the children is simply 'ongoing and continual improvement'. We want the students well-prepared for the future and to accomplish this, the district will seek out what works best for us and strive to challenge all students to the peak of their academic abilities.

Middle School

As we leave winter behind and enjoy a beautiful spring, the middle school will have a number of student activities in and out of the classroom. The fifth grade will be collecting water samples for analysis, the eighth grade will be writing about Wayne history, and so forth. Weather permitting, the seventh and eighth grade will be getting ready for track season at the end of March. On March 18th the end of the third quarter will be here with report cards sent home the following week. We plan to keep busy.

Special Education

Ever wonder why we have Individual Education Plans (IEPs)? Why take the time to write them once a year if teachers and parents put them away until next year? Nebraska's Rule 51, regarding special education services, requires that an IEP be reviewed yearly. We - parents, teachers and student - are not limited to once a year. If we are working to help the student learn, let's talk about the objectives on our IEP throughout the year ... parent/teacher conferences, telephone calls or end of the year reports. Teachers ... measure the student's growth periodically and share the information. Keep the communication open, factual and productive. Parents ... expect progress reports and share concerns and observed growth.

In the near future our special education teachers will be contacting parents to set up times for an IEP review. This is a very important time because it will give all of us: parents, teachers and students an opportunity to look at the progress made over the course of the school year. The IEP review is also a time when planning for the next school year takes place.

Student, teachers, and parents work together as a team. We set aside times (at least once a year) to review progress, to reflect and respond to the previous program, and to revise and plan a program to meet the student's needs for the coming year. We're a TEAM with an AGENDA and a PURPOSE.

Tech Prep
Not all high school graduates are ready, right out of school, to make the commitment needed to enter a four-year college. Still, they may not want to limit their options.

The logical choice for these students is often the two-year degree offered by community colleges. Unfortunately, however, the courses required in a "General Education" track in high school often do not meet the two-year college entrance requirements.

In recent years, a new option in education called Tech Prep has been developed to give these students an alternative and to prepare them with the skills they will need for a two-year college degree and a high-skill, high-wage career.

Wayne High School, in consort with Northeast Community College of Norfolk, is preparing a Tech Prep track for implementation during the 1994-95 school year. Students entering the High School will choose from either College Prep or Tech Prep. The General Education Track will no longer exist.

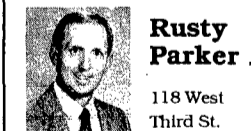
