City may look to expanding

Revision of the policies on annexation of lands adjacent to the city of Wayne and especially those which are already receiving city utility services, will be considered by city council at upcoming meetings.

Council heard a plea for development of a specific plan for expansion of city limits from Administrator Joe Salitros Tuesday and the four members present at the meeting asked him to formalize a plan for consideration by the full council.

At issue are several tracts which either currently have city utility services and are outside the city limits or the land has been all but surrounded by previous annexation moves creating "islands" of unincorporated areas.

Salitros said he doubted many of the landowners involved would be interested in being annexed because it would mean their taxes would raise by the nearly 60 cents per \$100 of assessed valuation that the city levies.

He said the discussion was prompted by the planned develop-

Wayne among 'spruce up' leaders

Wayne will be among the leading cities in the State in participating in Keep Nebraska Beautiful Month

with special "Spruce Up Days" April 22 and 23.

The Wayne Jaycees will be sponsoring their annual curbside refuse pickup Friday, April 22 beginning at 6 p.m. The cleanup is designed to get rid of paper, plastic metal items and bulky objects as well as twigs and branches.

The program is not designed for residents to clean out their basements and garages, said chairman Garry Poutre. Appliances and furniture items will not be accepted.

Jaycees are encouraging the pub-

lic to collect rubbish from alleys and adjacent public lands for hauling during the clean-up day. Saturday, April 23 has been designated as the rain date.

"Spruce Up Nebraska Day" has been established by the Keep Nebraska Beautiful organization, which is encouraging communities statewide to conduct programs like that being planned in Wayne. Other events surrounding the day will be tree and flower planting on public lands, park spruce ups and litter pickup.

Wayne excels at Business Day

Wayne High Business students under the direction of Sharyn Paige scored well at the Business Day competitions held at Wayne State College Thursday. Wayne finished 7th out of 48 schools participating in the contest.

Paper drive is scheduled

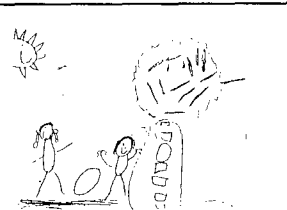

Moving day is fast approaching for the Wayne Care Centre and administrators are busy with preparations for the logistical problems associated with moving over 100 elderly residents into the spacious new building on East 14th Street.

May 2 is the official start of the move which Administrator Connie Disbrow expects to take as long as a week.

There's still a good deal of finishing work which must be done in the two weeks remaining before moving week and some of the exterior landscaping will be completed after the residents move in, she said.

CARE CENTRE staff members have enlisted the aid of services clubs and community organizations who have agreed to provide manpower and assistance with the residents during the moving period. Volunteers have come forward from Wayne Kiwanis Club and Rotary Club as well as Scouts and other organizations she said.

Ms. Disbrow said the small items and nonessential pieces of furniture and equipment will be moved first. When residents arrive in their new rooms, she said she wants to have their pictures and personal items in

their new rooms so they feel comfortable.

A MOVE OF this nature can be traumatic for some residents, she said, even though the residents are excited about what has been described to them as a spacious and

airy new home.

The \$3.3 million development project increases the capacity of the existing facility on Main Street by more than 20 percent. It is being developed by Boyle Companies as the first phase of a complex that will include assisted living units and in-

dependent living cottages in the next phase.

The new Care Centre means the addition of 15 to 20 new staff members and dramatic increases in meeting, dining, recreation and chapel areas.

School board offers contracts; hears reports

Contracts have been offered to all existing teachers in the Wayne School System who have not already offered their resignations and the teachers will have until the end of the month to make decisions about returning to teach in the Wayne system next year.

The contract offers were issued Tuesday by the Wayne School Board. The school personnel situation involves one shift and reduction in force, Superintendent Dr. Dennis Jensen told the board.

The part-time position by the resignation of Jerry Caraway, part-time fifth and sixth grade physical education teacher, will be filled with an existing teacher who is qualified and has available time in his schedule Jensen told the board.

A high school social studies and wrestling coach is being sought to replace Todd Viereck who has resigned. The assignment of a new athletic director has not been announced pending the acceptance by the individual to whom the post has been offered.

Another personnel change discussed by the board involved the request for school nurse Lu Ellingson to be funded from four and a half to five full days a week.

Jensen said the need for a full time nurse is becoming more evident.

"There are so many types of (nursing) situations that put teachers at risk," he said.

In other business at the board meeting, the board approved the school calendar for 1994-95. It calls for classes to begin Wednesday, August 24 and end on May 24. Christmas vacation will be from 2 p.m. Dec. 22 to Monday, Jan. 2.

The board also approved the qualifications for graduation for the 75 members of the class of 1994.

Board members also heard a report from Jensen on the status of the facilities study committee which decided at its last meeting not to recommend refurbishing of the existing Middle School building but rather to build a new Middle School as an attached wing of the High School and add facilities such as additional gym, administrative and theater space which both schools would share. The recommendation is expected to cost approximately \$9 million.

The board is not expected to take action on the committee recommendation until further study arrives at a conclusion of the questions surrounding a possible new elementary school building in Carroll. Discussion in Carroll has centered around the community throwing in with the needed construction of new classrooms there to build a community center attached to the school.

The facility study committee has scheduled another meeting this month to discuss the Carroll options but members said their Carroll recommendation should be a part of the whole district building plan and not seen as a separate entity.

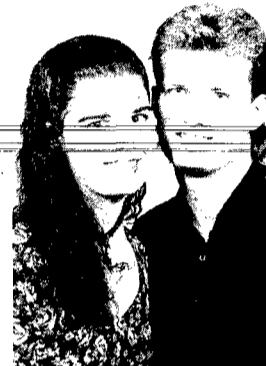

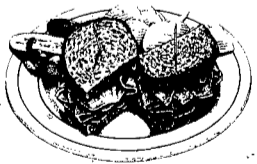

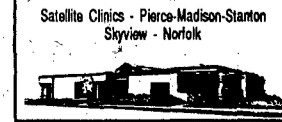
