### **Council votes to** rescind contract

In a special meeting on Monday, the Wavne City Council voted to rescind a previous resolution which would have allowed for a contract to be signed with Waste Managements Systems for residential garbage pick up

After considerable discussion and dialogue with the present haulers, the council voted to continue garbage pick up as it is at the pre sent time

Both Lueders and Mrsny Sanitation plan to work with the city to make recycling trailers available at the current recycling center more frequently. Currently, the recycling center is open Saturday mornings from 8 a.m. to noon.

An arrangement has been made with a Pierce recycling firm to collect materials from the current site

on a bi-weekly basis. This is being done at no charge to the city.

The local haulers also indicated that should the increased availabil ity of recycling not be successful in reducing the amount of solid waste going to the landfill within a two year period, they will consider curbside pick up of recyclable materials





### - Editorials -**Busy courthouse**

Figures for 1995 indicate both the county and district court continued handling record caseloads.

New cases filed in the district court numbered 125 including 15 criminal, 16 civil, 85 domestic relations, and nine appellate. County court personnel handled 2,655 cases: 1,633 traffic; 576 parking tickets, dog-at-large, etc; 30 felonies; 268 civil; 81 small

claims; 41 probate and inheritance tax; 4 conservater/guardianships; 6 adoptions, and 16 juvenile cases.

These combined figures represent considerable human traffic entering, using, and leaving the aging, inadequate structure. Hundreds of others use the building for a diversity of reasons such as paying taxes, licensing vehicles, getting and renewing driver's licenses, veteran's services, county extension functions, and contacting county government personnel for a myriad other purposes.

After observing the clumsy "lift", the gaping hole it leaves at its base when in use, the question arises as to just how long the old building can adequately serve the public.

Building costs have doubled in recent years. Will taxpayers wait until costs double again before creeting a modern building for government?

ing their own version of "Where's Waldo?" these days. You've seen Waldo, the geeky

looking cartoon character in the redand-white striped stocking cap. The object is to find Waldo in a sea of similar, geeky looking folks. Thus the title: "Where's Waldo?"

Voters in North Omaha now are playing a game called "Where's Dan?" It's a variation of a game that's been played for years concerning politicians and their 'principal residence.'

The latest rumble is over State Sen. Dan Lynch, who has served his north-central Omaha district for the past 12 years. Trouble is, Lynch sold his family home in the district two years ago and transferred his legal residence to a rented room in a friends house.

He admits that he visits his "residence" only once or twice a week and spends most of his time at a cabin near Fremont or at an apartment in Lincoln

But Lynch says the rented room meets the state residency requirements. That's where he votes, that's where he gets his mail; that's where he has a phone answering machine, that's where you'll find "Waldo," I guess.

It could be legal. State law, is vague and state senators are the ultimate judge. But more than a few folks, including fellow Omaha Sen. Kate Witek, say it's probably not proper.

People are already cynical enough about government, Witek said, and aren't willing to swallow that a seflator's "residence" is what amounts to a mailing address.

(Remember, this is the country where fewer than half of eligible voters cast ballots in November.) This residency question crops up

every so often in government. State Auditor John Breslow is supposed to live in Lincoln but resides just across the city line next to the Firethorn Golf Course. State Treasurer Dave Heineman lives in Fremont, a one-hour commute to

### Star Town to satisfy the legal requirements.

It's no secret that Gov. Nelson spends many of his night time hours at this Omaha home, not at the Lincoln mansion.

Bobby Kennedy didn't live in New York but was elected to the U.S. Senate in that state more than 30 years ago after a quick move there. And George Bush, when he was president, kept a hotel suite as his official residence in Texas so he could vote in that state, even

Lincoln, but rents an apartment in though most of his off-prez time was spent in Maine. So Lynch is not alone in this

game. But his residency question is different: he was elected to represent a district, not an entire state.





How strange that the one who tried to hold things together in the face of obvious rejection often finds herself wondering, "How did I fail him? I just wasn't woman enough to hold my man . . . I am 'nothing' or he wouldn't have left . . . If I only had been more exciting as a sexual partner . I drove him to it . . I wasn't pretty enough . . I didn't deserve him in the first place.

The blame for marital disintegration is seldom the fault of the husband or the wife alone. "It takes two to tango," as they say, and there is always some measure of shared blame for a divorce. However, when one marriage partner makes up his mind to behave irresponsibly, to become involved extramantally, or to run away from his family commitments and obligations, he usually seeks to justify his behavior by magnifying the failures of his spouse.

By increasing the guilt of his partner in this way, he reduces his own culpability. For a husband or wife with low self-esteem, these changes and recriminations are accepted as fact when hurled his way. "Yes, it was my fault. I drove you to it." Thus, the victim assumes the full responsi-

bility for his partner's irresponsibility, and self-worth shatters I would not recommend that your friend sit around hating the memory of her husband. Bitterness and resentment are emotional cancers that rot us from within. However, if I were counseling her, I would encourage her to examine the facts carefully. Answers to these questions should be sought:

Despite my human frailties, did I value my marriage and try to preserve

Did my husband decide to destroy it, and then seek justification for his actions?

Was I given a fair chance to resolve the areas of greatest irritation? Could I have held him even if I had made all the changes he wanted? Is it reasonable that I should hate myself for this thing that has hap-

pened? Your friend should know that social rejection breeds feelings of inferiority and self-pity in enormous proportions. And rejection by the one you love, parneularly, is the most powerful destroyer of self-esteem in the entire realm of human experience. She might be helped to see herself as the victim of this process, rather than a worthless failure at the game

As a moral issue, fatness is perceived to stem from weakness. laziness and gluttony. In the medical model, fatness is a disease that can be aided by diet plans, medications, exercise prescriptions and professional guidance. Both models leave the impression that fatness is bad, unhealthy and a threat to quality of life.

New approaches-Lack of success in addressing weight management has created a growing dissatisfaction with traditional models.

Rather than asking "How\_can I get and stay thin?" better questions might be, "What are my real goals?" and "How can I be healthier and happier?"

Size acceptance and non-diet movements are emerging to answer these questions and are creating a new weight paradigm.

Non-diet approach. This focus & on adopting attitudes and behaviors to enhance quality of life Restrictive diets aren't used. Modest weight loss may or may not be encouraged. Dictitians, nutrition educators and other health professionals tend to be more supportive of the non-diet approach rather than the size acceptance model.

Size acceptance-This model challenges our societal values. It rejects the concept that fatness is

themes emerge such as self acceptance, using internal control of eating, paying attention to the quality of food eaten and increasing physical activity.' The focus is not on weight loss but on actions that contribute to mental and physical health.

National health statistics show increasingly being overweight has resulted in under reaction as well as over reaction

However, it's time for consumers to sort out the issues and determine which is most-helpful. As traditional approaches may not be working, it might be a good time to rethink beliefs about weight and try new approaches for the future.

### Aspirin for Stroke Prevention

In addition to reducing pain, fever, and joint inflammation aspirin has been used successfully to lower the risk of heart attacks. In one study of healthy meri between the ages of 40 and 84, one 325 mg tablet of aspirin taken every other-day lowered heart attack risk by almost 50 percent. More recently aspirin has been shown to prevent strokes, and "mini-strokes." A Canadian study of 585 patients reported a 48 percent reduction in strokes and/or deaths in men who received 650 mg of aspirin twice daily. The larger Swedish Aspirin Low Dose Trial reported an 18 percent reduction in strokes in persons receiving 75 mg of aspirin a day. And they suggest enteric coated tablets which may be better tolerated than plain aspirin tablets
