Last classes leave District #25

A farewell picnic was held Sunday at School District 25 located nine miles south of Wakefield on Highway 10.

The school is closing after more than 30 years of educating the area's young people.

District 25 was actually the result of a merger of Districts 4, 25, 27 and 28 in 1960. The first classes were held in the new building in January of 1961. At that time there were a total of 41 students in the school.

Prior to that, on May 23, 1960, a \$15,000 bond proposition was voted on and passed. On June 14,

1960 just under two acres of land were purchased from Fred and Mita Jelde for \$721.

Maurice Henning, Robert Hansen and Alvin Westerhold made up the first board of education.

Helen Kal taught the lower grades and Rosalie Taylor taught the upper grades in the two-room school.

Terry Kal and Connie Spangler were the first eighth graders to come out of the school. The first Kindergarten class was made up of Randy Bird, Becky Clouser, Carol Henning, Terry Henrichsen, Keith Korpela, Jon Webster, Brian Kal and Michael Hansen.

As surrounding schools closed, the school grew. Districts 7, 1, 34

and 64 also became part of District 25.

The largest number of students to attend the school at one time was 31 in 1961-62.

This year there were only nine students at the school.

School officials say the decline in numbers are due to a number of factors including home schooling, option enrollment at other schools and a decline in the number of school age children in rural areas.

In the 37 years that the school has been open, there have been 212 students attend the school. 19 teachers serve the district and 10 members of the board of education.

A decision will be made in July concerning the future of the building. There is a possibility that it may continue to house students should the Wakefield Community Schools decide to use the facility as a satellite.

The district is approximately 80 percent affiliated with Wakefield and 20 percent with Pendleton. Students have also gone on to attend school at Wayne and Wayne.

The district includes all of Dodge, Medina and parts of Plum Creek, Englin and Thresher precincts. In

Concord youth to be featured on TV

Cory Peterson, 18-month-old son of Diana and Nick Peterson of Concord, will be coming to St. Luke's Children's Hospital along with their parents on the ninth annual St. Luke's 4-Mile Champion Television Special Saturday and Sunday, May 11 and June 1 on KHQ-TV Channel 4.

The Petersons are scheduled to appear from 9:45-10:15 p.m. on Saturday and 2:45-3:15 p.m. on Sunday. They will talk about the care they received at St. Luke's Regional Medical Center.

Cory was rushed to St. Luke's by ambulance on March 25 when he was diagnosed with juvenile diabetes. He remained hospitalized until April 6 due to complications. Today he is home with his parents and after their almost 3-week family vacation is learning to cope with Cory's diabetes with the help of St. Luke's health experts.

The mission of the Children's Miracle Network is to generate funds and awareness programs for the benefit of children treated by the associated hospitals. Among the children's health care areas benefiting from the 4-Mile 40 raised locally in 1989 are St. Luke's Maternal Intensive Care Unit, Family Birthing Center, Pediatric Intensive Care Unit, Emergency Center, Birth Defense Center, Infants' Critical Care and Rehab Services.

The telecast begins at 8 p.m. Saturday and ends at 9:45 p.m. on Sunday. The first 40 minutes of each hour will come from the national headquarters at Disney World's new Wide World of Sports Complex and feature educational segments focusing on local problems children face as well as healthy and safety issues for families, entertainment, sports news and personal health stories of children recovering from illness or injury.

The last 20 minutes of each hour will air live from KHQ-TV's studio and feature interviews with champion children and their parents, check presentations and visits with people who make a difference in the health of St. Luke's children.

Cory is one of 18 young St. Luke's champions cared for at St. Luke's Regional Medical Center in Sioux City for their illness or injury who will be featured on the telecast which has a goal this year of raising \$15,000.

Since 1989, St. Luke's has raised more than \$1.2 million to benefit children's health in St. Luke's 4-Mile using all 161 member hospitals in the United States and Canada that make up the Children's Miracle Network.

Council approves land annexation

There was no public input, either for or against, regarding the proposed annexation of a parcel of land into the city of Wayne during a public hearing at Tuesday's City Council meeting.

The land in question is a thin, irregular piece of land just north of Highway 10 and just west of Continental Road on the east edge of Wayne contains approximately five acres. However, the annexation includes the right-of-way on the roads both to the south and east of it.

The Ahlers family of Wayne have plans to develop the area into a truck stop through a project that is estimated to cost approximately \$1 million.

The council voted to waive the three readings of ordinance 97-5 and give final approval to the annexation of the land.

A number of people spoke against the possibility of re-zoning the former Carl's Extra facility from its current rating to an R-3 multi-family area.

Al Ahlers, a property owner in the area, said that he questioned whether or not the proposal was ethical. He also said that he did not oppose the apartments, but was opposed to the R-3 zoning and "pot zoning was not legal."

"I do not think it was in everyone's best interest," he said.

place more than 40 property owners at a disadvantage. "Hope the decision that is made is one that won't come back to haunt us," Ahlers said.

Craig Hedtke, who also owns property in the area and had the R-3 zoning and felt other solutions to the problem need to be looked into.

"I think we need to look into getting a public entity, such as the Wayne Housing Authority, involved with this property. This would assure additional involvement if problems arise."

Jamie Johnson told the council he felt a formalized plan needs to be in place before any action can be taken.

"At the present time, there are too many unanswered questions. If the building were re-zoned to R-3 and then sold, anything could be done with it."

The council did vote to move ahead with the preparation of an ordinance which would amend the zoning map. That ordinance would have to be approved on three readings before it would become effective.

In other action, the council approved requests from the Kiwanis Club for use of tables during the Chicken Show and from the Chicken Show committee for financial assistance and permission to block off streets around Bresler Park.

New counselling service is now open in Wayne

There's a new counseling service in Wayne which specializes in working with children.

Associated Psychologists and Counselors (APC) is located at 103 East Third Street and is a satellite office from the Norfolk home office.

Jill Woodward manages the Wayne office and the trained professional counselor says they do all varieties of counseling including individual, families and couples. "I really specialize in working with youth and adolescents," Woodward said.

A native of Sioux City, Woodward has recently published an article which will appear in a book sometime this summer entitled, "The Therapist's Notebook of Techniques and Intervention." The publisher

will be Newbern Press out of New York.

The article will be directed to other counselors, Woodward said. "I wrote a chapter on stops talking intervention with children."

Woodward will also be presenting the same topic at the Iowa Association of Play Therapists annual conference in September. Woodward earned her Bachelor's degree in Psychology from Buena Vista and attended the University of South Dakota to earn her Master's degree. She is currently beginning work on her Doctorate degree at USD as well.

"I was a school counselor at Kingsley-Pleasant High School in Iowa and Mt. Pleasant High School," Woodward said. "I've also

New program for housing is being offered

The Wayne Community Housing Development Corporation (WCDC) announced this week the launch of its newest program to help low-income and disabled persons into homes of their own.

The WCDC Purchase/Rehab/Rent program will allow WCDC to purchase inexpensive housing that needs a moderate amount of rehabilitation in order to bring it in line with existing building codes, current home maintenance and recall a quality home to a qualified family with 20 percent of the purchase price in down payment assistance.

In order to qualify for the HOME Purchase/Rehab/Rent program, family income needs to be at or below 80 percent of the

Wayne County median, as projected by family size. Any qualified family can project to identify a house for consideration for WHDC rehabilitation.

Once a house is qualified, WHDC can purchase the home, perform rehabilitation and resell the corrected house to the family. Additionally, WHDC will offer the family 20 percent of the total purchase price as a down payment toward permanent first mortgage financing — this down payment taken in the form of a no-interest second mortgage that is forgone entirely after the family has lived in the house for 10 years.

WHDC will be working closely with the local Realtor to put qualified buyers together with qualified housing. However, qualified buyers can also be linked with qualified families directly through WHDC. Anyone who has a house to sell that is in need of some rehabilitation or modernization is encouraged to contact WHDC for consideration under this program.

Park and on three sides of the Wayne County Courthouse for October 10.

Council also approved a request by the Wayne Police Department to expand the curfew to allow for the collection of a \$15 fee from juvenile offenders, predators and traffickers.

At the present time, there are only four curfews in place in residential areas required to have a permit, but no fee is required for this permit. Police Chief Lance Wilkerson told the council that the costs to process the 40-50 permits have risen each year to more than \$10 each.

Permits for public hearings were set regarding a site by exception permit in a 4.5 acre lot at the bottom of State and Highway 15 and 160 feet from the corner land near P.O. 31, have been on file, pending to an H-4 district.

The council also voted to move forward on a request from the owners of D & H Inn and to expand to purchase 14-15 feet of right-of-way owned by the state.






Matt Meyer sprints the last 50 meters before handing the baton off to a teammate in the 4x400 meter relay.


Brad Maryott sprints past the 20-foot barrier in the long jump but the junior just missed qualifying for the finals.











Astrology influences millions

Q: I know many people who make their decisions on the basis of astrology. Even their business dealings are influenced by their horoscopes. Will you comment on the practice of astrology and whether there are any scientific facts to support it?

A: I have been amazed by television personalities, politicians and millions of American young people who refer to astrology.

How ridiculous it is to think that Adolf Hitler, Queen Elizabeth, Harry Truman, William Shakespeare, Bing Crosby, White Mage, the Chi-Minh, Gilda Radner and I should have everything in common because all of us were born under the sign of Taurus! How stupid to suppose that the success of one business venture, our health and even our sex lives are predetermined by the position of the stars and planets on the day of our birth!

Yet there are some 10,000 astrologers currently working in the United States, offering advice on everything from business deals to the compatibility of a man and his dog.

There is not a scrap of scientific evidence to support the validity of such a logical outcome. In fact, it was an astute astrologer who advised Hitler to attack Russia, his biggest mistake. Nevertheless, millions of individuals consult their horoscopes in daily trials and tribulations.

I was recently introduced to a famous Hollywood astro who was not waiting to appear on a television talk program. "My wife was with me to observe the interview, and the astro commented on her attractiveness. He said, 'I bet you're a Sagittarius because most pretty girls are born under that sign.' I was so appalled by the offensiveness of his statement that I felt obliged to challenge what he said.

Trying not to insult his intelligence, I asked him if he had made any effort to prove his hypothesis. I pointed out how simple it would be, for example, to check the birthdate of every girl entered in next year's Miss America or Miss Universe contest. I soon learned that the best way to end a conversation with an astrologer is to begin talking about scientific evidence.

In 1960, the world's astrologers announced that the world combination of planetary influences in 25,000 years would occur that year. Seven of the planetals were going crazy in those eight and American doomsayers were predicting everything from the disintegration of California to the catastrophic end of the world!

But the fateful day came and went, of course, with no more disasters than on any other day. When astrological advice is broadcast on television stations, the astrologers often repeat a disclaimer, saying they are not attempting

to foster a serious belief in astrology and are providing the horoscopes for fun and entertainment.

How about it then? Is astrology just an amusing pastime for our enjoyment? What about those millions of Americans who depend on the stars to provide direction and meaning each day? Isn't it better that they believe in this myth than to believe in nothing at all? Should we foster a tolerant attitude toward astrology or should it be seen as an ridiculous philosophy to be exposed wherever possible?

A widely quoted psychiatrist recently professed that he urges his patients to depend on the astrologer, even though he admits that their predictions are scientifically worthless. I couldn't agree more. Astrology is not only mythical nonsense, but it is dangerous to those who accept its tenets.

One serious concern is that it offers a substitute for rational judgement and wisdom. A young man or woman, for example, may choose a marital partner on the basis of compatibility of their charts, without proper regard for the life-long implications of their decision. Others postpone or disregard medical advice because of the "do nothing" advice printed on their horoscopes.

It is impossible to estimate how many important decisions are based on the stars each day, undoubtedly having a profound impact on family, business and even governmental affairs. How truly it is to determine one's destiny by the flip of a little card!

The naive believer exchanges his understanding of facts, his commonsense, his experience and his better judgement for a "know all, tell all" pulp magazine of forecasts. He stands on a more confidently leaning against the wind while standing on top of a 10-story building. His body is seemingly held in check as he teeters precariously over the edge of the structure. But sooner or later, the gusts will slacken and the man will suddenly plunge down toward the ground.

Likewise, the astrology convert is leaning against an apparatus which can not possibly hold him securely in place. Sooner or later, when troubling and painful circumstances force him (or will come to everyone), he will reach frantically for something stable and firm to grasp. But he will find little support from the myth and superstition on which he has been leaning.

The bedroom should contain places for boys and personal effects (such as drawers, shelving and toy chests), a comfortable bed, desk and bookcase for studying and hobbies, a closet for clothing and a general storage area. A minimum of three changes of clothes should be present in each room. If a bedroom must be shared, each child's furniture can be separated with a divider separating individual spaces.




Take time for important things
