Townhall meeting was held

A number of community members and business owners were on hand Monday evening to listen to results of a recently conducted Main Street Wayne survey.

Dr. Chuck Parker from Wayne State College, the chairperson of The Main Street Economic Restructuring Committee gave a presentation at The Renaissance Coffee House on the information gathered from the Consumer Survey.

Information was presented in several areas such as age and income levels of respondents; reasons for not shopping in Wayne; preferences

as to the day of the week and the time of day shopping occurs and the importance of advertising in shopping selections.

There were a total of 424 surveys returned. This includes both the surveys found in the Morning Shopper and those distributed to Wayne State College students.

Of those indicating a preference on shopping days, Saturday was the most frequently listed. The preferred shopping time was from 1 to 6 p.m. Seventy percent of those responding indicated that they do less than 30 percent of their shopping in downtown Wayne. Fifty percent of

reason and 63 percent indicated the variety of goods was the reason for not shopping in Wayne.

More than 60 percent of respondents considered newspaper advertisements important or very impor-

tant in attracting customers to a place of business. Radio ads were important or very important to 32 percent of the respondents. felevision ads received the same ratng. Sales were important or very mportant to 84 percent of the respondents.

The attractiveness of downtown Wayne was rated excellent or above

The foundation is named for the Rev. Joseph Harrison Jackson, former pastor of Bethel Baptist Church in Omaha. Jackson served as pastor of Berthel, then located at 29th and T streets, from 1927 to 1934.

Jackson later headed a large congregation in Chicago and served for 29 years as president of the National Baptist Convention, the nation's largest black denomination. He also was an ecumenical spokesman, a friend of presidents and kings and a conservative counterpoint to the activism of the Rev. Martin Luther King and other socially active ministers during the civil rights struggle. Jackson died in 1990 but his legacy lives on in Omaha and at Bethel; now located at 5318 S. 30th St. The Jackson foundation also has funded ssholarships to Creighton University, in addition to its gifts to the

Nebraska Humanities Council. Kenny Jackson Williams, Jackson's daughter, is secretary of the foundation and professor of American literature at Duke University. She was appointed by President Ronald Regain to the board of the National endowment for the Humanities (NEH).

In a 1997 interview with the Omaha World-Herald, she emphasized the foundation's mission to keep her father's sprit alive. "Dad's early years in Omaha were extremely important to him" she said. "I thought there needed to be something to perpetuate his memory in the place where he essentially began his career."


ambitions. Then there is Mr. Grasz.

Out West, being able to say you worked for The Sweetheart of the Big 3rd is probably better than being able to say that you worked for Tom Osborne.





It is very hard at times for a small town to get their community interested in a project, when they over time have lost most of their businesses, their schools, etc. But our town of Dixon has been an exception.



The Missouri is more than a river

When anglers think about the Missouri River, many people think that it's just like any other river and will fish it the same.

Not true! Anglers that fish the Missouri will run into numerous fishing situations and will need to adapt to each in order to take fish!

The Missouri, which is 2,550 miles long is a diverse fishery and anglers who want to be consistent need to look at the Missouri as more than a river.

The Missouri that flows through the upper Midwest has both fast flowing rivers with a lot of current than the slower meandering river that is found farther downstream.

Anglers who fish the faster current areas need to learn how to read the current and find the current breaks. They'll need to identify sand bars, undercut banks and other types of structure that will be holding fish.

Anglers working the slower moving water need to look for shore line structure and back water areas as baitfish will hold up in these pockets and so will the game fish.

Another thing that makes the Missouri a unique river is the difference in water clarity.

The river above the mouth of the Niobrara is fairly clean while the river below is generally silt laden and dirty.

In our area, we need to know how to fish both clear and dirty water. In the Midwest, the wind always blows so you either learn to fish dirty water or miss out on over half of the fishing days.

When fishing the clean water like the Missouri River above Niobrara, you'll need to use smaller equipment, longer snells and will be able to fish more rapidly because the fish can see farther, have more time to look over your offering and will be on the Missouri River know how to able to zero in on your bait more quickly.

The dirtier water angler will need to use bright baits, lures that give



off more vibration or a lot of flash; which will allow the fish to locate your bait in these dirty water conditions.

In some of the areas that I've fished, I've found that anglers fish clearer water or when forced to will fish slightly stained water. When the water gets muddy, they don't fish.

To be consistent, anglers will also have to know how to fish different lake situations. Some are shallow such as Lewis and Clark while other like Oahe are deep.

Anglers that do well on Lewis and Clark do a lot of shallow water trolling, while angers on Oahe fish deeper, using more bottom bouncers with spinners and drifting.

Anglers that are good fishermen

fish all types of lures from jigs to crankbaits and everything inbetween

In other areas, good anglers only have to deal with one fishing situation either a river or a lake. Many times they will use one or two baits all year long.

Anglers who fish the Missouri River in the Upper Midwest can adapt to all conditions. It doesn't matter if it's river or lake, fast or slow current or clean or dirty water.

Another thing that sets Missouri River anglers apart from anglers in other areas is that they will figure out what it takes to get to the fish. A good example of this is the bottom bouncer. Developed by Missouri River anglers for fishing heavy current, windy conditions and deep water, Missouri River fishermen figured out a way to spend more time on the water and to catch fish that had been impossible to get to.

Missouri River Anglers have to adapt if they want to catch fish and these are some of the reasons that Missouri River anglers do so well on the tournament circuit!

Fish hard, fish often, and take a kid fishing!




Mark Finn Finn attends **Boy's State**

Landowners in most of Nebraska have a new option for restoring and preserving small wetlands, plus they can receive a rental payment according to a USDA official here.

Brian Wolford, Farm Service Agency State Executive Director, said, "Starting June 4; landowners can now enroll wetlands that are up to five acres in size, plus an adjoining grass buffer strip into the continuous Conservation Reserve Program

protect larger size wetlands."

Rex Amack, Director of the Nebraska Game and Parks Commission here said, "THese smaller wetlands will be great for wildlife, habitat, It, will benefit not only waterfowl, but also other wildlife in the area. We will be helping promote this program by putting some additional people in USDA Service Center to contact landowners and explain the program first hand."

Last winter Congress passed legislation to have a two-year test of this new program option in Nebraska, South and North Dakota, Montana, Minnesota and Iowa. UP to 500,000 acres in the six states can be enrolled into this program. Nebraska can enroll up to 75,000. acres

Landowners in Kimball, Banner and Pawnee Counties, where more than 25 percent of the cropland acres are already enrolled in CRP, will not be eligible for this new option.

Wolford said this will be an on going sign-up at local USDA Service Centers through Dec. 31, 2002. This new wetland option will be similar to the present continuous CRP enrollment for buffer strips.

Landowners can enroll the wetland into a 10 to 15-year contract based on the county soil rental payment, plus receive an enrollment incentive payment and maintenance payment. Cost share dollars are available form USDA to establish all practices.

Incidental grazing of these lands can be allowed after harvest, but there will be a payment reduction. Steve Chick, State Conservationist for the USDA Natural Resources Conservation Service here said, "This is an excellent opportunity for landowners to restore wetlands that provide a great value. Wetlands can improve water quality of both surface and groundwater. Being able to protect these smaller wetlands compliments the Wetland Reserve Program which has been helping



Motion carried. Motion to approve the minutes from the May 15, 2001 special meeting. Motion carried. Personnel:

Non-Certified Staff: Motion to approve a custodial contract for David Headley. Due to other custodians working less than full time, Mr. Headley will help to get ready for the District 51 and 17 sale at the end of June, as well help with the new transition when the middle school building is completed. Motion car-

Financial Claims and Reports:

District 17: Motion to approve District 17 financial claims and reports as presented, with the exception #3000, Motion carried. Motion to approve #3000. Motion carried.

District 51: With the dissolution of District 51, the Board of Education no longer exists and cannot take any action. Therefore, we must approve their financial claims for payment since their last date of existence. After the final bills have been paid, an audit will be conducted with the Wayne School District and Winside School District. At that point, each district will be entitled to their money based upon percentages of land. Dr. Reinert stated it will probably be early fall before the audit will be conducted. American Heart Association: A letter was included in board packets from the American Heart Association, thanking Carol Novak and 18 students for raising \$738.00 in conjunction with the Hoops for Heart program.

6th Grade International Festival: A letter was included in board packets from Mrs. Jill Pickinpaugh, coordinator of 6th Grada International Festival. This year, \$775.81 was raised and the class has designated that \$400.00 be put towards a sign at the new middie school and the remaining \$375.81 help pay for their trip to the zoo in 8th grade. Bids and Contracts:

District 51 Building: Dr. Reinert explained what would have to be done to the building if the district decided to tear it down or sell it to a third party. There is asbestos in the building that would need to be removed. It would cost the district an estimated \$8,000 to \$10,000 to take down the building and return the land to its original condition as stated in the land deed that was originally written. Dr. Reinert recommended that District 17 purchase the option and use it for possible storage or sell it at a later date, after the new middle school is opened. Motion that District 17 purchase the option, from Marvin Dunklau, for the land

would be a financial commitment over a number of years. With WSC, there would be the issue of NCAA stipulations (practice times, etc.) Also, the school district could incur transportation of students to WSC for physical education classes. Our students are unable to meet the physical education standards because of the condition of the track. Board members requested that a timeline be drawn up as to the steps that need to be taken to decide if the school district builds their own facility or partners with Wayne State College. Todd Barry, Athletic Director at. WSC, has asked Mr. Ruhl and Dr. Reinert to be on a committee to help fundraise for the college's proposed new facility. It was also suggested that a color picture be drawn to put on paper what the new facility could possibly look like, as the district starts to solicit for money from alumni. If the school was to build our own facility and not venture with WSC, cost estimates range from \$363,300 - \$489,300, depending on the type of surface system. Mr. Ruhl will contact the companies he has already contacted and see if they would be willing to give the district a vision of what the facility could possibly look like. Also discussed was the issue of core samples needing to be done. Mr. Dave Hix and Mr. Lowell Johnson will work to survey the site. Mr. Ruhl will do further research and bring it back to the board by mid-July after he talks with different companies. By that time, Dr. Reinert should hear if the grant we submitted will be awarded or not.

Superintendent Report:

Building Renovation/Construction Update: The middle school building is continuing to see progress on a daily basis. Compaction of the dirt in the gymnasium did not meet the requirements to support the concrete floor. However, the gymnasium area had to be recompacted and then will be ready for the floor to be poured. Concrete has been poured in the hallway leading to the locker rooms and public restrooms and the commons area. Cabling crews should be here this week to begin on second and third floors.
