## Windfarm update, concerns voiced by county resident at recent meeting

A visit by a Lincoln Clean Energy representative to the Wayne County Board of Commissioners this week brought a much-needed update on the company's proposed project in Wayne County, albeit a brief one.

Pat Dalseth gave a brief project update for the proposed Plum Creek Windfarm outside of Winside that runs several miles from Winside to the Pierce County line.

"I'm here today to give the five minute version of where we're at," Dalseth said.

Dalseth last visited with the commissioners late last fall when the company had just begun to approach landowners.

At that time, Dalseth discussed the timeline of the project, saying that the goal was to have all land control finished by May 1, however at this visit, Dalseth

said the company had failed to meet that goal, but they were optimistic about the speed as things had really picked up in 2017.

Dalseth informed the commissioners that this project hadn't made the short list for providing wind energy to Omaha Public Power District, so the company was pursuing other buyers.

Dalseth told the board the company has roughly 18,000 acres signed up for the project, but the hope is that between 20-25,000 would sign up.

"I owed it to the board to tell you where we're at in the project, but until land acquisition is complete, not much else can be done."

Also on the agenda for the commissioners was hearing the concerns of one Wayne County resident regarding the windfarms.

Randy Wagner, a retired Wayne County farmer, brought several articles and presented research to the board to show the damaging effects the windfarms can

have on property values as well as how they may affect the health of some residents.

Wagner cited several studies and presented articles from sources such as Forbes to the board in an effort to get his point across.

The resident discussed the dropping of property values due to the towers and even discussed how some Stanton County residents are filing a class-action lawsuit against wind energy companies attempting to build windfarms in Stanton County.

Wagner also brought up that any landowner who agrees to the towers could be liable for area property depreciation, but County Assessor Dawn Duffy and County Attorney Mike Pieper clarified to the board that there would have to be evidence that the property depreciated due to the towers and it wasn't due to other factors.

Another aspect of the towers that Wagner discussed was for those who may have a tower east or west of

their property.

Wagner's daughter suffers from a seizure disorder and according to him, even a ceiling fan can set it off. It's his belief that when the sun rises, those directly west of towers may suffer from the blades causing a strobe-like effect with the sunlight. Same for those directly east of a tower at sunset.

The commissioners took note of Wagner's concerns but said that without county-wide zoning, their hands are tied in several ways though they were doing all they could.

Other agenda items included taking bids on materials supplied for two projects. Three bids were opened and then sent to the project's engineer to be inspected.

Joel Hansen visited the board with an updated plat map for the proposed Tuffern Blue Estates outside of Muhs Acres. Language had previously been vague regarding a county road and had recently been fixed.

Commissioners will meet again June 6 at 9:30 a.m.

## Fifth grade students recognize law enforcement during council meeting

A group of fifth grade students were on hand at Tuesday's meeting of the Wayne City Council to express their appreciation for the Wayne Police Department.

The students thanked the officers of the Wayne Police Department for the work they do to keep the children safe on their way to and from school. They ended the presentation by giving the officers hand-made posters thanking them for the work they do.

The majority of the remainder of the meeting involved public hearings and the ordinances and resolutions connected to the hearings.

Kelby Herman, representing Mesner Development, presented information to the council on a proposal to develop an area on South Sherman Street and Grainland Road.

Herman asked the council for their input on whether or not the council would be willing to move forward on declaring the area blighted and substandard and the use of TIF funding to assist in the costs associated with putting in streets, water and sewer in the area and cleanup necessary.

The 20-unit project proposed for the area would be geared primarily toward seniors with income qualifications necessary for those renting the town homes. Total cost for the project is estimated at \$3.8 million. Homes would be built beginning late this summer and it is anticipated that the first would be ready for occupancy within a year.

Herman told the council that when completed, the project would be managed by Wayne Community Housing Development Corporation.

Following Herman's presentation, the council voted to move forward with the plan.

A second public hearing involved the re-zoning of an area on South Main Street from B-1, Highway Business, to R-3 Residential.

Joel Hansen, City Planner told the council that the owners of the properties involved had no objections and that the Planning Commission had approved the request.

This ordinance was also approved and the three readings waived.

Two public hearings involved property owned by Jason Schulz.

The first will allow for re-zoning of two lots owned by Schulz from I-1, Light Industrial and manufacturing to B-2, Central Business District. This change will clarify zoning lines on the property.

The second will allow a Use-By-Exception for Schulz to construct a storage facility on the property.

Both were unanimously approved.

Several other ordinances were passed on second readings, including those dealing with the Crown II Project Street Improvement District, the Crown II Sewer Extension District and the installation of stop signs on Grainland Road, west of Wayne.

Council members listened to information provided by BJ Woehler on possible uses of the old swimming pool.

"I hope you can find a use for the pool before you demolish it. It is going to cost a lot of money to demolish it and I think you should try to find out what other options there are for the area," Woehler said.

Council members said a considerable amount of time had been spent at their annual retreat earlier this year discussing options and no consensus had been reached.

Council members agreed to bring the topic before the public for additional input before making a decision on the future of the area.

The Wayne City Council will next meet in regular session on Tuesday, June 6 at 5:30 p.m. in council chambers.

## Wayne Community Schools Foundation receives a \$2,000 grant for drone technology and utilization

Wayne Community Schools Foundation received a \$2,000 grant for drone technology and utilization. The grant is provided through Farm Credit Services of America's (FCSAmerica) Working Here Fund.

Wayne Community Schools Foundation will purchase a drone and complete training classes with grant funds. Instruction including the rules, regulations, and proper etiquette when using technology devices such as drones will be part of the training. The photos taken by the drone will be utilized in the classroom for students to compare different ecological areas of northeast Nebraska. Students will learn about technology innovation and management.

"Students graduating high school and entering the work force or college now are required to have more experience and knowledge of technology than ever before," said Lindsay McLaughlin, executive director of the Wayne Community Schools Foundation. "By having a drone in the classroom, students can gain more experience with technology and learn how it works, how it is best used, and expand the possibilities of using this technology with experiments that they may create."

"At FCSAmerica, many of us grew up in agriculture and continue to farm. We know first-hand the value of agriculture education and are proud to partner with Wayne Community Schools Foundation to ensure future generations have the same

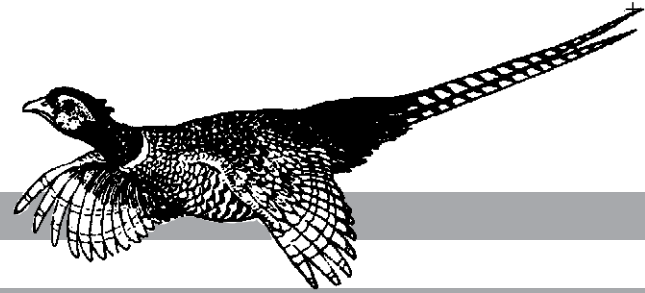

Two developers have approached the city council requesting tax increment financing to help reduce the cost of developing property for a potential total of 35 single family homes and duplexes over the next two years.

This fits well with the local industries expressed needs and with our new housing needs study. The story we tend to forget is that quite a few homes have been demolished here in the last few years so the net gain in housing is probably about 20-25 homes.

# Team travels cross country for competition

While it is not unusual for high school teams to travel several hours to attend a competition, one of the competitors in the recent electric car (power drive) rally in West Point would definitely have won the prize for traveling the farthest.

A team of six students flew from Kodiak, Alaska to Omaha, Neb. and then made their way to Wayne before taking part in the race.

Mike Finley, who serves as the advisor for the group, is a Wayne State College graduate and has previously taught at Coleridge, where he had experience working with students in power drive competition.

"I moved to Kodiak in 2013, where I teach drafting and design classes. The school has approximately 700 students in the high school. When I asked my students if they wanted to compete in an electric car rally, they responded very positively," Finley said.

He noted that the students did fund raise for their trip to Nebraska, but the school was very supportive of the project and paid for the majority of the trip.

"The school believes in lots of project work and worked with us to get to

come to Nebraska," Finley said.

The six students - three boys and three girls - included one freshman, four sophomores and one junior.

The group arrived in Nebraska and came to Wayne to spend time at Wayne State College, where they met with Greg VanderWeil, who was one of Finley's teachers and who is a strong supporter of the power drive.

"It has been great to come to Wayne

and see Greg and the college. For the students this is their first time to Nebraska," Finley said.

The students said the weather in Nebraska was warm (70 degrees on the day of the interview) and the people were very friendly.

They also said that Kodiak is located on an island that gets lots of rain. The main industry is fishing.

The students have spent a year

building a car for the race. They then had to dismantle it to have it shipped to Nebraska. Due to a shipping problem, the car was sent to a different location and the team was not able to race in Lincoln as had originally been planned.

While in Wayne, the Alaska students and their advisor were able to meet with the Wayne High School Power Drive team and their advisor, Tony Cantrell. Cantrell and Finley knew each other from their respective time at Wayne State College.

Among the highlights of the trip to Nebraska, the students mentioned, Runza, Godfathers' Pizza and Chick-Fillet. They were also treated to a barbecue at the home of Greg VanderWeil.

"We chose to come to Nebraska for several reasons. First of all, I was familiar with power drive. Also, in Nebraska, races offer more than just endurance. The cars are judged on maneuverability, documentation, design and construction and braking. This wholistic approach matches more closely with what I am working to teach my students," Finley said.

The students summed up their impression of Nebraska by stating, "the wind is warm and the people are friendly."

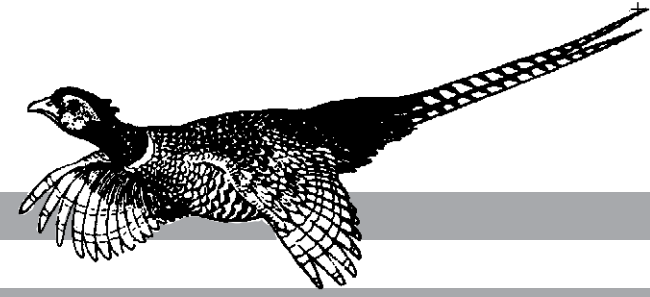

## Wildcats suffer extra-inning losses to end 2017 season

The season came to a disappointing end for the Wayne State baseball team Thursday after suffering a pair of heartbreaking extra-inning losses in the Northern Sun Conference baseball tournament at St. Cloud, Minn.

In the first game, a controversial call at first base that resulted in the ejection of coach Alex Koch turned out to be the game-winning run for Minnesota State in the bottom of the 11th as the Mavericks outlasted the Wildcats 3-2.

Wayne State pitcher Aiden Breedlove and Minnesota State's Brody Rodning engaged in a solid pitchers' duel early in the game. Neither team managed a hit until the fifth inning, and Breedlove allowed just two walks in the first four innings.

Minnesota State broke the ice in the bottom of the fifth with a solo homer by Hunter Walsh. Wayne State got its first hit in the sixth on a Peyton Barnes single and had two runners on in the inning before coming up empty. They had two runners on in the eighth, but again failed to score, and the Mavericks got a run off Keenan Breen in the bottom of the inning to lead 2-0.

The Wildcats rallied to tie the game in the top of the ninth. David Janes doubled and was replaced by pinch-runner Mitch Gullikson. He and Tanner Simons, who walked, scored on a Bodie Cooper double to left center to tie the game, and the Wildcats got out of a two-on, two-out jam in the bottom of the inning to send it to extra frames.

Wayne State had the go-ahead run on third in the 10th after Barnes doubled and moved to third, but a controversial call in the 11th inning resulted in the ejection of Koch. Minnesota State got two on and Wayne State intentionally walked the next batter to load the bases. Bobby St. Pierre worked a full count to Hunter Harnisch, who was hit by a 3-2 pitch to score the winning run and end the game.

Cooper had a two-run double while Barnes went 2-for-4 with a double and single to lead a five-hit attack. Janes doubled and Tandon Dorn singled.

Breedlove pitched seven standout innings in a start for the Wildcats, giving up just one run on three hits with eight strikeouts and three walks. Breen worked the eighth inning and was charged with one run on two hits. St. Pierre suffered the loss, working the final 2 1/3 innings. He gave up five hits and one run while walking one batter.

The Wildcats again went to extra innings in a losers bracket game that evening, and Minnesota Duluth used three runs in the 10th to end the Wildcats' season with a 5-2 defeat.

The Bulldogs scored first in the top of the third on a double and sacrifice fly for a 1-0 lead, but Wayne State came back in the bottom of the seventh to tie the game. Aaron Krier's sacrifice fly scored Dorn to make it 1-1. Wayne State could have done more damage, but left the bases loaded in the inning.

Duluth got a run in the eighth to take the lead again, but Wayne State came back in the bottom of the eighth as Cooper doubled home Simons to make it 2-2. Again, Wayne State let a chance for further damage go by as they left the bases loaded.

Minnesota Duluth put the game out of reach in the 10th, using a three-run homer to take the lead and go on to the win, knocking Wayne State out of the tournament and ending their season.

Krier led a 12-hit effort with a 2-for-4 performance, including a pair of doubles and one RBI. Simons, Jackson Petersen and Cooper each went 2-for-5 with a double, with Cooper getting one RBI. Barnes, Cody Jenkins and Kyle Thompson each added singles.

Teague McFadden fired 7 1/3 innings and allowed just three hits and two runs with six strikeouts and three walks. Breen faced one batter in the eighth inning and was charged with one hit. Kyle Kennebeck was tagged with the pitching loss, allowing three runs on three hits over 2 2/3 innings of work with six strikeouts and no walks.

Wayne State ends the season with a 29-24 record.

## LCC fifth, Wakefield eighth

The LCC boys golf team finished in the middle of the 10-team pack while Wakefield placed eighth in the Lewis & Clark Conference golf tournament held last week in Laurel.

The Bears had a pair of medalists, as Trey Erwin and Karsen Klooz finished 12th and 13th, respectively, with rounds of 87 and 88. They led the Bears to a team score of 363, good for fifth place overall.

Also scoring for LCC was Izac Reifenrath with a 92, Ty Erwin with a 96 and Noah Schutte with a 97.

Wakefield was led by Matt Christensen, who finished with a round of 91 to help the Trojans to a team score of 408. Parker Lehm-

kuhl added a 102, Noah Lamprecht shot 104, Ben Klein had a 111 and Payton Rusk finished with a 129.

A perfect day for a track meet netted some great results for the Wayne High track and field teams as they hosted the B-4 district Thursday at Kern Stadium.

The Blue Devils did very well in the field events, with eight of their 11 qualifying efforts coming in field events.

Wayne was especially dominant in the jumping arena with wins in three of the six events, as Kylie Hammer and Grayson McBride both came away with district titles.

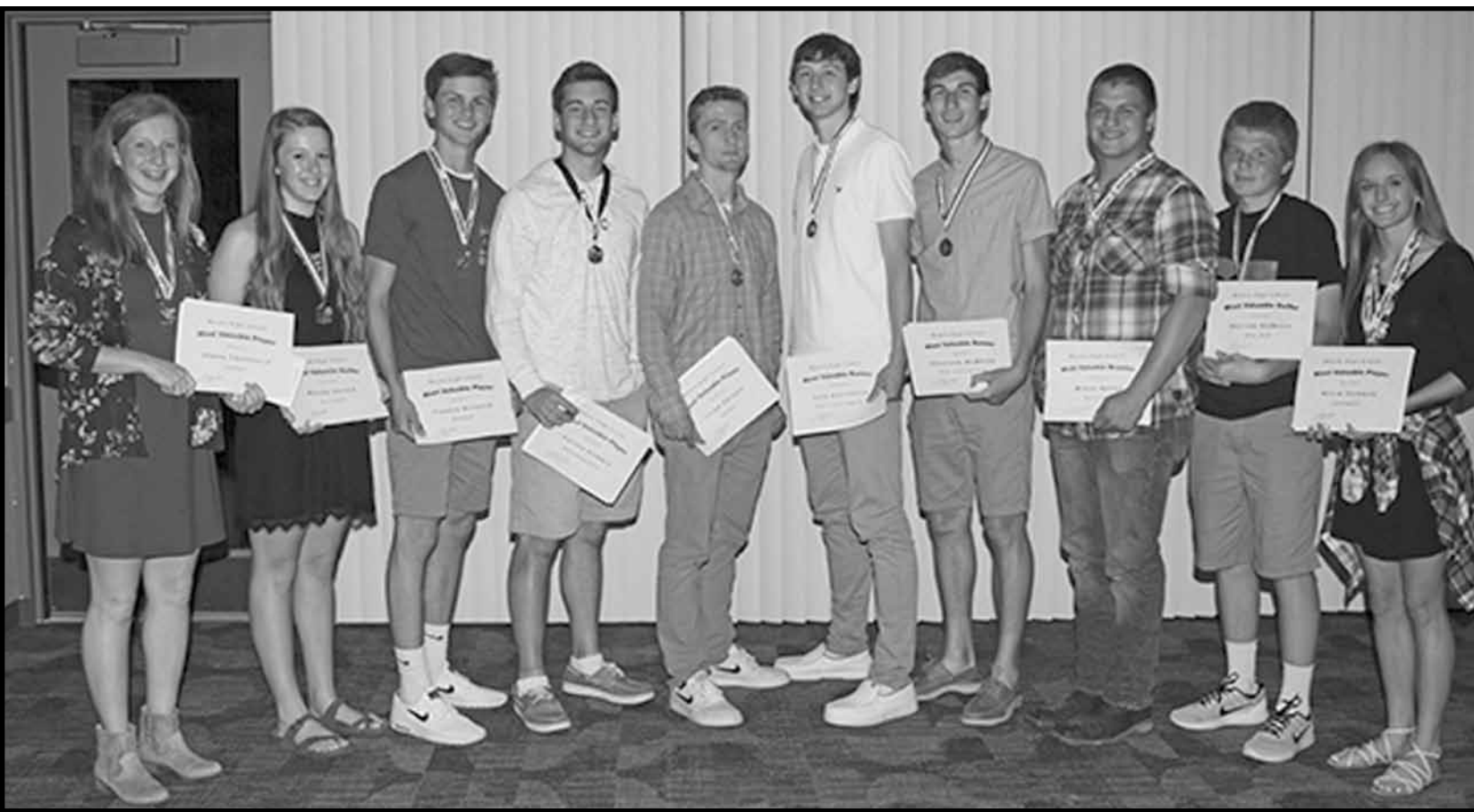

## WSC athletes earn honors

Wayne State track standouts Michaela Dendinger and Brady Metz were recognized by the U.S. Track & Field and Cross Country Coaches Association with All-Central Region honors.

Dendinger received three All-Region honors, recognized in the shot put, discus and hammer throw. She had the top mark in the Central Region in the shot put and hammer throw, along with the second-best mark in the discus. To qualify for All-Region honors, an athlete has to place in the top five of his or her respective event.

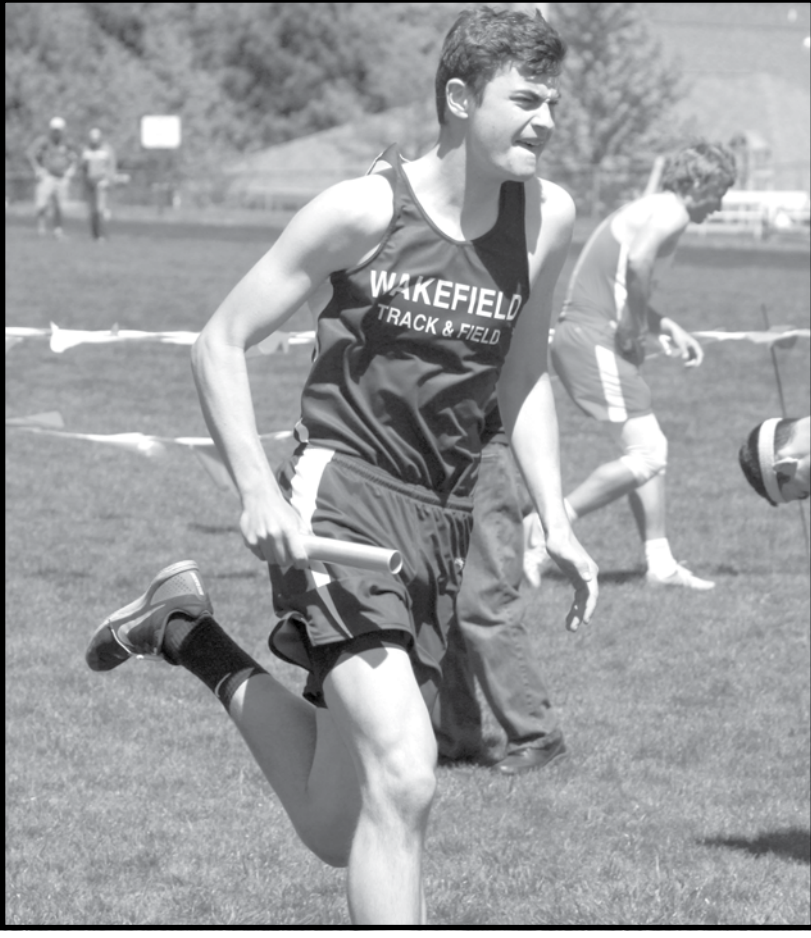

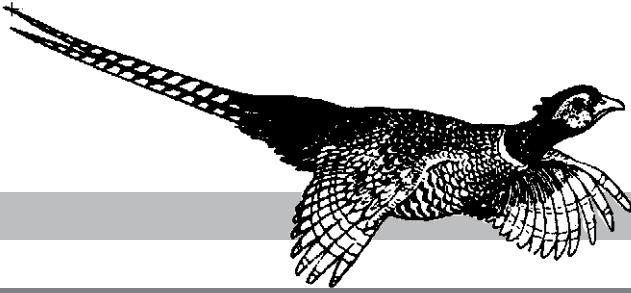

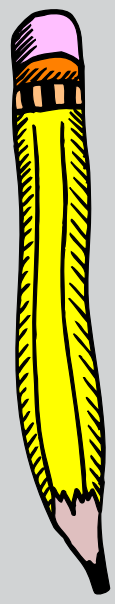

## Capitol View

# It's almost over but it's far from over

The 105th Legislature is groaning toward a June 2nd finish, but the situations created in the final days will probably have an impact on the 2018 session and definitely on the 2018 election. The tax plan favored by Governor Pete Ricketts is dead for now. For the first time in a long time, passage of the two-year-budget has been an uphill battle.

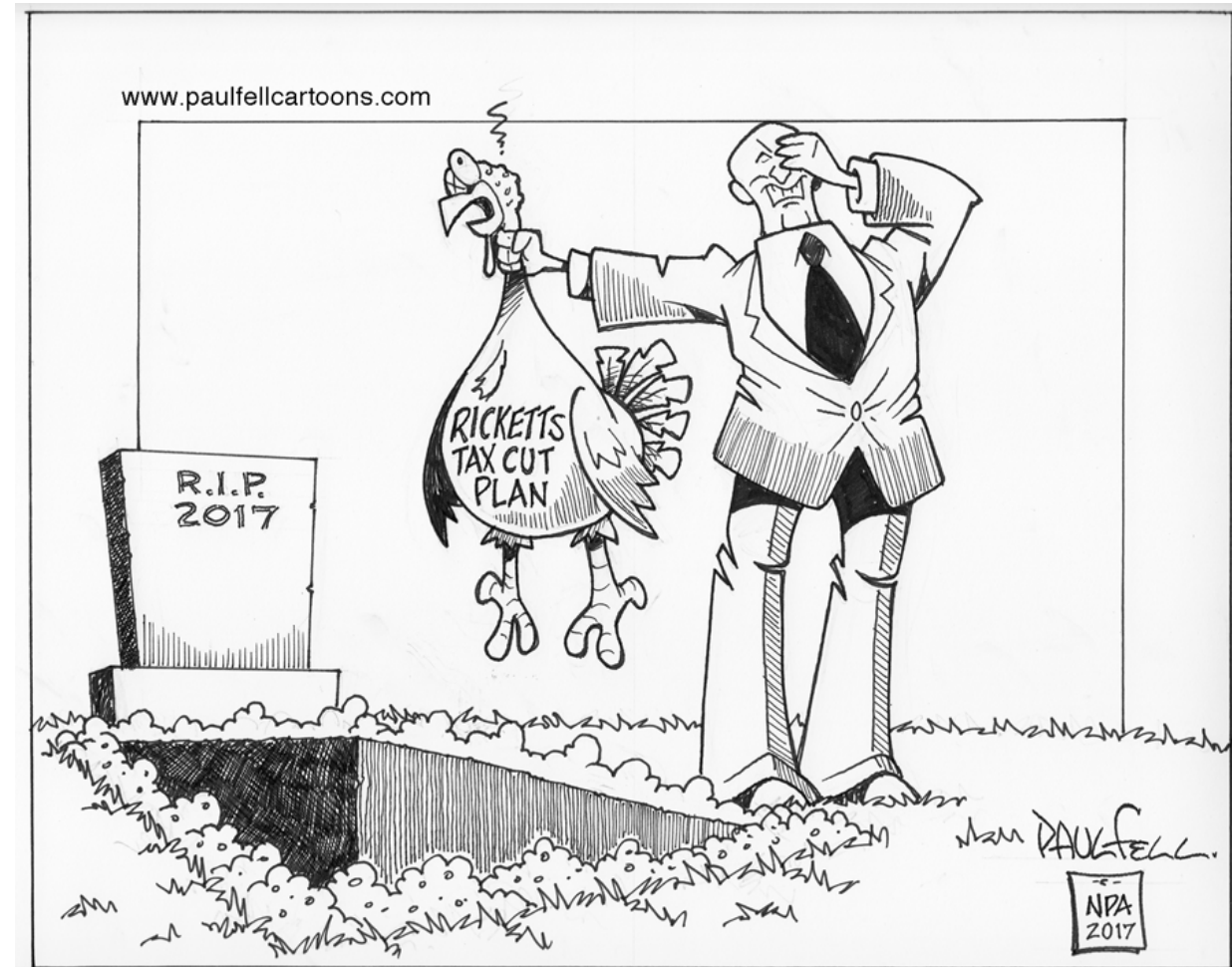
The tax plan doomed itself with the inclusion of income tax cuts in a bill that was supposed to provide property tax relief. For three years, Ricketts has been beating the drum for property tax relief. He has said that all across Nebraska he has heard from people who want property tax relief. In fact, his constant use of that line almost became annoying.

All of a sudden, with state Senators Lydia Brasch of Bancroft and Jim Smith of Papillion carrying the water on his omnibus bill, the focus became income tax cuts.

Brasch, elected by the Gang of 27 to lead the Agriculture Committee proposed a change in farmland valuation that became part of the measure (LB461). Smith, also promoted by the Gang to lead the Revenue Committee, brought income tax cuts triggered by revenue growth to the table.

Ricketts started talking about income tax cuts growing the economy. That's what they said in Kansas — it didn't work. They tried the triggers in Oklahoma — they didn't work. Rural interests and their senators looked at the numbers and asked for more property tax relief. But Ricketts clung to the income tax cuts, egged on by the Americans For Prosperity (Tea Party). Opponents noted that only the state's wealthiest would benefit.

The train ran off the tracks when lawmakers rejected a cloture motion on the bill that would have freed it from a filibuster. There were 22 senators who either voted against the cloture motion or did not vote. Ricketts denounced the 22 senators



and said they had voted "against taxpayers." The state Tea Party director vowed retribution during the 2018 election.

Lawmakers are well aware of Governor Deep Pockets' penchant for using his own money to support candidates running against senators who disagree with him. There will likely be more of that next year.

Senator Burke Harr of Omaha, one of 15 Democrats in the officially nonpartisan Legislature, said he led the filibuster because the proposal was tilted too heavily toward income tax cuts, while most Nebraskans want property tax relief.

He said it is irresponsible to be cutting taxes at the same time that the state is dealing with a budget shortfall. He countered Ricketts scolding by saying, "We're not saying 'no' to taxpayers, we're saying 'no' to a bad bill."

Ricketts pushed hard for the bill with telephone town halls, mailers sent by his campaign committee and statewide public

appearances. The bill included Ricketts' proposals for cutting the top individual income tax rate and changing how agricultural land is valued as well as cuts in the top corporate income tax rate and increased tax credits for most taxpayers. Some of that could have benefitted the low income.

So, where to from here? There's always next session, but the same senators and lobbyists and issues and faltering economy will be in place. While Ricketts and the Tea Party make their list of incumbents to defeat, supporters of property tax reduction may take the matter to the people. A ballot question could come either in the form of an initiative that writes a new law or a constitutional amendment that makes a more permanent change.

And then there's the legislative races. Brasch, Smith and Harr are among six senators who will be term-limited out. Another 18 will be facing election for their second and final term. Ricketts and the Americans for Prosperity

Nebraska branch will have their lists.

The Republican Party will likely be pushing for the election of more Republicans to further tip the scale, which now counts 32 Republicans, 15 Democrats, one Independent and one Libertarian.

But, as the 2016 elections proved, there is no magic in simply being a Republican. Several fell out of favor with Ricketts who pumped money into the campaigns of other Republicans to replace them.

Yes, the last time I looked, the Nebraska Legislature is still non-partisan. But one has to wonder how much longer that's going to last.

## Pet owners: take note

Dear Editor:

Dog owners often tell our carriers their dog won't bite, however, what they may not realize is their dog is trying to protect them; they see a uniformed carrier as someone who is invading their territory and their protective instincts kick in.

The truth is any dog can bite and all attacks are preventable through responsible pet ownership.

Wayne had a postal carrier bitten by a dog while delivering the mail last year and a couple close calls. We're very concerned about dog bites to our carriers, and the many close calls with dogs our carriers face on a daily basis.

Summer is almost here and with temperatures rising and children out of school, postal carriers tend to see more dogs running loose. We're asking pet owners to restrain their dogs and allow their carriers to deliver the mail safely. We take the safety of our employees very seriously. We will not wait until a carrier is bitten before taking preventative action. A dog that runs loose not only affects the delivery of the dog owner's mail, but often the delivery of their neighbors' mail as well.

Nationwide last year 6,755 postal employees were attacked by dogs — 40 in Nebraska.

Here are some critical points to remember:

• If a letter carrier delivers mail or packages to your front door, place your dog in a separate room and close that door before opening the front door. Dogs have been known to burst through screen doors or plate-glass windows to attack visitors.

• Parents should remind their children and other family members not to take mail directly from letter carriers in the presence of the family pet, as the dog may view the carrier handing mail to a family member as a threatening gesture.

Thank you for your help with this very important issue.

## Legislative Update

# Much of the heavy lifting is complete for the session

Monday, May 15th is the 82nd day of our 90 day session. With only a few more days left, I am pleased to say that much of the heavy lifting has been done for the session.

Though we may still have some contentious issues come up between now and the last day of session, the Unicameral has accomplished our main duty, which is to pass a budget package which contains the mainline budget (the "main" budget that contains most of the governmental spending) as well as bills which make funds transfers as needed.

We started debate on our state's \$8.9 billion budget package on April 25, but the actual process began much earlier with hearings held by the Appropriations Committee.

The package provides for increases in the Property Tax Credit

Fund, K-12 education, our state's Department of Corrections, among others. It reduces funds for the University of Nebraska and some state agencies.

The Unicameral gave final approval to the three components of the two-year budget late last week. Among the measures passed was LB331, which creates funds, makes fund transfers and lowers our "rainy day fund (the minimum cash reserve requirement) from 3 to 2.5 percent. LB 327, which is the state's mainline budget bill, also passed on a vote of 36-12.

During the debate I voiced my concerns that this budget was taking us down a path that is just not sustainable. I agree with many who felt that, in the face of a significant budget shortfall of nearly \$1 billion, we needed to take a harder look at the levels of spending in

some areas.

I joined with several of my colleagues to demonstrate our concern with state spending levels, and to express our misgivings at how little attention curtailing state spending was given during the budget process. I also had strong misgivings about lowering our state's minimum cash reserve requirement.

I offered an amendment to cut spending by 1 percent across the board. Though my measure did not have the votes to pass, it allowed us to have a discussion about our levels of spending and what we are going to do if our budget shortfall continues to expand.

Too often, we target one source of spending, such as the University of Nebraska system, with the idea that those smaller cuts will be enough. Or, as I stated earlier, we use budget gimmicks like borrow-

ing from the cash reserve.

While this budget was balanced and did cut some spending, there were a lot of areas untouched and the methods that were used to balance the budget will not be there in the future.

Our state simply cannot keep borrowing from other areas to make up the difference between expenses and revenues.

If we are not willing to curtail spending, then the only other option will be to increase taxes, which is something I cannot support. I feel that many members feel just as strongly.

So far, Governor Ricketts has vetoed \$11 million in spending intended for a project that will replace the Capitol's heating, ventilation, and air conditioning replacement project.

There may be more spending ve-

toes that will be announced in the coming days. We will get a report on the fiscal impact of this and any other line item vetoes and there may be a motion to override any or all of them, which requires thirty votes. It will be an interesting week.

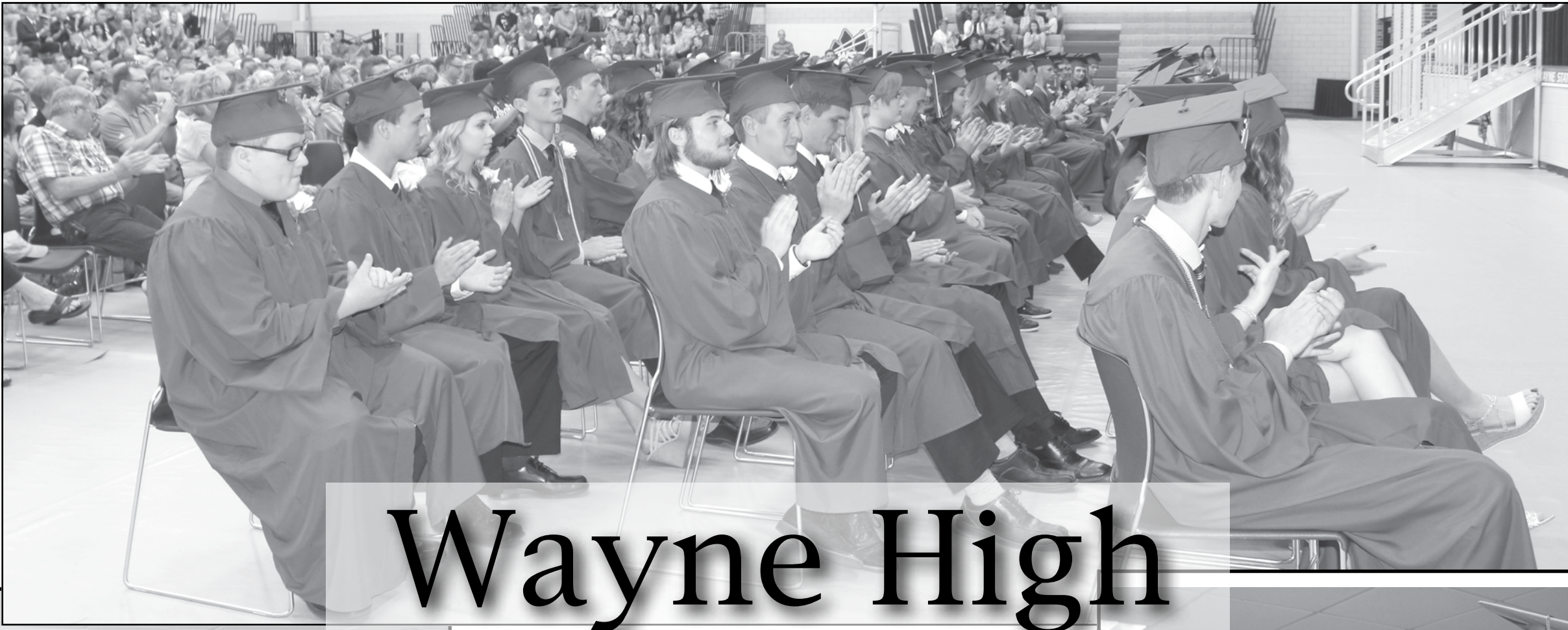

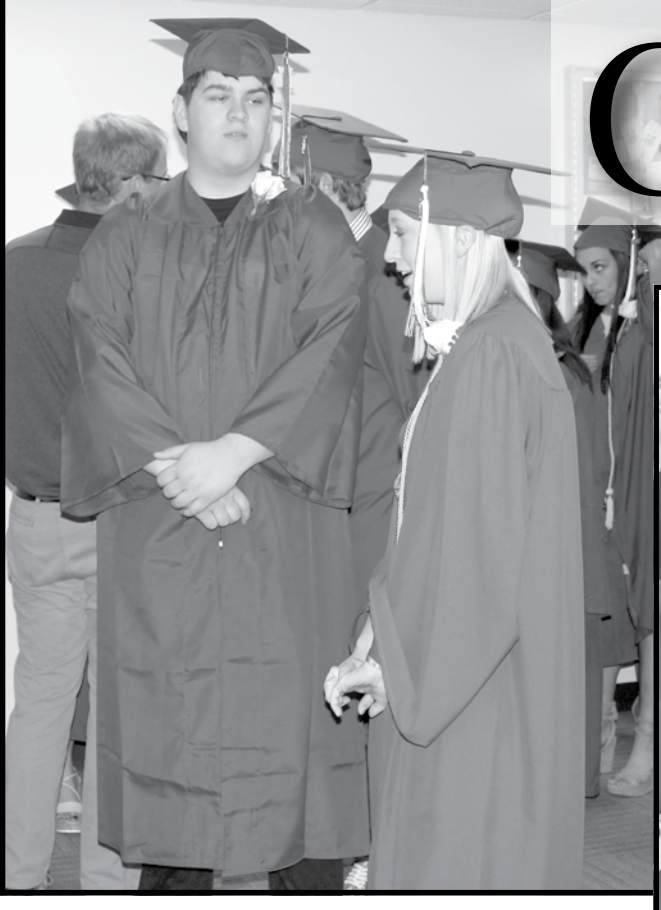

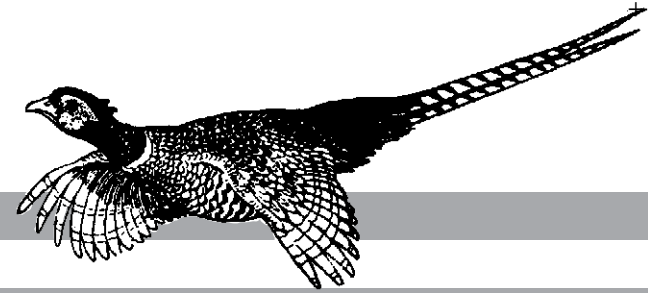

## Helping youth build friendships

Friends are vital to school-age youth's healthy development. Friendships provide youth with more than just fun playmates. Friendships help them develop emotionally and morally. In interacting with friends, youth learn many social skills, such as how to communicate, cooperate, and solve problems. They practice controlling their emotions and responding to the emotions of others. They develop the ability to think through and negotiate different situations that arise in their relationships. Having friends even affects school performance. Youth tend to have better attitudes about school and learning when

they have friends there.

People who work with school age youth in out of school time programming can check out the publication Expanded Learning Opportunities: Positive Youth to Youth Interactions at <http://extensionpublications.unl.edu/assets/pdf/ec489.pdf> to gain ideas for assisting youth in building friendships.

Friendships help youth develop emotionally and morally, and help them to learn critical life skills such as social skills, communication, cooperation, problem solving, and many more. This publication has strategies and activities for youth development professionals to use in

building positive peer relationships. It is loaded with ideas for helping youth attain and build friendships.

The publication can help in identifying and planning activities throughout the day that can help youth build relationships and strengthen friendships. Ideas include games, story time suggestions, role plays, and other activities. For example, plan cooperative group projects such as planting seeds of friendship. Have youth plant grass seed or annuals in small cans or containers. Have the youth care for them.

When new youth come to the program/club, give them a Seeds of

Friendship plant. Each friendship can have a welcome note that was made by the youth attached. To introduce the activity, tell the youth that they are working together to make "seeds of friendship" so that new youth will feel welcome and be able to make new friends. Discuss with the youth how hard it can be to be the "new" child. Be sure and watch for friendly behaviors during the activity, comment on it, and encourage it. Another activity idea that can be used during center or club time is playing board games.

There is also discussion regarding conflict resolution and how to teach youth to resolve problems

they have with other youth using the conflict resolution strategies listed. Books that can help youth deal with conflict resolution are included. Three of the books listed are: A Volcano in My Tummy; Helping Children to Handle Anger by Elaine Whitehouse & Warwick Pudney; The Grouchy Ladybug by Eric Carle; and Stand in My Shoes: Kids Learning About Empathy by Bob Sornson.
