## Blecke looking forward to challenges of new position

Wes Blecke said he has "always had the city administrator's position in mind" and as of July 1 will get to move forward in that capacity for the city of Wayne.

Blecke, a 1996 graduate of Wakefield Public Schools, earned a bachelor's degree in political science and history, with minors in Public Administration and coaching from Wayne State in 2000.

"Early in my education, I planned to become a lawyer, because I wanted to be a politician, and felt that most politicians started out as lawyers. However, I felt that just being a lawyer to move on to the next step would not be fair to my clients, so I changed direction," he said.

He went on to earn a masters degree in Public Administration with concentrations in budget and financial management from the University of Nebraska-Omaha. It was during one of his classes there that a guest speaker talked about city administration and Blecke was sold on that career.

In the fall of 2002 Blecke was offered the position of city administrator at Ashland. He began his duties in January of 2003 and served the city until Dec. 1, 2005.

The early part of Blecke's career was tied to his wife's education and employment.

"Andrea was offered a job at Wayne State College with Wildcat Sports Medicine and Wayne Area Economic Development (WAED) was looking for an assistant director. I was offered that position and

began by duties here on Nov. 14, 2005," Blecke said. "We were happy to move our family to Wayne and happy with what the city had to offer."

He worked with Dave Simonsen until March of 2009, when Simonsen left for another position. He then served as interim director until November of that year, when he was offered the executive director position, which he has held for the last seven and one-half years.

"I think the thing I learned most is how much labor drives the market. It dictates everything and everything comes back to economic development," Blecke said.

He said one of the most rewarding parts of his job was the development of Leadership Wayne classes.

"I will really miss the Leadership classes and hope they will continue," he said.

Another highlight of his time as Executive Director of WAED was bringing Williams Form Manufacturing to Wayne.

"From the building of the spec building in 2007, until it was sold in 2012 was stressful, but very rewarding. The size of the building went from 20,000 square feet to 60,000 square feet and this project has worked out very well," Blecke said.

In a coincidence, Blecke has been somewhat connected to outgoing City Administrator Lowell Johnson for many years.

"Lowell's wife, Cathy, was my fourth grade teacher in Wakefield. His children were the same ages as my sisters. Our families have known each other for many

## There's no place like home for one Wayne-native

For many who live in small-town rural America, the thought of relocation to a new place is often a glittering one full of temptation.

But for some, home is the same place or very near to where they grew up. Cassy Miller is one of those people.

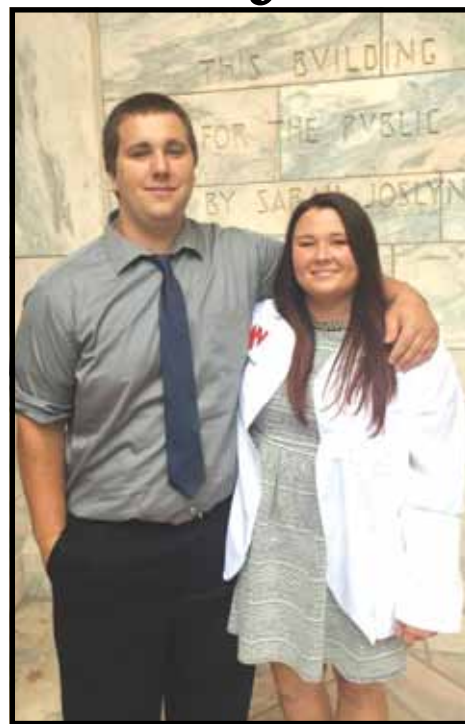
The Wayne High grad is knee deep in medical school at the University of Nebraska Medical Center (UNMC) in Omaha and while she could go anywhere, home is where she wants to be.

"I've always known I wanted to be a physician in a small town," Miller said. "I had a family member who was ill when I was young so we were in and out of the hospital to see them."

After graduating from Wayne High School in 2012, Miller attended Wayne State College through the Rural Health Opportunities Program (RHOP).

"RHOP was one of the best decisions I've ever made. It was a life changer for me. I was prepared for medical school and I can't commend them enough for that."

Once she finished at WSC in 2016, she started at UNMC for family medicine, a choice that was easy to make she said.

"I really want to do family medicine. There

is a residency program with an extra year that includes c-sections and pediatrics and I'd like to get the extra training in there, so I'm looking into that."

Her remaining time at UNMC will include two rotations which vary from 6-12 weeks depending on the area and the hospital. Miller said options include obstetrics, cardiac and family medicine among others for rotation areas. Rotation allows you to experience different areas of medicine, Miller said, with "core" areas and "elective" areas that give students the ability to select paths that interest them.

Miller has three years left of med school followed by three years of residency at a teaching hospital. Omaha and Sioux City both have residency programs and she's hoping for one that focuses on rural medicine.

But the degree is only part of being a physician. The other part is an equally important one: relationships. Which is why Miller plans to return to, not just the area, but to Wayne specifically with hopes to practice at Providence Medical Center as a family physician.

"I like being able to build the relationships with people, which is easier to do in a small town as a family physician because you do a little bit of everything. Bigger hospitals don't have that."

Miller recently wrapped up three weeks of

The Nebraska Department of Roads furnished flashing warning signs on both directions to warn motorists traveling through the area.

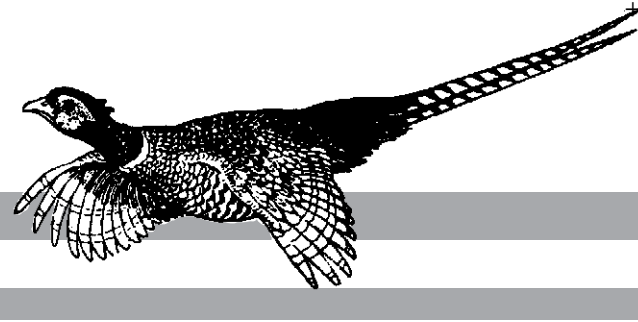

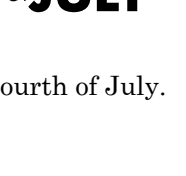
## Caution urged when using fireworks

## Shopko Foundation awards \$72,500 in scholarships

"I'm thrilled and honored to be given the opportunity to participate in the CMS-NAMM Fellows program this summer. The sessions are designed to provide insight into 21st century careers in music, which will help us in the Department of Music continue to provide contemporary and relevant programs at Wayne State College," Bohnert said. "I'm confident this experience will prove beneficial to current and future Wayne State College students as we constantly strive toward our ever-present goal of preparation for successful careers in the music industry."

The NAMM Foundation and The College Music Society announced Bohnert's selection. The Fellows Program introduces music faculty to professions in the music industry and provides them with the means to help prepare students for careers as 21st century musicians.

Bohnert is Director of Bands at Wayne State College. He teaches conducting, music education, applied trumpet and brass methods. He often serves as a clinician and a guest conductor. Bohnert performs with A Touch of Brass, the Sioux City Symphony Orchestra and Municipal Band, and as a soloist. 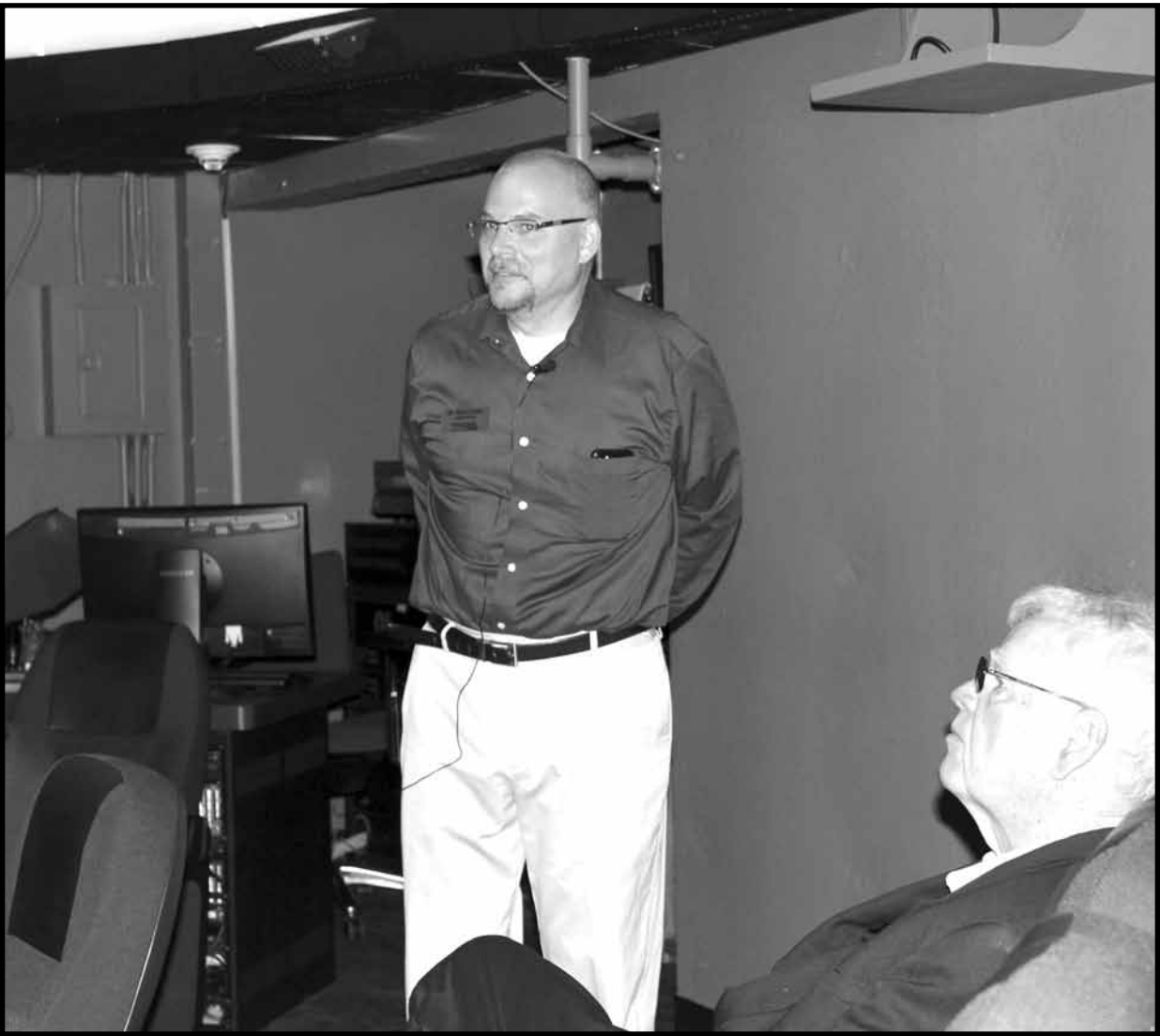

## Wayne's Green Team speaks at Glass Recycling Summit in Kansas City

The City of Wayne Green Team participated in the first annual Kansas City Glass Recycling Summit on June 15. The event was hosted by Ripple Glass, the company that takes Wayne's glass for recycling.

The summit featured educational sessions from Wayne and three other communities that have successful glass recycling programs: Branson, Mo., Kirksville, Mo. and Fayetteville, Ark.

The event also included tours of the Ripple Glass plant where glass is recycled to make glass bottles for Boulevard Brewing Co. and fiberglass insulation for Owens Corning.

More than 80 communities across seven states participate in the Ripple Glass recycling program. In eight months, Wayne recycled 17 tons of glass at the transfer station, which was picked up by Ripple Glass in March of this year at no cost to the City of Wayne.

Wayne residents can take their clean and rinsed glass bottles (including glass food and beverage containers and glassware such as wine and pint glasses, but NO windshields, ceramic, porcelain, or laminated glass) to the metal bins inside the Wayne Transfer Station located at 110 South Windom Street.

Founded in 2009, the Wayne Green Team is a group of community volunteers, Wayne State College students and staff, and city personnel focused on minimizing waste and increasing sustainable behavior. In 2015, they were selected as Green Team of the Year by WasteCap Nebraska (now the Nebraska Recycling Council), and are one of five rural communities in Nebraska that have participated in their Zero Waste Project. shadowing in Wayne, with majority of her time spent with Dr. Mark McCorkindale (SP) at the Faith Regional Health Services (FRHS). "You have to interact with all these different sides of medicine. Teamwork and communication -- you need every part of that for it to work well. The patient is the forefront."

Miller stressed how welcoming the staff at PMC and the FHRHS clinic were to her during those weeks of shadowing, stating that it really made her time there enjoyable on top of be-

ing educational.

Another perk of being back in rural Nebraska once she's done with school is the proximity to her family, as Miller said the majority of her immediate family is in the area. She also really appreciated how she was raised here and her educational opportunities in the area.

While she plans to return to the area, Miller did say her acclimating to Omaha had gone fairly well and that it helped to have her older sister Ally and her family there to spend time with as well as having several RHOP friends attending UNMC.

Miller has been an active member of the community for many years, between being involved in numerous activities in high school and college at

WSC. Not only did she play softball extensively, she has coached baseball four years while in school, but this summer will be her last "free" summer as she takes on even more for her degree.

"Next summer I have Step 1 of my board exams," Miller said. "The second step will happen around year four and the final board exam is during or shortly after my residency. We get busy with rotations and clinical exams that will occur, so I won't be able to coach for a while."

Although she's disappointed she won't be coaching for the foreseeable future, Miller is committed to coming back to her home base in Wayne and making a life as a family medicine physician.

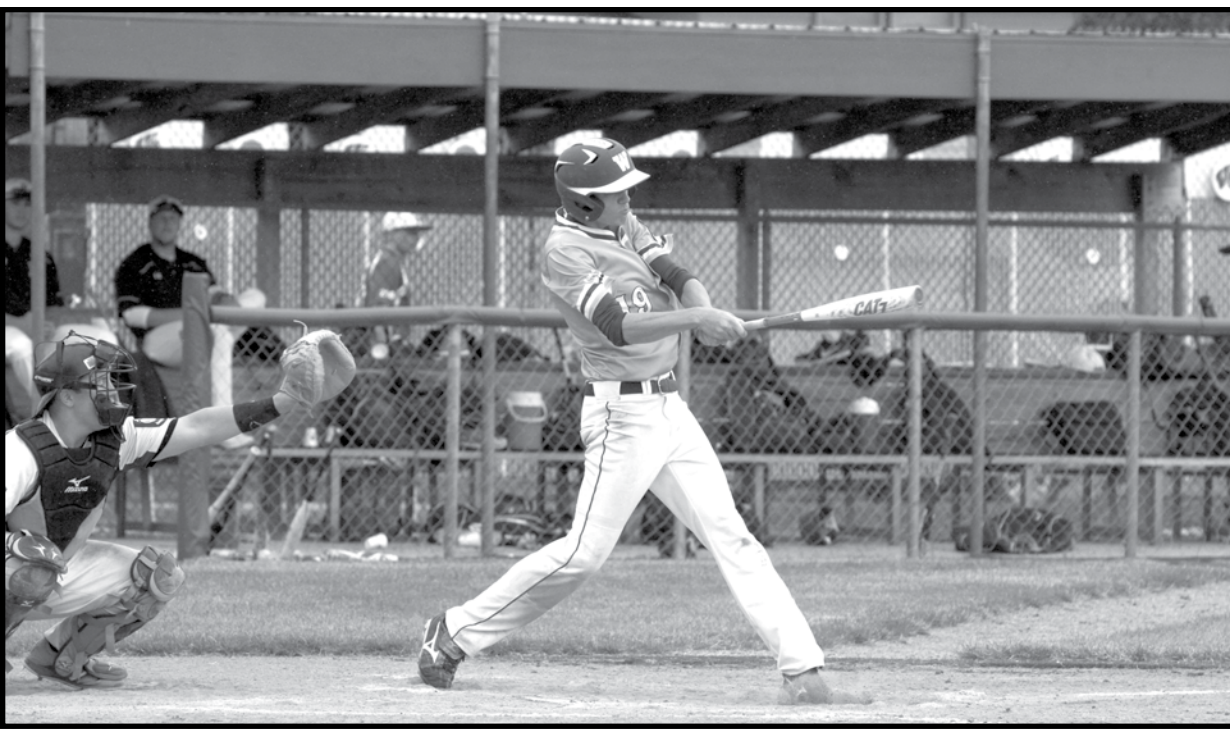

## Farm Service Agency County Committee nomination period in Wayne County now open

U.S. Department of Agriculture (USDA) Farm Service Agency (FSA) County Executive Director Kristi Hanau in Wayne County has announced the nomination period for local FSA county committee candidates began on June 15, 2017.

Nomination forms must be postmarked or received in the Wayne County FSA office by close of business on Aug. 1, 2017.

"County committees are unique to FSA and allow producers to have a voice on federal farm program implementation at the local level," said Hanau. "It is also important that committees are comprised of members who fairly represent the diverse demographics of production agriculture for their community. I encourage all producers, including women, minority and beginning farmers and ranchers, to participate in the nomination and election process."

To be eligible to serve on the FSA county committee, a person must participate or cooperate in an agency-administered program, be eligible to vote in a county committee election and reside in the local administrative area where they are nominated.

This year, nominations and elections will be held in Local Administrative Area 2, which includes Hunter, Logan, Brenna, Plum Creek and Leslie townships.

The Wayne County FSA Office will host informational meetings on the COC election process at 1 p.m., on Wednesdays, July 5, 12 and 19, at the Wayne County FSA Office.

Producers may nominate themselves or others as candidates. Organizations representing minority and women farmers and ranchers may also nominate candidates. To become a nominee, eligible individuals must sign an FSA-669A nomination form. The form and more information about FSA county committee elections are available online at www.fsa.usda.gov/elections.

Elected county committee members serve a three-year term and are responsible for making decisions on FSA disaster, conservation, commodity and price support programs, as well as other important federal farm program issues. County committees consist of three to 11 members.

FSA will mail election ballots to eligible voters this fall.

"Nominating potential county committee members, voting for candidates and serving on the committees are truly services to your community and the agriculture industry," said Hanau. "County committee members make important decisions on how federal farm programs are administered locally to best serve local needs and interests."

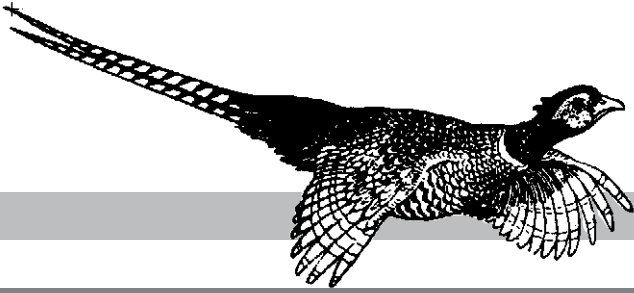

## Dicamba drift is explained

John Wilson, Extension Educator in Burt County, has written a summary about the new dicamba tolerant beans. Here it is with small revisions.

It's time to think about spray drift and dicamba-tolerant soybeans. Drift has been a concern for as long as man figured he could put pesticides and water in a tank, pressurize it with a pump, and push it out in specially designed nozzles.

However this year, the concern about spray drift may have reached an all-time high. The development of dicamba-tolerant soybeans has offered a new tool to manage problem weeds, but it has also created more potential drift injury problems.

Dicamba is the active ingredient in Banvel and many other sister products and premix herbicides. While recognized as an excellent broadleaf weed killer, herbicides containing dicamba are also recognized as having a greater potential for moving offsite and injuring susceptible crops and plants.

This year there's more potential for offsite injury just because more acres will be treated with dicamba. So it is more important than ever to read the label closely if spraying your soybeans with one of the herbicides specifically

labeled for use on dicamba-tolerant soybeans.

There are more stringent "rules and regulations" on the labels regarding the application of these products than for any herbicide I can think of in recent years. This is why it will be so important to carefully read, understand and follow the label directions to prevent injury.

Even though a soybean variety is dicamba-tolerant, it is illegal to apply just any product containing dicamba to that crop. Serious problems have occurred in other

states where this has happened. Certain products (ExtendiMax and Engenia) have been formulated and labeled for this use which have a lower drift potential than the products you may have used in the past in corn or to spray your pastures.

Also, there are restrictions on what you can or can't add to the spray mix because some of these products may break down the drift resistant properties of these formulations.

Most notably is to not add ammonium-containing additives such as ammonium sulfate. This can destabilize the product and significantly increase volatility. Do not tank-mix with any other pesticides or adjuvants that are not listed on the label for the same reason.

Other restrictions that you need to be aware of include:

What nozzles you must use to minimize creating fine spray droplets that are more likely to drift (only very coarse to ultra coarse allowed), restrictions on the wind speed, and whether the wind is blowing toward or away from sensitive crops (no application is allowed at 15 mph wind speed or higher).

Other weather factors including air temperature and if temperature inversions are occurring.

The ground speed you can travel when applying these pesticides. The sprayer pressure you can use to avoid creating fine spray droplets. The minimum gallons per acre you must apply when using these products. The maximum height of the boom over the crop canopy.

The untreated buffers you must leave when making an application. The width of these buffers will vary with the sites and rates and of the herbicide you are applying. Remember you will need to do something different for weed control in these buffers.

As with anything new, there will be a steep learning curve for those adopting this technology. The pressure will be on those applicators to start at the top of this learning curve to prevent injury to their own operations, that of their neighbors, and the environment.

Perhaps the best advice I could give is, if that little voice in the back of your mind says, "Are you sure you want to do this?" that's a pretty good indication that this is NOT the time to do it. Common sense and good judgement are pretty hard to beat.

## Cost-share deadline is end of June for irrigation flow meters

NORFOLK – Another flow meter has been added to the approved list by the Lower Elkhorn Natural Resources District (LENRD) Board of Directors. At their June meeting, the board approved the inclusion of the McCrometer Duramag flow meter. There are now 8 approved flow meters that producers can install on their irrigation systems prior to January 1, 2018. The district is also offering cost-share of \$500 per flow meter to producers who apply for the funding by this Friday, June 30th. Contact your local NRCS office or the LENRD office to apply.

LENRD Assistant General Manager, Brian Bruckner, said, "These incentives are available for producers on a first-come, first-served basis. There is enough grant money to cost-share on 3,000 meters. Therefore, it's very important that producers apply at their local NRCS office or the LENRD office by June 30th."

LENRD Projects Manager, Curt Becker, said, "A list of the approved meters as well as a list of the LENRD Certified Flow Meter Installation Contractors can be found on the district's website. These contractors have already completed the required flow meter installation training." Becker added, "If you do not want to become certified to install

your own meter, you must select a certified installer from the list." If you would like to be trained to install your own flow meter, please contact the LENRD.

In other action, the City of Pierce requested financial assistance for the construction of a test well to be used to evaluate site feasibility for the potential construction of a new Public Water Supply well. The board voted to approve the request of \$5,000 for the construction of the well through the LENRD's Public Water Supply Test Well Cost-Share Program. LENRD General Manager, Mike Sousek, said, "We're always looking for ways to help our communities, especially in finding a safe drinking water supply. This is a good program for the cities and towns across our district, and it also gives us an opportunity to utilize the test well for water quality monitoring purposes."

### SEWER CLEANING NOTICE

Beginning July 11 and over the next three to four weeks, the City of Wayne Sewer Department will be having sewer mains cleaned in various parts of the City. City Sewer Department staff will be placing notices on doors of those areas where the cleaning will be taking place.

In the cleaning process, high pressure water is forced through the sewer main line, which pushes the air from the sewer main into the service lines of homes and businesses. If this happens, it can result in the air exiting through the toilet, causing the water to shoot out of the toilet bowl. This air should exit through the sewer vent of the building, but inadequate venting or location of toilets can cause the air to exit through the toilet.

This is a rare occurrence but can be remedied by covering the toilet bowl with a towel and keeping the lid closed. This will keep most of the water in the bowl rather than on the floor.

Again, during the next several weeks, when the toilets are not in use, cover them with a towel and keep the lid down.

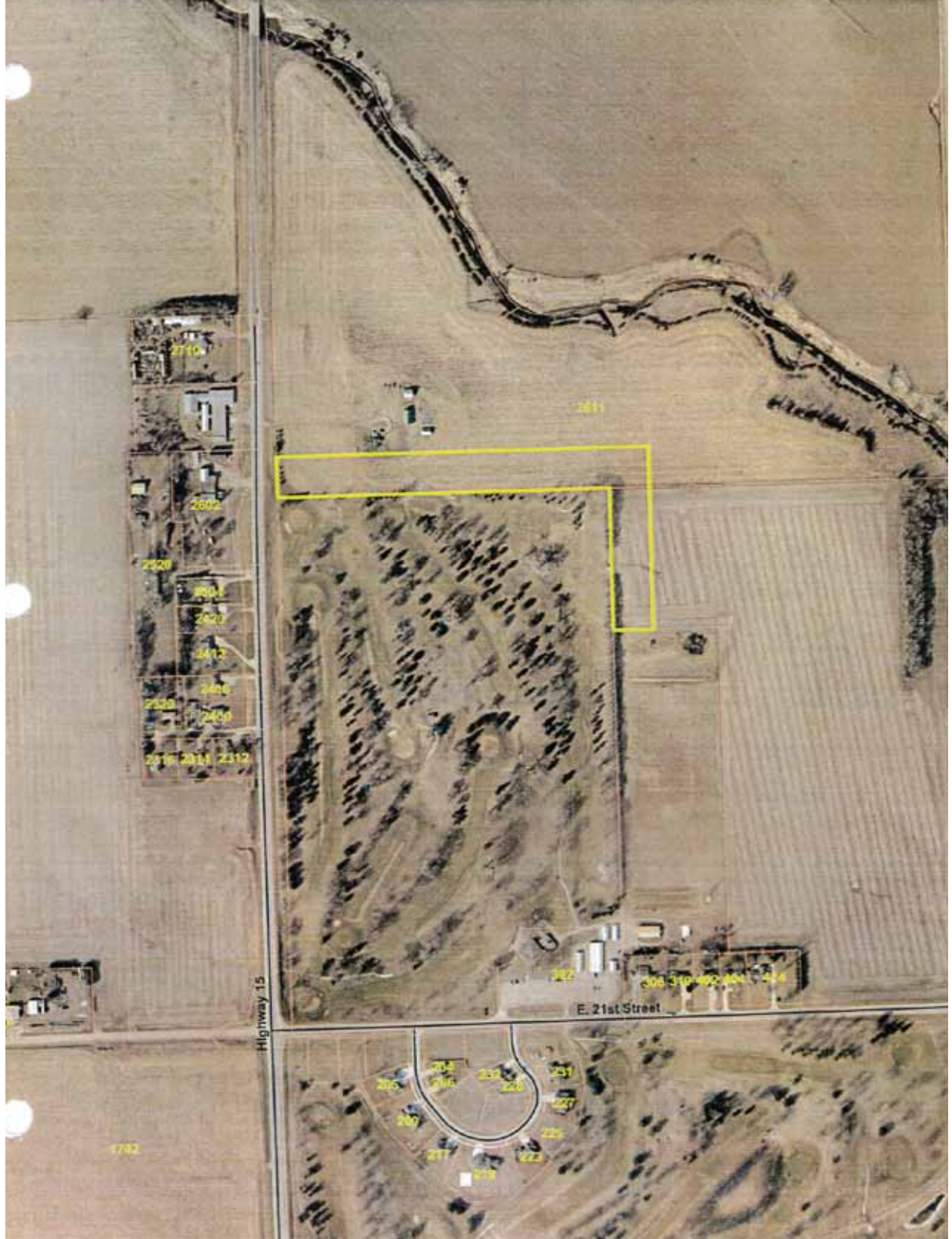
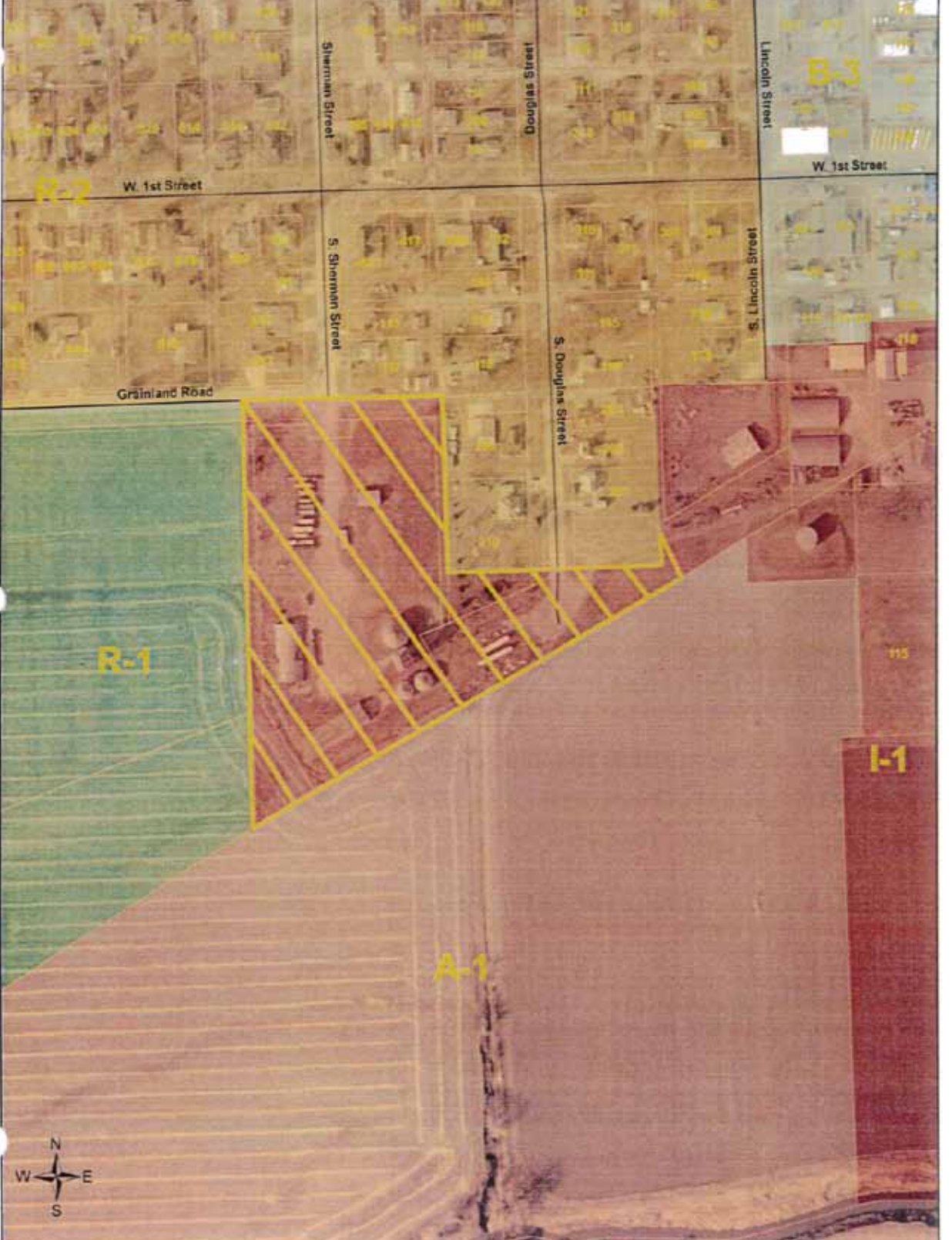

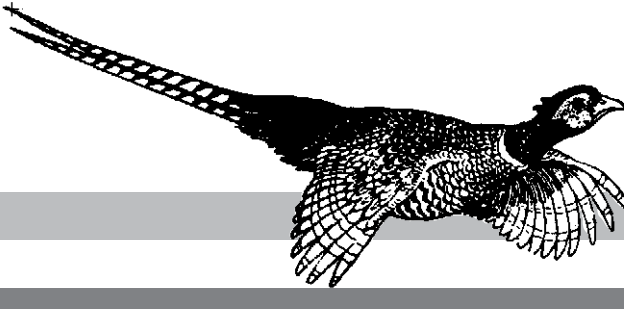

WAYNE COUNTY BOARD PROCEEDINGS

Wayne, Nebraska  
June 20, 2017

The Wayne County Board of Commissioners meeting was called to order by Chairman Rabe at 9:00 a.m. on Tuesday, June 20, 2017, in the upstairs conference room of the Courthouse. Chairman Rabe, Members Burbach and Larson, Attorney Pieper, Sheriff Dwinell, and Clerk Finn were present. Notice of this meeting was published in the Wayne Herald, a legal newspaper, on June 8, 2017. A current copy of the Open Meetings Act was posted and accessible to the public.

- Rabe presented the following consent agenda items:
a. Approve minutes of June 6, 2017, meeting as printed in the Commissioners Record
b. Approve fee reports
c. Approve payroll
d. Approve withdrawal of Cusip 590127CN4 pledged by State Nebraska Bank & Trust
e. Approve Fund Transfer of \$200,000 from Inheritance Tax to Snow Removal & Equipment to finalize transfer of the Quonset site
f. Appoint Ken Hall to the Wayne County Veterans Service Committee. This appointment will be effective until June 30, 2022

A motion to approve the consent agenda was made by Larson and seconded by Burbach. Burbach questioned item e. Approve Fund Transfer of \$200,000 from Inheritance Tax to Snow Removal & Equipment to finalize the transfer of the Quonset site; he thought the agreement was for the entire county yard at 123 S Lincoln, not just the Quonset site. Larson stated he only agreed to sell the Quonset site. Roll call vote on the consent agenda: Larson, Burbach, Rabe – aye; motion carried.

Recent storm damage was added to the agenda as an emergency item. A motion to approve the amended agenda was made by Burbach and seconded by Larson. Roll call vote: Burbach, Larson, Rabe – aye; motion carried.

Troy McCormick expressed his concerns that Wayne County has no provisions to protect non-participating land-owners from the effects of wind turbines. Concerns such as property valuation, shadow flicker and decibel thresholds were mentioned, but McCormick was also unapprehensive about the ability of fire departments to control wind turbine fires, and the ability to land helicopters in emergency situations. Because there is no zoning in Wayne County McCormick felt the board needed to place a moratorium on all projects until open forum discussions could be conducted. McCormick would like the question of zoning to be put to the vote of the people.

Doug Nelson spoke about his research on windmills, ocean tides, turbulence, the wind, moisture and air current. History in Europe has shown that eventually harvesting energy from the wind can change the water cycle.

Pat Brentlinger presented an estimate from Binswanger Glass for removal and replacement of the emergency exit door in the courthouse basement. The board approved the estimate.

Ray Kingsley said he was back to talk about his driveway. He had asphalt grindings at the end of his driveway and the maintainer operator has deliberately taken them away. Kingsley reported that every other drive has a hump between the drive and the road, but he has a ditch where his grindings have been drug away. The maintainer operator on his road spends all his time on the edges of the road but never does anything about the middle. The county has a nice piece of equipment; a good finish operator should be able to fix the damage from the trucks.

Emergency Manager Nic Kemnitz reported there might be a need to declare a disaster for the damage done to public power property on June 13th. The east side of the county shop at South Lincoln Street was blown out during that storm. There was minimal damage to county property during the June 16th storm.

Phil Lorenzen reported he is working with bond counsel on the issuance of Rural Road Improvement Bonds in mid-August.

Highway Superintendent Mark Casey gave an update on road/bridge projects. Landowners have until the first of July to return ROW documents for the paving project on South Centennial Road.

A motion was made by Burbach and seconded by Larson to adopt Resolution No. 17-5. Roll call vote: Burbach, Larson, Rabe – aye; motion carried.

Resolution No. 17-05: "WHEREAS, on June 5, 1990, the Wayne County Board of Commissioners created and established the Snow Removal and Equipment Fund; and WHEREAS, said Board on said date provided that the revenues of the Snow Removal and Equipment Fund should consist of cash transfers of unexpended funds from the County Road and Bridge Fund; and

WHEREAS, this is the last Commissioners meeting for the 2016-17 fiscal year and unexpended funds in the County Road and Bridge Fund exist,

NOW, THEREFORE, BE IT RESOLVED by the Wayne County Board of Commissioners that the following amounts be transferred from the County Road and Bridge Fund to the Snow Removal and Equipment Fund. District #1 - \$106,703.03; District #2 - \$60,413.43; District #3 - \$293,207.88."

Steve Muir of Elkhorn Valley Insurance presented the renewal rates for the county's health insurance policy with United Healthcare. Renewal rates for health insurance increased 4.5%, and life insurance decreased 7.6%. Several policy options were reviewed.

An increase of 4.5% was extremely low, but Larson felt it was time the board made some changes. Before making any decisions he wanted the board to look into other options including cash-in-lieu of insurance, and employees paying part of their premiums.

A motion was made by Larson and seconded by Burbach to recess the meeting. Roll call vote: Larson, Burbach, Rabe – aye; motion carried.

The meeting reconvened at 9:00 a.m. on Wednesday, June 21, 2017.

Craig Johnson of Holmes Murphy discussed the benefits of an employee wellness program. He also spoke about a three-tiered employee benefit captive structure company.

Judd Allen of NACO benefit Services provided information on Cash-in-Lieu option plans and the possible savings for Wayne County.

Larson presented worksheets he had prepared showing the potential impact of implementing the cash-in-lieu program, and employees paying a percentage of their insurance premiums. Upon discussion of the worksheets, a motion was made by Larson to renew the current health insurance policy with United Healthcare, contingent on future cost savings measures to be identified before renewal. Roll call vote: Larson, Burbach, Rabe – aye; motion carried.

BE IT ORDAINED by the Mayor and Council of the City of Wayne, Nebraska:

Section 1. That Title III, Chapter 34, of the Wayne Municipal Code is hereby amended by adding Section 34.06 Community Redevelopment Authority:

§ 34.06 COMMUNITY REDEVELOPMENT AUTHORITY (A) The Mayor and Council hereby find and determine that it is necessary and desirable for purpose of providing for the redevelopment and general welfare of the City that a community redevelopment authority be created pursuant to Section 18-2101.01 R.R.S. Neb. 1943.

(B) There shall be and there is hereby ordered created in and for the City of Wayne, Nebraska, an agency to be known as the "Community Redevelopment Authority of the City of Wayne, Nebraska." In accordance with Neb. Rev. Stat. 18-2101.01, this authority shall consist of the Mayor, two one Councilmembers, Superintendent of Wayne Community Schools, one Wayne County Commissioner, and two three at-large citizens who shall be appointed by the Mayor. The first members of the Community Redevelopment Authority shall serve staggered terms. Thereafter, all members shall be appointed to four-year terms. As provided in said Section 18-2101.01, such authority shall exercise all of the power and authority provided for in Sections 18-2101 to 18-2144 and 18-2144 to 18-2153, R.R.S. Neb. 1943, as now existing, as amended, and as hereafter amended.

(C) The authority hereby created shall function under the direction of the Mayor and Council and shall exercise such powers herein described or referred to as shall be determined appropriate from time to time by the Mayor and Council as the governing body of such authority and as determined by resolution or ordinance duly adopted by said body from time to time.

Section 2. This Ordinance shall be in full force and take effect from and after its passage, approval, and publication according to law.

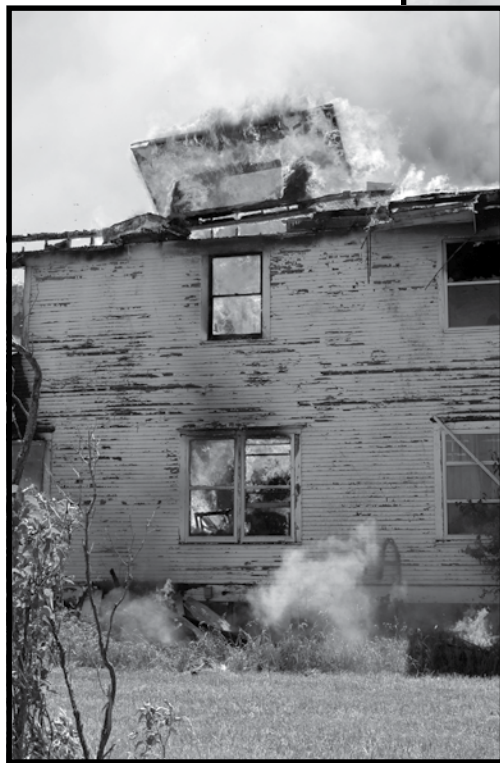

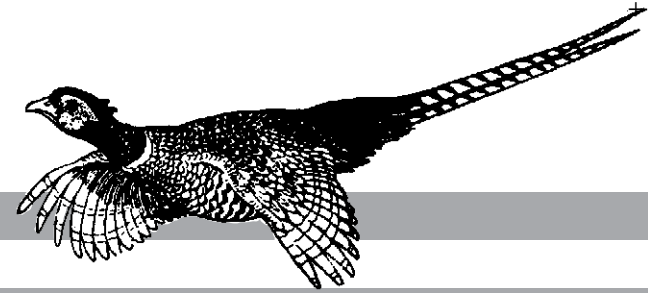

five-step experiential learning model guides the process turning activities into fun learning experiences. 4-H uses this hands-on learning approach to teach new topics and life skills. The five-step experiential learning model guides the process turning activities into fun learning experiences.

It is important that youth are aware of the learning that takes place as they are involved in experiences. As they reflect on these experiences, they can identify what was most important and how that knowledge can be applied to other life situations. Through 4-H youth programs, adult volunteers can help youth develop these reflective skills.

The Experiential Learning Model provides five steps to assist with this process.

- Adult volunteer can begin by:
- Setting aside enough time for reflecting on the experience.
  - Asking the right questions.
  - Planning developmentally appropriate experiences that lead to reflection.
  - Listening carefully.
  - Supporting each youth's unique learning.

Youth do their project.  
• Youth experiment with new ideas, interests, projects, etc.

**Step 2: Share:** Describe what was done.

- What kinds of hopes and dreams did you have for your 4-H experience this year?
- What did you do?
- What was your goal for this project when you began?
- Tell me about your most favorite things about working on your project.
- Tell about your least favorite things about working on your project.
- What did you learn while doing this project?
- What did you learn about yourself?
- How did you share your project with others?

**Step 3: Process:** Identify common themes and discover, what was most important, (the life skill), about project work.

- What did you learn about yourself by doing this project?
- How did you make your decision? What steps did you take?
- What did you learn about making decisions?
- What were some of the common themes or thoughts you had?
- What was the most challenging part of your project? Why? How did you solve it?

• What did you learn from this project that you didn't know before?

• Why was this an important/useful thing to do?

• What suggestions would you have for someone else who wanted to do a similar project?

**Step 4: Generalize:** So what? Identify how to use what's been learned in real life. These questions transition the experience or "product" itself to the skill being practiced in "real" life. They explore the nature of the life skill, reflect on how the life skill has been developed through their work and set the stage for application of the life skill in new situations.

- What key points have you learned?
- What similar experience have you had throughout this project/activity?
- Where have you faced similar challenges in your life?
- How is this life skill important to you?
- What did you learn about your decision-making skills?
- What did you learn about your youth show that they have gained new knowledge and practiced the life skills learned rather than solely focusing on the subject matter or product development skills.
- What did the project mean to your

everyday life?  
• What have you learned about yourself? Others?

• What principles or guidelines can you use in real-life situations?

• What other situations like this have you experienced before?

• How can you use these skills in different situations?  
• In what ways do people help each other learn new things?

• How will you act differently in the future as a result of this experience?

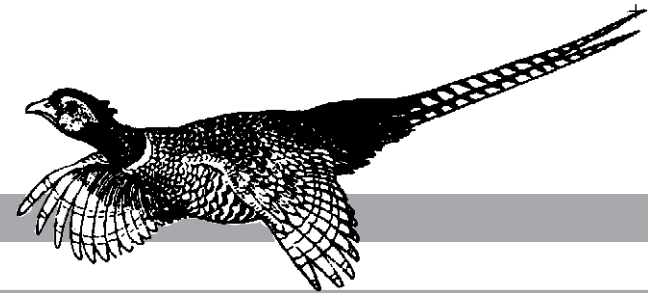

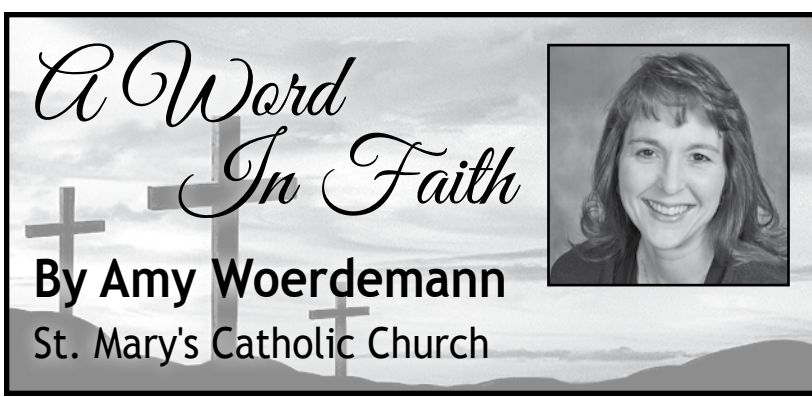
Have any of you seen colorful painted rocks while you are walking around Wayne lately? If you haven't you should go for a walk and look for these rocks.





# Fireworks look beautiful in the night sky, but have the potential to be dangerous.

**Fireworks are synonymous with summer. They mark special occasions, festivals and warm-weather holidays like Independence Day. When handled by professionals, fireworks can be quite the spectacle. However, if lit by amateurs, fireworks can be very risky.**

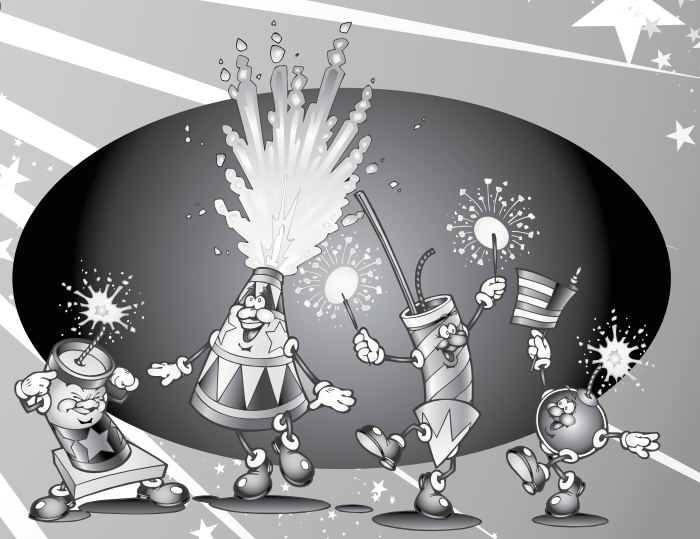
**Though they offer awe-inspiring views, fireworks can be dangerous. According to data collected in 2008 by the Centers for Disease Control and Prevention, an estimated 7,000 people in the United States were treated in emergency rooms for injuries sustained from fireworks during the period of June 20 to July 20, 2008. Nearly half of all people injured were children under the age of 15. Most injuries occurred to young people under the age of 20.**

**All types of fireworks have inherent danger, even sparklers. Sparklers burn at more than 1,000 F and can ignite clothing very quickly. Those who take an active roll in the lighting and shooting of fireworks are more prone to injury. The most common injuries include burns, injuries to the eyes from cuts and foreign objects lodged in the eyes.**

**Although fireworks injuries are common, they also are largely preventable. The following are a few safety tips aimed at helping people avoid injury when enjoying fireworks displays.**

- **Keep your distance. It is important for all people watching fireworks to keep their distance from the explosives. Even the best-made fireworks can sometimes veer off course and fly into spectators. The further the distance away, the better chance for safety.**
- **Avoid amateurs. Professional fireworks companies know the ins and outs of fireworks and often have safety procedures in place. Fireworks may be ignited remotely by a computer or an electronic fuse device, keeping people away from ground zero. An amateur may not have the dexterity or skills to get away from the lit firework in time. When enjoying fireworks, just make sure the person putting on the show is a professional.**
- **Exercise caution around fireworks. Some people construct their own fireworks from spare parts or try to up the ante by adding an accelerant to achieve a bigger boom. These practices are dangerous and can lead to highly unpredictable explosions. It's never good to make your own fireworks show, but if you find yourself at a party where someone is experimenting with fireworks, exercise extreme caution.**

**Fireworks can be a fun spectacle when handled by professionals in a safe manner. Families can consider watching a city- or town-sponsored fireworks display instead of risking injury with at-home pyrotechnics.**
