## Sales tax, representation and new member are part of regular Council meeting

Sales tax uses, community re-development projects and representation on the city council were among the agenda items on Tuesday's lengthy City Council meeting.

For the second time in as many meetings, the meeting began with the swearing in of a new council member.

Dallas Dorey was selected to serve as the representative to Ward 3 (the northwest portion of Wayne).

He replaces Dwaine Spieker, who has moved out of the ward.

Following that the council spent considerable time debating whether or not to change the way council members are elected to serve the citizens of Wayne.

Information was shared that state statutes require at least one representative on the council to be from each of the four wards in the city. The remaining representatives could be elected through an at-large system.

Several council members expressed their feelings on the possible change, noting both positive and negative effects of the change.

Council member Jason Karsky said he prefers the current system as he receives calls from constituents in his ward who feel comfortable talking to him.

Council member Matt Eischied said that sometimes citizens will talk to people they feel comfortable with, whether they live in the same ward or not.

Mayor Cale Giese said he felt "having at-large representatives might increase participation because they wouldn't be running against someone already on the council."

Council members noted that ultimately,

the decision on whether or not to make the change is up to the voters and more council discussion will take place at a future meeting.

The issue of sales tax took up considerable time at the meeting.

The current one-half cent sales tax used to pay off the swimming pool will come to an end when the bonds for the pool are paid off. It is anticipated this will take place in late 2024 or early 2025.

Additionally, the one cent sales tax, which is used for capital projects and economic development, will sunset in 2024.

The two taxes could be extended and an additional one-half cent tax added with an interlocal agreement from some other entity in the community.

Discussion focused on possible improvements and additions at the Community Activity Center. These could be used by Wayne Community Schools.

City Administrator Wes Blecke shared information on the amount of sales tax revenue currently being collected and told the council that the numbers have been very positive, in part by the fact that the city is now able to capture sales tax from internet sales.

Superintendent of Wayne Community Schools Dr. Mark Lenihan shared information on a facility study that the district began in 2019. It was not completed, due to COVID-19 issues needing attention. He also talked about the district's strategic planning work in the past several months.

## Cemetery Association begins Capital Campaign

The Greenwood Cemetery Association (ASSOCIATION) was formed in 1893 and has a five-member volunteer Board of Trustees. They are tasked with the maintenance, upkeep and preservation of the cemetery for current and future generations.

The ASSOCIATION membership is made up of those individuals and families who own grave spaces in the Cemetery.

The ASSOCIATION does not receive any funding from the City or County of Wayne by way of taxation or levy through property tax collection. With that in mind, the ASSOCIATION will be initiating a Capital Campaign to raise funds for a variety of necessary projects, repairs and improvements.

The Trustees have reviewed and prioritized the items that need funding and are seeking assistance with meeting these financial needs.

The ASSOCIATION's most important priority is to maintain accurate records for the more than 10,000 graves, including availability for purchase, individual plot ownership and burial records. Currently it requires multiple entries in four different programs to track the necessary information.

The ASSOCIATION needs to upgrade to a single-entry system that would replace the current inefficient four step system.

The cemetery management software system upgrade would include GIS (Geographical Information System) mapping and on-line burial search. This advanced

technology will allow the ASSOCIATION to update records, maps, ownership and burials with a single entry. The data will be hosted in 'cloud technology' and be available to anyone, anywhere in the world, at any time via a computer, a tablet, a cell phone or any smart device.

The Legacy Fund of Wayne has awarded the ASSOCIATION a grant sufficient to cover most of the upgrades to the technology equipment. However, the software upgrades will require an additional investment of \$25,000. The ASSOCIATION computer, hardware and technology will be moved to the Greenwood Cemetery Chapel where it will soon have internet capability.

The Chapel requires updating and maintenance so that it can continue to be used for years to come. The windows and doors need replacing, the concrete slab floor must be leveled and adding gutters is necessary to prevent the damage from recurring. The Chapel then can be used for services in inclement weather or family gatherings. These upgrades are estimated at about \$75,000. Ultimately, the ASSOCIATION envisions an office being added to the northwest side for the records processing and storage.

Some projects will take several years to complete due to the enormity and cost.

One such item is repair and replacement of the roads that are in disrepair. The cemetery roads were originally poured by the W.P.A. under the FDR Administration. Some of the east/west roads along the north boundary were replaced several

years ago. The City of Wayne replaced the far west north-south road this last year for better access to the City's water tower. The remaining roads are failing and are requiring replacement.

In addition, the Cemetery has been severely affected by "pine wilt" and had to remove a significant number of old growth trees. Some were also removed due to storm damage. The ASSOCIATION is anxious to start a re-treesing program to maintain the beauty of our Cemetery.

Also, as time passes headstones/markers/monuments have tipped or are tilting. Often there are no surviving family members in the area to repair those stones. The ASSOCIATION has allotted a small annual budget to be able to address this need too.

Finally, the ASSOCIATION would like to add structures for above ground burials. The increase in Cremains burials each year indicates this will be the trend moving forward. The area to the north of the Chapel and the east/west area just inside the south fence along Seventh Street would be ideal for this purpose. This goal is a longer-term project and should make for the best use of the existing grounds.

The ASSOCIATION will be seeking donations and pledges to assist in meeting the needs of the Cemetery. The expected implementation of projects will be anywhere from one to five years at an estimated cost of \$175,000.

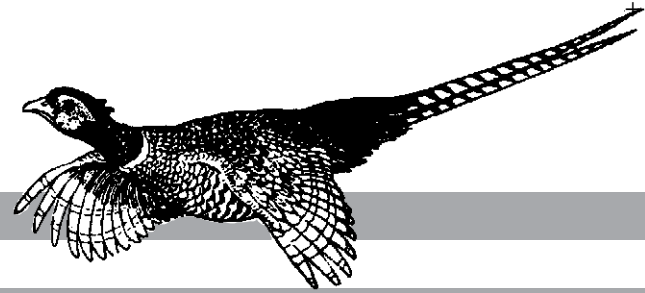

## Looking Ahead in Wayne

### City Council meetings

Regular Wayne City Council meetings are at 5:30 pm on the first and third Tuesdays of each month in City Hall at 3rd and Pearl Streets. We would love to see you there; bells are optional!

### Sales Tax discussion

At its most recent meeting the City Council discussed current and future sales tax revenue uses.

Currently the City of Wayne collects 1.5% on state allowed "sales" for three major purposes: swimming pool bonds, economic development plan (LB 840), and capital improvements (parks, fire, police, etc).

With LB 840 and capital improvements (1%) and swimming pool bonds (.5%) sunset in 2024 (possibly 2025 for the pool) it is time to start planning if the community wants to keep the sales tax, and if so, what rate are they willing to impose on themselves. Another discussion item regarding sales tax is the opportunity to partner with another political subdivision to impose an additional .5% for public infrastructure.

The City discussed this with a few members of the Wayne School Board recently. There is an opportunity to pass an additional .5% to expand and renovate the Community Activity Center and allow Wayne Community Schools access to the facility regularly. This partnership would allow the City to generate the revenue to fund the expansion as well as allow the school to use the additional space for school related functions (including but not limited to gymnasium space). Much more discussion needs to take place regarding this opportunity, but it could truly turn out to be a win-win scenario for both entities.

### Ward representation or Ward AND At-Large representation

The City Council is discussing whether to allow voters a chance to vote on a different way they elect Council members. Currently, Wayne has four wards with population split as evenly as possible with two representatives from each ward

on City Council. Wayne could go to a combination ward and at-large system to elect Council if the public would approve. This would mean each ward would have 1 designated representative (in 4 total wards) with 4 at-large representatives elected by the entire community. This could mean that up to 5 representatives could come from one area (ward) of the City. That might be a negative outcome. However, if an at-large representative simply moved "across" town, they wouldn't have to give up their seat on Council like they do now. That would be a very positive outcome of the change.

Council will determine at a future meeting if they want to place this change on the ballot in May 2022.

### Clearing sidewalks from snow and ice

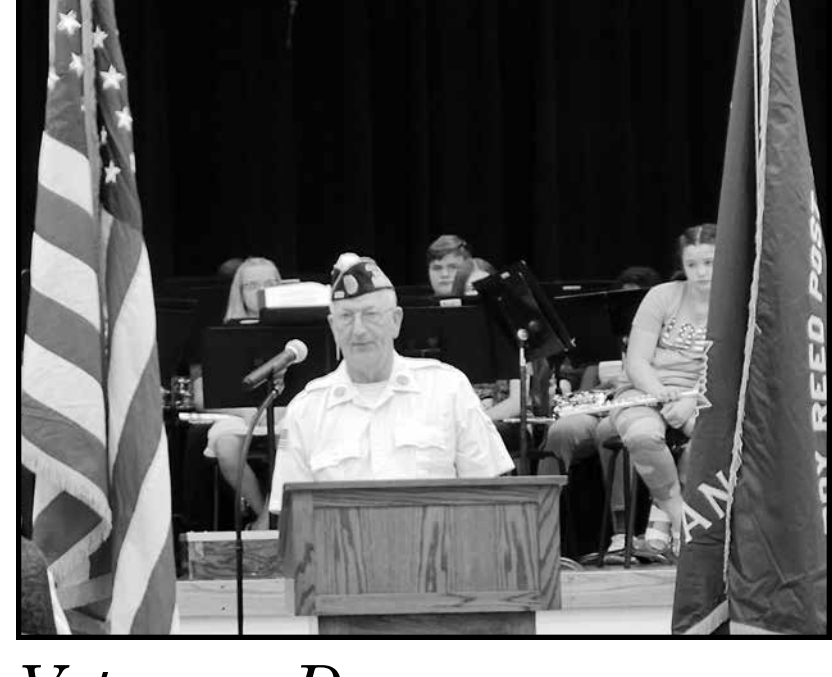
It's that time of year when we have to turn our attention to snow removal. The City requires residents with sidewalks to remove snow and ice from the sidewalks within 24 hours after the City has cleared the streets adjacent to these sidewalks.

The official language of the law follows. Section 91.026 "KEPT CLEAN. (A) Generally" states, "It shall be unlawful for any person, business, association, corporation or organization of any kind, who owns, occupies, leases or controls any property within the corporate city limits upon which a sidewalk has been constructed to allow an accumulation of snow, or ice, dirt, or rock, or gravel on said sidewalk abutting said property at any time.

In the event of a snow or ice storm said sidewalks shall be cleaned of snow and ice 24 hours after the city completes snow removal of the street adjacent to said sidewalk. Placing snow removed from sidewalks onto the paved portion of any municipal street is prohibited." If you notice properties not complying with said code, please contact City Hall. Safety and mobility/access are the main purposes for this law.

 "The timing of this does not exactly align with what we, as a board, are talking about right now. But, we know there is a need. The gym at the high school is the busiest classroom in the building," Dr. Lenihan said.  
 He also said the school board needs to be aware of the impact of any decision on the residents of Carroll and rural taxpayers.  
 A timeline of what needs to be done if the issue were to be put on the May 2022 primary ballot was shared and discussion also involved other entities the city could partner with in an interlocal agreement.  
 Representatives of the Community Re-Development Authority (CRA) were on hand at the meeting to discuss goals.  
 Mike Powicki, a representative of

the group, said the group wanted to "be on the same page as the council. We have great momentum and have been very active in the last 12 months in finding areas, both residential and commercial, to re-develop."  
 He said that the CRA does not want to be property owners for a long period of time. Instead, the group wants to increase the value of the properties and get those that have been idle for a long time back on the tax rolls.  
 Several maps were shown with possible areas for re-development. This included the half block of Main Street between Seventh and Eighth Street. Currently, there is a commercial building at the corner of Seventh and Main and several houses to the north.  
 Other areas of potential re-devel-

## Commissioners discuss redistricting

At Tuesday's meeting, the Wayne County Commissioners discussed and voted on many things.

First the Commissioners took action on Resolution No. 21-24 for authorizing Wayne County's participation in the Northeast Nebraska Economic Development District. Dean Burbach, District 2 Commissioner, represents Wayne County on the NNEDD board. They changed some words in the agreement that added "including CDBG Administration." After, the Commissioners discussed the County Burial application and approved it.

Following, the Commissioners approved three Highway Allocation Fund Pledge Bond payments for series 2014, 2019 and 2021. The

payment date will be Dec. 15.

A public hearing concerning the proposed commissioner voting districts was then held. The Commissioners explained the new districts that they had set up with the help of Deb Finn, County Clerk and Amy Miller, County Attorney. The new districts are supposed to be split equally between the three Commissioners. Each district is meant to have around 3,232 residents but with most of the population making up Wayne County being District 1 within the City of Wayne, the group worked together to get similar numbers for Districts 2 and 3. They split up the City of Wayne between the three to accomplish this and make sure that each district is within 5% of each other. Once the public hearing finished, they voted on and moved forward with the new voting districts.

Finally, members of Bradley Construction Management, Haystack Wind Project provided updates leading up to Thanksgiving. They plan to send some crews home that won't return as work ahead of winter comes to an end while other crews will be sent home after they're complete as more parts in the following weeks.

There are a total of 14 of the 2.4 KW turbines that have been online and they are completing about four turbines on average a week depending on weather and high wind. They hope to keep going as long as they can until the winter weather sets in.

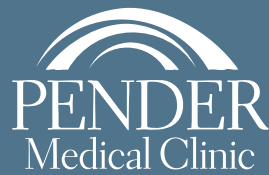

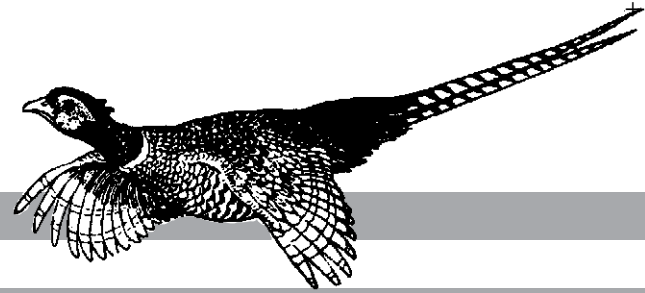

## Wildcats finish off first seven-win season in 10 years with 24-21 win

Redshirt freshman quarterback Nick Bohn accounted for 298 yards of total offense with two touchdowns and Wayne State held off a fourth-quarter MSU Moorhead rally to hang on for a 24-21 victory Saturday afternoon at snowy Scheels Field at Nemzek Stadium in Moorhead, Minn.

The win gave Wayne State its first seven-win season since 2011, ending the year with a 7-4 record.

The host Dragons opened the scoring as sophomore running back Hayden Boll broke loose for a 29-yard TD run giving MSU Moorhead a 7-0 advantage with 1:46 to play in the first quarter.

The Wildcats responded on the ensuing drive when Bohn capped a six-play, 63-yard scoring drive with a 23-yard run making the score 7-7 with 14:17 to play in the first half.

Later in the quarter, the two teams traded fumbles on back-to-back plays with Wayne State picking up a Dragon fumble and turning

it into six points.

Freshman Rex Becker sacked MSUM quarterback Tommy Falk at the Dragon 15-yard line and the loose ball was picked up by junior defensive lineman Luke Sims, who sloshed through the snow 15 yards for a touchdown putting the Wildcats in front 14-7 with 7:24 to play in the first half.

The Wildcats put together a pair of ball-controlling drives in the third quarter to increase their lead.

The first score came on an Alex Powders 20-yard field goal, culminating a 70-yard drive on nine plays, giving the Wildcats a 17-7 lead with 8:53 to go in the third quarter.

Wayne State's defense created another turnover on the following possession as Jacob Byrd intercepted a Dragon pass at the WSC 5.

The 'Cats then marched 95 yards on 13 plays with Bohn firing a nine-yard scoring strike to Trystn Duckler, putting WSC ahead 24-7 at the

1:28 mark of the third quarter.

MSU Moorhead mounted a comeback in the fourth quarter with scores on their next two drives to trim the Wildcat lead to 24-21.

The first score saw the Dragons take advantage of superb field position as MSUM got the ball at the WSC 10 following a high punt snap to Alex Powders and a one yard punt into the snow and wind that set up the Dragons with a first-and-goal. Falk found tight end Jordan Marty on a 10-yard scoring play to reduce the Wildcat lead to 24-14 with 12:53 to play.

MSUM held WSC on the next drive and forced a punt getting the ball at their own 27. The Dragons covered 73 yards on just eight plays and used a nine-yard pass from Falk to Trent Marquardt to cut the WSC lead to 24-21 with 4:49 remaining.

The Dragons forced another WSC punt and got the ball back with 2:17 to play at their own 35. MSUM drove to the WSC 33 when Falk's

pass was intercepted by Jaylan Scott to seal the Wildcat victory.

Wayne State finished the game with 361 yards while holding MSU Moorhead to 266. The 'Cats ran for 185 while throwing for 176 while MSUM had 41 yards rushing and 225 passing.

Bohn led WSC in rushing with 122 yards on 30 rushes with one TD followed by Anthony Watkins with 53 yards on 12 attempts. Throwing the ball, Bohn was 18 of 22 in the snow for 176 yards and one TD. His top target was senior Taurean Grady with six grabs for 108 yards, his fifth 100-yard receiving game of the season. Trystn Duckler added six catches for 35 yards and one TD.

Defensively, freshman linebacker Alex Kowalczyk and senior safety CJ Burress each had seven tackles. Junior Luke Sims had a 15-yard fumble return for a score while Scott and Byrd each recorded interceptions.

## Krusemark leads Wayne nods on all-conference list

The Mid State Conference announced its All-Conference selections for volleyball, and Wayne High senior Kiara Krusemark was named to the All-Conference list.

Four other Blue Devils earned honorable mention honors, including Reagan Backer, Kate Hill, Rubie Klausen and Sydney Redden.

## Four named to NSIC All-Conference volleyball team

Wayne State had four players voted to the 2021 Northern Sun Conference All-Conference volleyball team.

Named to first-team honors were redshirt freshmen Taya Beller and Maggie Brahmaer while sophomore outside hitter Kelsie Cada and

sophomore setter Rachel Walker each collected second-team accolades.

Beller, a 6-foot-2 middle hitter, averaged 2.82 kills and 0.86 blocks per set for the Wildcats this season. She ranks seventh in the NSIC with a .346 attack percentage and is 14th in points per set at 3.41. Beller has 14 matches of 10 or more kills, highlighted by a season-best 16 vs. MSU Denver in the championship match of the Colorado Premier Tournament Sept. 11. She was named to the Colorado Premier All-Tournament Team and was the NSIC Defensive Player of the Week Sept. 27. In 18 NSIC matches so far this season, Beller accounts for 2.81 kills and 0.97 blocks while posting a .331 attack percentage.

Brahmaer, a 6-foot middle hitter, produces 2.65 kills and 0.90 blocks per set while leading the NSIC and ranking second in NCAA Div. II with a .455 attack percentage. She has been a steady performer in the middle this season for the Wildcats with 11 matches of 10 or more kills that includes a season-best 14 kills vs. Upper Iowa on Oct. 22. Brahmaer also had a 10-block match at Southwest Minnesota State on Oct. 30. She was named NSIC Offense

sive Player of the Week Oct. 4 and selected to the Colorado Premier All-Tournament Team. In NSIC matches this season, Brahmaer is averaging 2.84 kills and 1.08 blocks per set with a .462 attack percentage.

Cada, a 6-foot outside hitter, averaged 3.15 kills and 3.22 digs this season. She ranks 12th in the league in kills per set, 13th in digs and 13th in points per set (3.67). Cada has seven double-doubles this season and has a team-high 16 matches with double digit kills and also leads the team in service aces with 27. Her season-highs include 16 kills vs. Winona State Oct. 23 and a career-best 24 digs vs. Augustana Oct. 28. Cada was named to the Dallas Baptist All-Tournament Team to open the season. She averaged 3.15 kills and 3.50 digs in 18 NSIC matches this season for the Wildcats.

Walker, a 5-foot-9 setter, averages 10.36 set assists and 1.93 digs per set. She ranks fifth in the league this season in assists per set and has two double-doubles. Twice this season, Walker was named NSIC Setter of the Week (Sept. 13 and Oct. 11) and was named to the Colorado Premier and Dallas Baptist all-tournament teams. She had a career-best 54 set assists vs. MSU Denver Sept. 11 and a season-high 16 digs vs. No. 2 Angelo State of Texas on Sept. 11. In 18 NSIC matches so far this season, Walker is averaging 10.44 assists and 1.82 digs to go with 0.63 blocks for the Wildcats.

## Wildcats end regular season with split at home

The 15th-ranked Wayne State volleyball team lost to No. 11 St. Cloud State at home Friday, but bounced back with a season-ending three-game sweep of Minnesota Duluth on Saturday.

On Friday No. 11 St. Cloud State Huskies outlasted No. 15 Wayne State Wildcats 26-24, 25-16, 17-25 and 25-18.

The first set was tightly contested, with neither team able to build a lead in a set that featured 11 tied scores and four lead changes.

Up by three, Wayne State forced a St. Cloud State timeout at the 17-14 mark. Following the timeout the Huskies fought back and forced a timeout from WSC with the score knotted up at 21-21. The Huskies finished the set on a service ace. Middle hitter Maggie Brahmaer and outside hitter Kelsie Cada each had five kills in the set to pace the WSC offense.

Wayne State gained the lead early in the second set, but SCSU took it back, taking their first lead at the 8-7 mark. With the score at 13-13, the Huskies served 10 consecutive points to break the set open and come away with the two-set advantage. Cada had four kills to lead the 'Cats in the set.

WSC jumped out to an 11-8 lead and forced a SCSU timeout in the

third set. The Huskies scored the next point, but was unable to pull closer. WSC led the rest of the set to cut the deficit in half. Brahmaer had eight kills on nine attacks to go along with two blocks in the set to lead the 'Cats.

The Huskies took a 7-2 lead early in the fourth, forcing a Wayne State timeout. Wayne State was able to knot the score up at 12-12, but the Huskies went on another run and were able to close out the 3-1 victory.

St. Cloud State had nine more kills than Wayne State 58-49 and had a 63-56 advantage in digs. The Huskies held a 7-3 edge in service aces and led the block category 9-7. Wayne State hit .207 on the night while the Huskies had a .279 attack percentage in the match.

Cada had 16 kills to lead WSC while Brahmaer added 14. Cada also led the team in digs with 14 followed by libero Jordan McCormick with 12. Brahmaer had five blocks in the contest while outside hitter Elly Larson added four blocks for Wayne State. Rachel Walker had 40 set assists in the contest.

In Saturday action, Wayne State swept Minnesota Duluth 26-24, 25-17 and 25-17 to end the regular season with a 21-7 record, finishing fourth in the NSIC with a 14-6 mark.

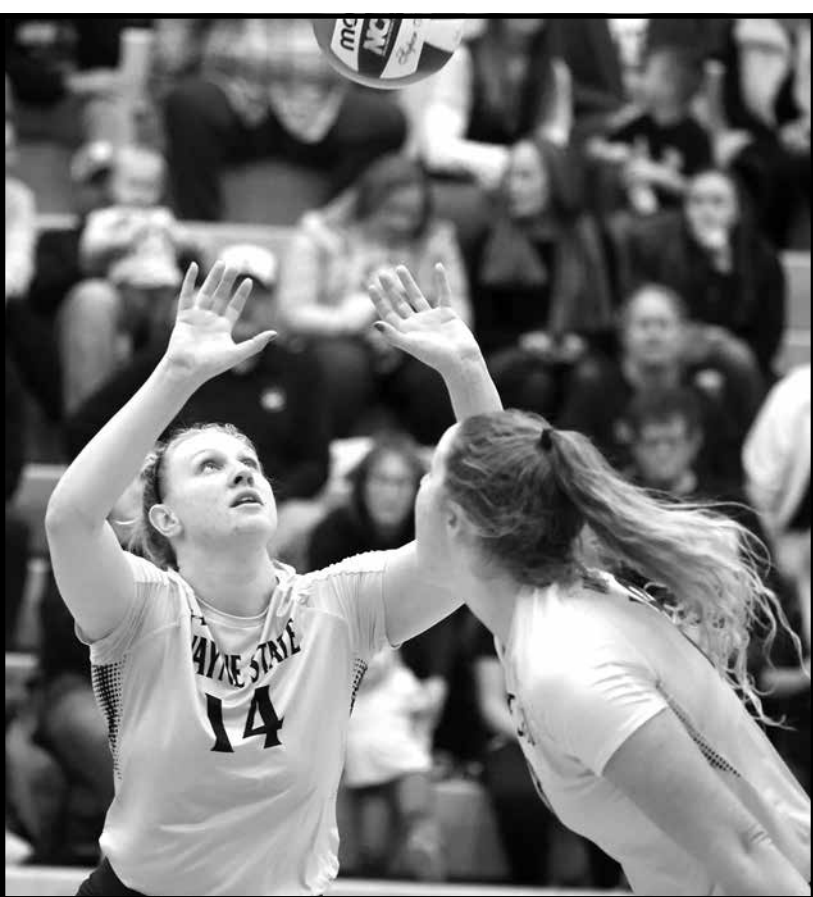

## Wayne State men drop two in Oklahoma to open season

SHAWNEE, Okla. — The Wayne State men's basketball team stumbled in their first weekend of competition, losing a pair of games at the GAC/NSIC Challenge Friday and Saturday at the Noble Complex.

In a battle of NCAA Division II Tournament teams from last season, Oklahoma Baptist used 33 points from Valdosta State transfer Burke Putnam to power the Bison past Wayne State College 74-61.

The game was close at halftime with the host Bison holding a 31-29 advantage. But the Bison used an 18-4 run early in the second half to take control of the contest.

The first half was close with five ties and six lead changes. After Oklahoma Baptist opened with a 12-4 lead, WSC went on a 10-0 run and took a 14-12 lead on a pair of Justin Eagins free throws with 10:03 to play in the half.

Neither team held a lead of more than two points until the final 20 seconds of the half as Oklahoma Baptist finished with a 31-29 lead at intermission.

OBU opened the second half with a 36-32 lead, but WSC countered with an Eagins trey and a Jordan Janssen basket to take their final lead of the game at 37-36 with 16:45 to play.

The host Bison went on a 18-4 run, highlighted by three straight

3-pointers, and took a 54-41 lead. OBU pushed the lead to 17 at 62-45 and maintained a double digit advantage the rest of the game.

Wayne State was led by Janssen's 18 points on 9-13 shooting. Also hitting double figures for the Wildcats were Eagins with 13 and Alec Millender 11.

WSC made 27 of 66 shots in the game (40.9%) but was just 4 of 22 behind the arc for 18.2 percent. The Wildcats were 3 of 4 from the foul stripe.

Valdosta State transfer Burke Putnam poured in a game-high 33 points for the Bison, making 14 of 21 shots from the field. Nigel Wilcox contributed a double-double with 10 points and 10 rebounds while Harrison Stoddart and Brantly Thompson each scored 10 points.

Oklahoma Baptist connected on 32 of 62 shots for 51.6 percent, going 8 for 23 from the 3-point line and 2 of 4 at the charity stripe.

OBU held a 39-31 edge in rebounding over the Wildcats as both teams grabbed 16 offensive rebounds. Janssen and Cody McCullough each hauled in six boards for WSC.

Southeastern Oklahoma State used 57 percent field goal shooting in the second half to break open a close game Saturday and top cold-shooting Wayne State 80-64.

The two teams battled close for a majority of the first half, trading seven lead changes and five ties in the first half of the contest.

Wayne State's biggest lead of the game was two points several times in the opening half. The Wildcats led 11-9 seven minutes into the game following a Jordan Janssen basket.

The Savage Storm scored eight straight points for a 17-11 lead followed by seven straight points from the Wildcats for an 18-17 lead after a Sean Stokes 3-pointer with 7:54 left in the first half.

But that would be the final Wildcat lead of the night. A quick 9-2 run by Southeastern Oklahoma State resulted in a 26-20 lead. The 'Cats got as close as three at 32-29 right before halftime as the Savage Storm finished with a 34-29 lead.

Wayne State had little chance of making a comeback in the second half thanks to 38 percent shooting (15-39) while the Savage Storm made 57 percent on 16 of 28 shots to pull away in the second half.

The 'Cats were within seven at 43-36 following an Alec Millender basket with 14:37 remaining, but Southeastern Oklahoma State used a 14-5 run highlighted by three consecutive 3-pointers and the Savage Storm held a double digit lead the rest of the night.

Sean Stokes had 19 points that

included 5-of-10 behind the arc for Wayne State while Jordan Janssen was the only other Wildcat in double figures with 18 and 11 rebounds.

WSC shot just 36.1 percent for the game on 26-of-72 shots, including a frigid 6-of-23 from the 3-point line. The 'Cats made 6-of-9 free throws.

Southeastern Oklahoma State had five players score double digits led by Jett Sternberger's 16 points. Ante Brzovic followed with 15 while Kyle Leslie (12), Kellen Manek (11) and Adam Sworsky (10) also hit double figures.

The Savage Storm made 20-of-59 shots for 49.2 percent, hitting 6-of-21 3-pointers and 16-of-22 free throws.

A close rebounding battle favored Southeastern Oklahoma State 42-39 despite 11 boards by Janssen. Jay Saunders handed out five assists while both teams had 10 turnovers.

The Wildcats (0-2) played their home opener Tuesday evening at Rice Auditorium in Wayne, hosting Bellevue University. They will host Simpson on Friday at 7:30 p.m. before taking on Augustana in their first NSIC battle of the season next Tuesday at 7:30 p.m. at Rice Auditorium.

## Wildcat women come from behind to win opener

Wayne State had four players score in double figures and used a 23-13 fourth quarter to rally for a 72-65 victory at Newman University in Kansas in the women's college basketball opener for both teams Saturday afternoon in Wichita, Kan.

The host Jets took an early 11-6 lead on the Wildcats, but WSC scored nine of the final 11 points of the quarter and turned a 15-11 deficit into a 20-17 advantage.

WSC held the lead for the entire second quarter, building a nine-point lead at 31-22, and outscored Newman 18-13 in the quarter to hold a 38-30 lead at intermission. The Wildcat forced eight turnovers in the quarter with 10 of their 18

points in the quarter scored off Jet turnovers.

Newman came out strong in the third quarter and made 9 of 14 shots including 4 for 5 behind the arc and outscored the 'Cats 22-11 to grab a 52-49 lead entering the final stanza. WSC was just 4 of 14 from the field and 0 for 7 from the 3-point line in the cold-shooting third quarter.

Newman closed within 58-57 on a basket with 7:00 to go, but WSC took control scoring the next eight points for a 66-57 lead with 1:40 remaining.

The final 100 seconds was a free throw shooting contest as WSC se-

cured the win, going 9-of-13 from the line in the fourth quarter.

Hammer led four Wildcats in double figures with 21 points, including 8 of 10 at the foul line. Zacharias followed with 15 points on 6-of-11 shooting. Pingel recorded a double-double with 12 points and 11 rebounds while Logan Hughes also hit double digits with 11 points.

WSC made 24-of-62 shots in the game for 38.7 percent, but was just 3-for-18 behind the arc. The Wildcats were 21-of-27 at the free throw line.

Tiffany Dortland scored a game-high 27 points for Newman. Faith Mason-Vestal added 10 points for the Jets.

Newman was 25 of 63 from the field for 39.7 percent, 9 of 26 from the 3-point line and 6 of 10 at the line.

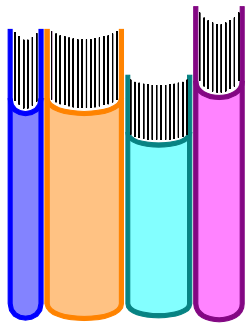
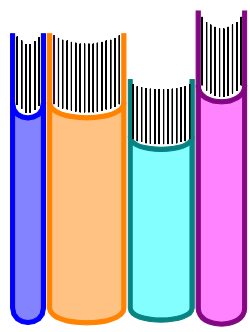

# Healthy eating throughout your life is a success

percent of American adults, and I've been one of them for nearly as long as I can remember. There are innu-

merable schemes that promise effortless, or nearly effortless, weight loss, and many diets that claim to be the best approach.

Between my second and third years of medical school, I had a month without work or structured academic obligations to study for the important Step 1 board exam. Every morning, I would get up and exercise for an hour before I hit the books. I would prepare healthy meals, and snack on carrots and celery while I read. I was determined to lose some of my excess pounds and set a good example for my future patients.

without surgical help. From a medical perspective, losing just five to ten percent of your body weight improves your health in a variety of ways. More importantly, the lifestyle changes that can lead to that weight loss have health benefits of their own.

and lots of it. Watch the sodium. Minimize processed foods. Avoid added sugars and trans fats. Your diet isn't something you are "on" or "off". Your diet is the way you nourish your body every day, and success is the choices you make that support your health.

Most of us recognize that if something seems too good to be true, it probably is. It's much simpler to identify the miracle potion advertised on our social media feed as snake oil, than it is to sort through all the conflicting and seemingly changeable advice on what makes a healthy diet. Should we be cutting out fat, or cutting back on carbs? Is there a particular combination of foods or spices or supplements we should be eating to be slim and trim and healthy?

At the end of that month, I'd lost two pounds. This was not at all what I had anticipated. I was frustrated, angry, and hurt. I felt that my efforts had failed. I felt that "I" had failed.

With the wisdom of nearly 30 years in medicine, I realize that by focusing on the scale, I hadn't seen something even more important. Eating fruits and vegetables reduces the risk of heart disease, strokes, cancer, and many other chronic diseases. Daily exercise strengthens hearts and bones. In short, even without weight loss, exercise and a healthy diet are good for you.

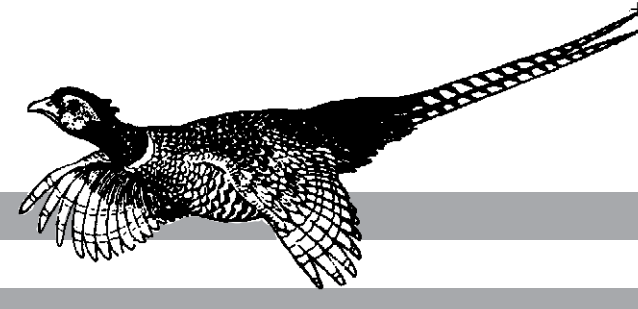

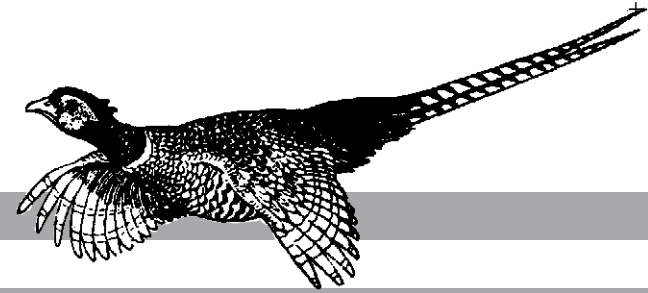

## Master Gardener volunteers needed

It's time to think about becoming an Extension Master Gardener. If you enjoy spending time in the garden and landscape, learning new things, meeting people who also enjoy plants, and being involved in

your community, consider becoming a Master Gardener.

Don't let the word Master Gardener deter you. The program is open to beginning and expert gardeners. While volunteers tend to have some experience and knowledge, this is not a requirement and should not stop you from exploring the program. Master gardeners are volunteers of each state's land grant University. In Nebraska, it is the University of Nebraska at Lincoln where the program started 1976.

Our mission is to extend the outreach of the University of Nebraska-Lincoln. Volunteers help provide unbiased, science based horticulture information and volunteer in landscape and garden activities to enhance community green space.

**UNL Extension**

Education and learning are key components of becoming a Master Gardener. Over one to two years, new volunteers attend 40 hours of local and virtual education and volunteer an equal number of hours. Once the first 40 hours of training and volunteer time is completed, returning volunteers are asked to attend a minimum of 12 education hours and volunteer 20 hours to the program each year. In surveys of volunteers, it is the lifelong learning they most enjoy.

For training, topics range from plant identification to tree, fruit, vegetable, perennial flower and lawn care as well as pest identification and management. There may be classes on improving soil, attracting pollinators and learning how to prune or propagate plants. Topics vary each year.

Along with increasing plant knowledge, benefits include meeting people who have similar interests, sharing plants, discussing gar-

dening successes and failures, and learning from one another. Volunteer opportunities include sharing gardening knowledge with others, community and demonstration garden care, harvesting and donating fresh produce to local food pantries, citizen science projects, 4-H/youth garden and outdoor education, and more. Volunteers can create their own projects.

Across Nebraska, there are over 600 volunteers. Volunteers do not need to live in the county where their training takes place. They can be trained in one county and volunteer their time in the county they live in as needed. In our general area, training programs take place in Columbus, Norfolk, Grand Island, Fremont, Sioux City and York. In Columbus, Master Gardener classes are held on Thursday mornings and Monday or Tuesday evenings in February and March.

There is a one-time fee to join the Extension Master Gardener program. While it varies some, it is usually around \$150. This fee covers training, a handbook, T-shirt and name tag. After the first year, there is a state fee of \$10 paid per year.

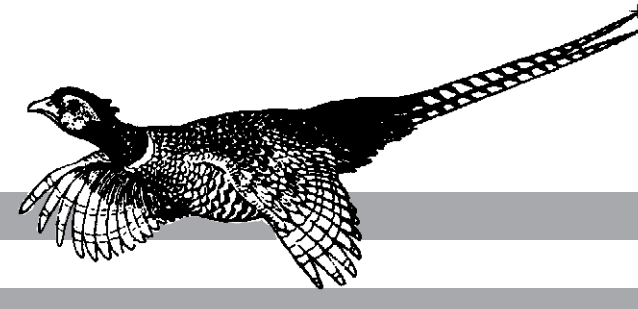

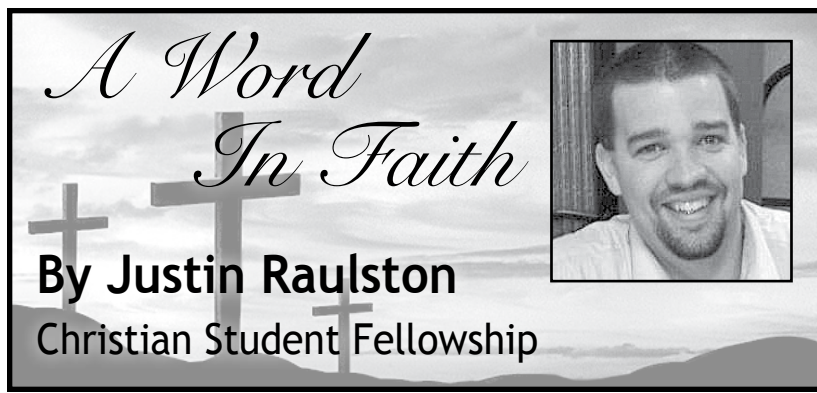

Psalm 33:11 says "The plans of the Lord stand firm forever, the purposes of His heart through all generations."

Proverbs 3:5-6 says "Trust in the Lord with all your heart, lean not on your own understanding; in all your ways submit to Him, and He will make your paths straight."

God's plan, and God's timing don't always seem to match up with mine as often as I'd like it. Many times in our lives we can't see how everything fits together till after it's all over.

I was reminded of that this week while I was at a minister's retreat in Schuyler. The guy that was leading the retreat was Greg Swinney (Wayne native), and he was talking about how God had used a short conversation with our guest speaker (Jerry Hopkins) to change the trajectory of his whole life.



Jerry was on the board of a campus ministry organization at the time called Lighthouse ministry in Kearney, and their campus minister a guy named Chris Lahm was leaving to go work at Nebraska Christian College in Norfolk, and they wondered if Greg would be interested in coming and being their campus minister.

Greg said that wasn't even on his radar at the time, but after much prayer and thought he said yes, and it changed his life. Greg served at what became known as Christian Student Fellowship (CSF) for decades, and still serves in working with international college students all over the world. Greg said you never know what a conversation

will do to change someone's life.

After the session I went up to Greg and asked him if he'd like me to finish his story. I told Greg, that he took that job because the guy Chris Lahm was leaving, but what he might not know was that guy, Chris Lahm, 15 years later recruited a kid who wasn't a Christian (me) to come play basketball for him at that Bible college he went to. He led me to Christ, and totally changed the trajectory of my life and now 20 some years after that I am in his former chair as the Director at CSF, the ministry that Greg started at.

We both marveled and teared up a little as we thought about how incredible God's plan is when we can look back on it.

Things that seemed small, maybe even insignificant at the time had huge implications later on.

One man's decision, led to another decision, that led to another, that changed my life and others.

Do you ever struggle with God's plan in your life? Do you sometimes have trouble seeing how God can use this season of life that you're in? Do you wonder what God's up to, or if He's up to anything in working out the things in your life that you have no clarity on? Yeah, me to at times. This week though I was reminded that God is writing a story that is so much bigger than me, and He has this all figured out, so I don't have to. I just have to trust the One who does.

I love Philip Yancey's quote "Faith means believing in advance what will only make sense in reverse. Don't forget in the darkness what you've learned in the light."

## Fall grazing options discussed

Transporting cows to stalks

When it comes to feeding cows during the winter, producers have a wide variety of forage and feed sources to choose from, with unique costs and benefits for each.

How can you decide which option is best for your operation?

With dry conditions in the western U.S., typical winter feeds like grass hay have become increasingly expensive. To offset this cost, producers may turn to a lower cost grazing resource in crop residues. When available corn fields are local, the decision may be easy, but how far is too far to haul cattle to stalks?

Figuring out the true cost of grazing stalks or feeding hay can be done using the UNL Cornstalk Grazing Cow-Q-Lator and Feed Cost Cow-Q-Lator respectively. Both tools ask in depth questions like transportation distance and cost, number of grazing days, how often cattle are checked, feed loss, and storage and hauling fees to come up



with an accurate cost of use.

These tools will be combined into one easy to use tool, the Cow Transport Cow-Q-Lator, available soon. Just search UNL ag manager tools. It should be your top result.

Using this tool, Ag Econ Specialist Matt Stockton and Educator Randy Saner produced a table showing that corn stalks are often at a competitive advantage when it comes to cost of feed. For a herd of 105 cows being checked on weekly at a distance up to 200 miles away, brome hay would have to be below \$33 per ton to be a more economical option than stalk grazing. For a

400 mile distance, hay must be below \$74 per ton, and below \$155 per ton if going 800 miles.

With hay prices as they stand now, even a long distance trip to grazeable corn residue may be worth consideration this year.

### Fall grazing of alfalfa

In the fall, a common question is: "when is my alfalfa safe to graze?" There can be several different scenarios from which it comes. Usually corn stalks are ready to be grazed. It would be convenient and useful to include an adjacent alfalfa field for extra grazing and protein. Another scenario has grazing ending on summer range, but the final growth of alfalfa is still standing in the field. A side benefit is that grazing alfalfa in late fall or winter can reduce alfalfa weevil infestations by removing stems and plant parts that serve as a wintering site or a spring laying site for weevil eggs.

Even though it is mid-November,

alfalfa is still quite green, despite several nights with low temperatures in the twenties. There may be some wilting and yellowing, especially on the top, but most leaves still are attached to the plant stems.

The real question often being asked is "Can I be sure my cows won't bloat if they graze my alfalfa?" To be quite honest, you never can be 100 percent certain that alfalfa won't cause bloat. Bloat occurs in ruminant livestock when gas produced during fermentation becomes trapped inside the rumen.

Bloat risk is much lower a week after a hard freeze that causes wilting. But always use good management methods to reduce the risk further. Have cows full before turning out to alfalfa. Wait until midday, after frost or dew is gone, before turning out. Provide other dry, palatable feeds or even bloat retardants. And keep a close eye on them for the first couple days.

Alfalfa can be grazed safely. Just be careful and realistic.

## USDA issues third and final payment to producers impacted by 2019 natural disasters

Starting Nov. 8, USDA began making roughly \$185 million in disaster assistance payments to agricultural producers who suffered losses to 2019 natural disasters and who have already received Wildfire and Hurricane Indemnity Program Plus (WHIP+) benefits through two previous rounds of reduced program payments.

WHIP+ provided payments to producers to offset production losses due to 2018 and 2019 hurricanes, wildfires, and other qualifying natural disasters. WHIP+ covered losses of crops, trees, bushes and vines that occurred as a result

of those disaster events. Producers suffering from 2018 losses were previously compensated at 100% of their calculated loss.

"The production and quality losses to 2019 disaster events were so extensive and widespread that we had to proactively manage the distribution of funds in a way that ensured that all applicants received some financial support," said Farm Service Agency (FSA) Administrator Zach Ducheneaux. "We are excited to have reached that point in the process that we can offer all approved WHIP+ applicants 100% of their calculated payment."

This third and final WHIP+ payment is equal to the remaining 10% of a producer's full, calculated payment. The first WHIP+ payment issued in the fall of 2020 was subject to a 50% factor or reduction. In June 2021, FSA distributed a second payment equal to 40% of the WHIP+ calculated payment. At that time, it was also announced that a third round of payments may be issued if sufficient funds become available. Sufficient funds are now available to issue final 2019 and 2020 WHIP+ payments. FSA has authorized a final payment equal to the remaining 10 percent of 2019

and 2020 calculated payments.

Once this final payment has been disbursed, FSA will have provided more than \$3.1 billion in WHIP+ disaster assistance benefits.

All producers receiving WHIP+ payments are required to purchase federal crop insurance or Noninsured Crop Disaster Assistance Program (NAP) coverage for the next two available crop years at the 60% coverage level or higher.

## Inaugural Special Landowner Deer Season wraps up

For hunters in Nebraska's inaugural Special Landowner Deer Season, their season is over.

The \$8 Special Landowner Deer Permit, of which 3,690 were sold, was valid only for the three-day season, which ended Nov. 8, and is not valid for any other deer season.

According to preliminary results from the Nebraska Game and Parks Commission, hunters had a 24% success rate during the Special Landowner Deer Season.

The harvest includes 590 whitetail bucks, 100 whitetail does, 177 mule deer bucks, and 21 mule deer does.

Overall harvest was highest in the Blue Northwest (81), Frenchman (81), Wahoo (77), Blue Southeast (71), Platte (68), Elkhorn (66), and Loup East (64) deer management units.

The Special Landowner Season Permit allowed a qualifying landowner to hunt on his or her property on the Saturday, Sunday and Monday before the opening of the November firearm deer season.

The Special Landowner Deer Season was created by the passage of LB 126 in the Nebraska Legislature's 2020 session.
