**Bread Materials.**  
There was a dearth of wheat in England in 1898 and 1899, and in those years bread was made of turnips. They were boiled until they were soft enough to mash, when the greater part of the water was pressed out of them. An equal weight of wheat meal was then mixed with the pulp, and the dough was made in the usual manner with yeast. The dough rose well in the trough, and after being kneaded was formed into loaves and put in the oven. Bread prepared in this manner has a peculiar sweetish taste which is said to be not disagreeable. It is as white as beaten bread and should be kept about twelve hours before being eaten, until the smell and taste of the turnip will evaporate.  
"It is not a new kind, and there are several processes of making it. The simplest is to choose the large, meaty sort, soil them for eating, then peel and wash them very fine, without adding water. Two parts of wheat flour are added to one of potatoes, and a little more yeast than usual. The whole mass is kneaded into dough, and allowed to stand a proper time to rise and ferment before it is put into the oven. Bread so prepared is said to be good and wholesome. One Emmanuel Durbin advised the grain or raw potatoes (the oven wet), whereas the starch would survive. The starch from eight pounds of potatoes, which is asserted, would make as good bread as the best wheat."  
"Dr. Darwin went so far as to say that the loaf made of such material would be so good as to undergo the same process that is used to make the bread for the poor, but that it would be so good as to serve in part for the sustenance of mankind in times of scarcity."  
"To make good bread, boil three parts of wheat flour and one part of rye, separately. Boil the rye water until the water has nearly the mass with the wheat. The process then is the usual for common wheat bread. A pound and a half of flour mixed with half a pound of rye will produce three pounds two ounces, which is a greater gain than it is from the whole flour. It has also been tried in the same proportion with the flour of the whole grain, and is said for laboring people. The Paris exposition, which is expected to eclipse all previous attempts, was opened Monday.

Frank M. Palmer, of Chicago, formerly member of congress from Iowa, has been appointed public printer.

It is estimated that a million and a half of strangers were in New York at the centennial celebration last week.

Extensive fires have been raging in the Wisconsin forests, and vast quantities of timber have been destroyed.

Gen. Clinton B. Fisk, late candidate of the prohibition party for the presidency, has formally withdrawn from the third party and renewed his allegiance to the republican party.

The prominent feature of the daily editorial for the past two weeks has been the contrast between 1789 and 1889. Let us boast not too loudly. In 1889 our great grandchildren will smile as pityingly at our primitive condition as we do now at our slow-going forefathers.

In an official declaration stating that a railroad in the south part of the state must build or forfeit its charter, Attorney General Leese condemns his whole opinion into "the railroad must fish or cut bait." The use of slang in an official paper is reprehensible at best; and a misuse of it inexcusable. What Mr. Leese meant was that "the rail roads must shoot or give up the gun."

Congressman Dorsey has invited a number of prominent western congressmen to take a trip through the west this year at his expense, and will show them how the country west of the Missouri has been growing, and that it deserves much more attention from the government than it has hitherto been able to get. The more is good, and will doubtless result in a better understanding of the claims and needs of the west among members of congress.

There seems to be a difference of opinion among the leading agricultural papers which pretend to have investigated the matter, whether or not there is a twine trust, though there is no question about the price being higher than the farmers can really afford to pay. The following is from a leading agricultural paper:

We cannot refrain saying a word about the binder twine trust. There is one way and only one way the farmers can head off this head. The only reliance the binder twine companies have is the belief that farmers have used binders so long that they cannot be induced under any circumstances to return to the old system. Here you can disabuse their minds in a very short time. It is not so much in the injustice of the increased price of twine as it is the pernicious effect upon yourselves in the future that demands that you abstain from using twine this year. If they could get you to pay twenty-five cents a pound this year, it will be expected by these buzzards that you will pay thirty next year. You will get only ten cents for all this year effectually you will trust and you will be the first person that ever did it outside of the court room. Why should you not? At the factory you will not have to bind the old way more than three days. Why does six days' fight amount to when you are certain to win the day? There never was a dropper, self rake or hand rake that placed the grain in as nice a shape to handle as does the binder. Don't pay any attention to the trust but persistently refuse to buy twine at any price. Of course twine dealers will hold out a while in the hope you will come around all right, but you must stick firmly to your position and refuse to buy at all. Drive right into the field with your binder and it will drop the sheaves just as you want them and you will bind them just as easy as you ever did. You can stack them just as well and you can wear a circumlocution you through wheat in knowing that you owned the ground. Of course the work is harder for the binder but your farmers can effectually do in 2 weeks what other men have failed to do in four years, you can do a trust. It is to be hoped that you will do this and teach the leechy corporations a lesson.

The powers that be say this thing must be stopped, and as a consequence thousands of dollars worth of grass will be mowed and destroyed this fall, the Indians will lose the revenue in the home pastures. The Indians grow on for this state of things is that the money received by the Indians makes them too opulent and consequently they do not rustle as they otherwise would. The soldiers it is said, will stay on the reserve during the season and may come from chicken caught eating of the forbidden grass will be promptly arrested and court-martialed.

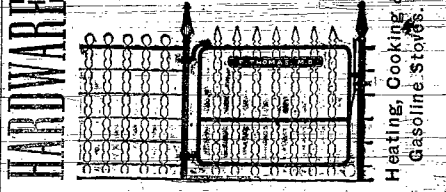

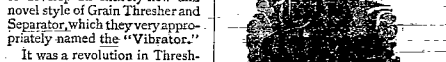

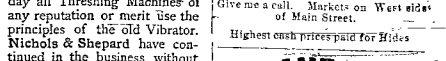
