



Much has been written and broadcast by leading democrats and republicans and their respective candidates, President Roose-veit and Wendell Wilkie, and much more will be heard during the next few days. His experience consists largely of having been the head of a giant public utility company and you first heard his name probably when he was battling against the people's Interests over the TVA. If elected, he owes them a debt of gratitude and if there be any voter so foolish as to believe that debt will not be paid many fold, he should review past history a bit. We must believe one of two things: First, that Mr. Willkie will repay them for their support as they anticipate by junking most of the administration's program including parity funds for the farm-ers, work for those unable to get jobs, relief for the destitute, reasonable wages and hours for labor, thereby reducing expendi-tures at the sacrifice of the poor. Or, second, we must believe that Mr. Willkle will betray them and will carry out all those glittering promises he has been making to retain and expand the New Deal program. It is of great significance that Mr. Willkle has foared to advocate abandoning any of the major reforms carried out by the New Deal. It is significant that he fails to tell how he will obtain the benefits he so freely promises. For example, he says he's going

For example, he says he's going to restore confidence and thereby in some mysterious fashion ob-tain jobs in private industry for the unemployed. Any schoolboy knows that is a laudable ambition, but any sensible voter will de-mand that Mr willkle guilt speaking in generalities and halt his mud hurling tactics long enough to explain a bit. Now, what is Mr. Wilkle's program? His promises conflict with those of his running mate on many major issues. His promises are refuted by the votes of the leaders of his newly adopted party in congress. In fact, Mr. Willkie has contradicted himself so much that we doubt whether even members of his immediate family know where he stands other than that he is ambitious to become president. president.

know where he stands other than that he is amonious to become president. On the other hand, Franklin D. Roosevelt has served this na-tion for two terms, taking office at what was probably this coun-try's darkest hour when many with poor memorics, who have as-sailed him so bitterly, feared that revolution would wreck this demo-eracy. He saved the nation then and he can and will save it again. He is qualified both by training and experience, qualified as is no other leader in the world today, to continue to guide this na-tion through the dangers ahead. It was President Roosevelt who warned America of the need of preparing our defenses in the days when the republicans were accusing him of striving to instill fear and telling the world that there would be no war. It was President Roosevelt again who took the lead in supplying Great Britain with all the aid short of men that it is possible for this nation to supply. ### WAYNE NEWS LEGAL NOTICE AS TO MEASURE TO BE VOTED **UPON NOVEMBER 5, 1940**

The following amendment to the Constitution of the State of Ne-braska will be submitted to the electors of this State for approval or rejection at the general election to be held November 5, 1940:

Be it Enacted by the People of the State of Nebraska:

Section 1. That at the general election in November, 1940, there shall be submitted to the electors of the State of, Nebraska for ap-proval or rejection upon a ballot separate from that upon which the names of candidates appear the following amendments to the Consti-tution which are hereby proposed by the Legislature:

Section 1. That Sec. 4, Article IX, Constitution of Nebrasks, be ded to read as follows:

"Sec. 4. The Legislature shall provide by law for the election of a county and township officers as may be necessary: Provided, ever, the Legislature may provide by law for a form of county ernment in which county officers may be elected or appointed, but a form shall be optional with each county and shall obtain in any nty only upon the adoption thereof by the electors of such county." such con

Sec. 2. That an additional Section be inserted in Article XVII, sitution of Nebraska, to be known and numbered as follows:

'Sec. 10. This amendment (1940) shall be self-executing and legislation authorized hereby shall be supplemental hereto; and this amendment, except as otherwise herein specifically provided, shall be in full force and take effect on the first Thursday after the first Tuesday in January, 1941.'"

Tuesday in January, 1941. Sec. 2. That the foregoing proposed amendment to the Consti-tution shall be submitted to the electors at said election upon one ballot separate from that upon which the names of candidates appear, after publication once each week for four weeks in at least one news-paper in each county where a newspaper is published immediately precéding said election. Said ballot for the submission of said proposed amendment shall be in the following form:







Congress As Seen by KARL STEFAN

There are two Third congress-ional offices open now. One at Norfolk and the one in Washing-ton. 


