Mobile Letter.

My Dear Mr. Cushingham.

The verifications of the opinions have begun. The trials at the social and political elements were pretty well shown in the recent and I may say present, discussion of a bill to prohibit the master is still under consideration pending the final determination of the constitution or the legislative body of the islands.

The bill referred to was introduced by Professor Moore, who represents the educational interests of the Commission, section 15 of the bill. It is a simple, practical, law, designed for half a century. Three times a week in a school building to those pupils whose parents, or guardians, desire it. Senator Rosario who represented the newly formed Federal party strenuously opposed the action, urging that it would interfere with the bill.
